FROM THE PRESIDENT

Room 306 will be available on Saturday and Sunday for demonstrations IF someone in the Bay area will loan us a system. Preferably a hawk. Please call Sharon Greene at (303) 449-6917 to let her know if you could supply a system or if you would like to use the system for demonstration purposes.

Room 308 is being scheduled for discussions on Saturday and Sunday.

The main attraction will be an open forum discussion between Alpha Micro and all dealers and OEM's. AMDEAL will also be included. This will surely be your best chance to voice your opinions and ask questions. This session starts at 9AM Saturday. Len Backus and Patrice Martinez will be there.

Those members who are currently on the board of directors should note that we will get together at 12:30 Saturday.

The general meeting for AMUS will be scheduled into one of the regular meeting rooms by the "Faire" people and should be at 5:00PM Saturday. Everyone is welcome to attend this meeting. The Boulder area is having a terrible time with Persci floppies. Once, all 13 drives were out of commission at the same time. If a significant number of other users are having problems let me know and we will see if we can put some pressure on Persci.

Remember - if you have questions about membership, dues, reprints, software, etc. - call Sharon.

We had a lot of trouble hooking up the AM-400 board as a peripheral to a hawk system, but now that we have, what a beautiful system. All that storage and the flexibility of a cartridge too. You must disable the phantom and the prom by removing chip Z29 and bending out pin #5 on Z32. After the system is booted from the hawk, type TRIINI (or include it in your SYSTEM.INI. You may need to shut both tridents off line in order to get a status of 0 from the TRIINI command.

BAUD

Gary DeCamp has 4 systems that he claims the baud rate on one of the terminals is getting changed without being told to do so. Anyone else hear of this?

FLOCK

Dick Starr in Hamburg, Iowa had problems with the 5.0 option. It was determined that this option will create a "Device does not exist" error if the record number is zero. Otherwise it works OK. Record number zero can be accessed as logical record number one by using FILBAS=1. Terry Flander of Longmont Colorado also had problems with FLOCK leaving one que block in use. We do not think FLOCK is fixed on 4.1. It will not work well with the business package.

VUE with ADM-3

ALPHAVUE will work much better on the ADM-3 if you disable the Auto NL feature.

NEW PRODUCTS

Alpha Micro will be bringing out some new products in June. They will be shown at the NCC in New York.

COPY on TRIDENTS T25

The new 4.0 COPY.PRG does not work well on the trident system. There is a 4 block discrepancy in the size of the bitmap as seen between COPY and DSKANA.

A/M ACCOUNTING PACKAGE 1.1

In the Payroll Employee input program, the xcalls to input social security number and zip code have the wrong number of input characters. You must remember to put in your state sales tax in the OE billing program. Check out the calculation of amount due in the case where the entire amount was prepaid. You may be off 1 or 2 cents due to scaling.

Areas to be covered:


1. Dictionary files

THE COMPANY EMPLOYES 5 PROJECT MANAGERS WHO DIVIDE THEIR TIME EQUALLY BETWEEN COORDINATING ONGOING JOBS AND 'TAKING OFF' DETAILED PART AND LABOR COST ESTIMATES FROM BLUE PRINT SPECIFICATIONS OF PROSPECTIVE JOBS. THESE PART AND LABOR COST ESTIMATES ARE USED TO PREPARE BIDS FOR THESE PROSPECTIVE JOBS. ONLY ABOUT TEN PERCENT OF THE JOBS THAT ARE BIDDED ON ARE AWARDED TO MY CLIENT. THE PROJECT MANAGERS ARE HIGH PAID INDIVIDUALS WHOSE WORK IS CRITICAL TO THE PROFITABILITY OF THIS CONCERN. THEY MUST BID JOBS PROFITABLY AND COMPETITIVELY AND THEY MUST PROFITABLY MANAGE THOSE JOBS WHICH ARE AWARDED. THE GOAL OF THIS SYSTEM IS TO MINIMIZE THE CLERICAL WORK ASSOCIATED WITH BID PREPERATIONS.

PROCESSING - THE SYSTEM MAINTAINS ONE LARGE FILE OF PRICE AND LABOR FACTORS PER UNIT OF MEASURE FOR EACH ITEM THAT IS ESTIMATED. ONE ITEM IS 'COPPER PIPE', ANOTHER IS 'STAINLESS STEEL PIPE - ANOTHER 'BRONZE XTRA HEAVY VALVE' ETC. THE SYSTEM THEN ALLOWO FOR SEPERATE PRICE AND LABOR FACTORS FOR A RANGE OF 23 SEPERATE DIMENTIONS WITHIN THAT ITEM. ALMOST ALL THE MATERIALS THAT THIS CONCERN WORKS WITH SPAN DIMENTIONS (PIPES, ELBOS, VALVES ETC). WHEN AN ESTIMATION ELEMENT IS ENTERED THE PRICE AND LABOR FACTORS ASSOCIATLD WITH IT ARE ACCESSED FROM THE CONSTANT FILE. THEN A SEPERATE RECORD OF THE ITEM, DIMENTION, QUANTITY, AND PRICE AND LABOR FACTORS IS WRITTEN TO THE PARTICULAR JOB'S ESTIMATION FILE. IT MIGHT TAKE TEN SITTINGS OR SESSIONS WITH THE COMPUTER TO ESTIMATE ONE JOB. EACH SESSION GENERATES A SEPERATE DETAIL ESTIMATION FILE. THIS FILE CAN BE REPORTED ON AND VERIFIED. UPON ACCEPTANCE IT IS THEN DUMPED INTO A SUMMARY

LEVEL FILE OF THE JOB'S ESTIMATION ACTIVITY. IF 1/2 INCH COPPER PIPE APPEARED TEN TIMES ON TEN DIFFERENT PAGES OF A PLAN THEN TEN DIFFERENT 'DETAIL SESSION ESTIMATION RECORDS' WOULD HAVE BEEN GENERATED. IN THE JOB'S SUMMARY LEVEL FILE ONE 'SUMMARY LEVEL ESTIMATION RECORD' WOULD CONTAIN THE RESULTS OF THE TEN DETAIL RECORDS. THE DETAIL FILES AFFORD A SOURCE OF DETAILED ESTIMATION VERIFICATION BY SESSION WHILE THE SUMMARY FILE PROVIDES ALL THE DATA NECESSARY TO PRODUCE THE FINAL ESTIMATION REPORT.

STANDARD COSTS ARE ALSO SUMMED ACCORDING TO SUPPLIER INFO SO THAT QUANTITY DISCOUNTS CAN BE APPLIED.

ON-TASK

INTRODUCTION TO CTCS

The Contract Task Control System (CTCS) was designed expressly for organizing and controlling project costing, and for consolidating and reporting cost/schedule variances.

CTCS impacts the project cost estimating phase in a very positive way. By mandating the use of logical project planning for data input, CTCS starts off well where it counts the most - right at the beginning. To properly utilize CTCS, the user must prepare a Work Breakdown Structure (see Appendix A for W.B.S. considerations) showing all of the major areas of effort included in your project. By forcing task assignments to proceed in an orderly fashion, the risk of forgetting that important task can be reduced.

Depending upon the size of the project, one or more persons team to identify all tasks within each W.B.S. category, and input the task descriptions and expenditures into the CTCS data base.

Included in CTCS is a base-rate-of-pay table program that allows the forecast of labor tasks in terms of man-hours, with dollar amount calculation done automatically according to department. Both man-hour and dollar amount figures are stored for every month for every project task. Non-labor tasks (raw materials, purchased parts, outside processing, freight, etc.) are also accommodated.

The Forecast Expenditures Report is suitable for use as a "bid sheet" or price backup for formal contract proposals. Costs are reported by task, by W.B.S. category, and by resource (or department code). This report is available for any project month, quarter, or for the entire project.

CTCS follows through beyond the proposal phase and becomes the source for consolidated reports on the actual progress of your project. The Actual Expenses Report notes task expenses in terms of man-hours and dollars for the current month, in terms of man-hours and dollars (used and remaining) for cumulative-to-date, and in terms of man-hours and dollars for at- completion.

CTCS project files are limited in size only by the amount of disk space available. Multiple projects, coded by sales order number, are fully supported on the same disk.

In regard to the ADM3.TDV and 2.0 VUE being incompatible. If the driver is modified by changing the 7th line from the end.

```
old:      BMI      EOL9          ; IF PAST END OF LINE IGNORE
new:      BLE      EOL9          ; IF AT OR PAST END OF LINE IGNORE
```

The clear to end of line will almost work and the runaway problem will be fixed.

Don't forget to reassemble and copy the PRG to DSK0:1,6, then rename it with TDV extension. Last but not least boot the system to test it.

A bug in vue is encountered when you try to VUE a file not in your PPN ie: program in 50,1 and you are logged into 40,1. Vue will load and allow you to edit the file until you finish, at that time you get:

MEMORY IMAGE STORED IN MEM:IMAGE.VUE
```

The book says you can save the edited file by SAVE MEM:IMAGE.VUE in your PPN. What the book does not tell you is that in order to make any use of the file you must use EDIT and delete the first 10 characters first.

Two Diskettes are available from the Byte Shop of Reno. All programs come with complete documentation in the form of HELP files. Source code is provided for all programs on Diskette #1.

Diskette #1 contains a package of general utility programs. The utility disk may be purchased for \$35.00

Diskette #2 contains a generalized menu system. This system allows programs to be interfaced through a hierarchial menu tree which can easily be extended and edited. Modifications to existing programs is trivial. The Menu System may be purchased for \$85.00

Programs on Diskette #1:

BASIC language:

AUTO Allows automatic line-numbering for BASIC programs.

CMPALL Allows 'wild card' compilation of basic programs.

IF A conditional statement processor which allows the user to control the flow of procedure files.
An example: .RUN IF FILE ABC.BAS THEN COMPIL ABC
The file ABC will be compiled only if it exists.

RENUM A program which will renumber a basic program.
The renumbering can take place on specific sections if desired.

RESEQ A BASIC programs resequencer. Same as RENUM, but allows imbedded line numbers.

BASIC subroutines:

CHAIN Chain allows the user to chain to a command file directly by passing it a string of commands. This allows the user to pass arguments.

CLINE Cline will fetch the command line into a string. This is very useful in production programs which require arguments. Allows you to type things like: .RUN PROG ARG1,ARG2.

- COMBLK** Comblk is a general common block routine which allows common blocks to be stored in memory when chaining to other programs. It is similar to the alphaMicro COMMON subroutine, but it allows any number and size of common blocks. Common blocks may be stored in the system area also.
- DATCNV** A generalized date conversion routine. It allows dates to be stored in just two bytes. DATCNV will check for date legality (i.e. 2/29/77 is illegal) and is valid from 1/1/1900 through 6/7/2079.
- DSKRD/DSKWRT**
Two Routines to read and write directly to a block-structured device.
- EKOSET** Set/Reset your terminal's echo within a program
- GETCH** Gets a character from the keyboard without the necessity of pressing return.
- NXTPAR** Allows easy extraction of parameters from a string. It is used with the CLINE subroutine to extract arguments.
- PAUSE** Allows the job to delay for a specified amount of time.
- PRTERR** Prints an error message and waits for return from keyboard.
- PUTIN** Allows the user to force characters into his own input string.
- RGETCH** Allows real-time entry of characters from keyboard. Returns null if no keys pressed, but returns a character when one has been entered.
- TRIM** Removes trailing blanks from a string (Similar to the Alpha-Accounting STRIP routine, but is smaller and faster)

Assembly language programs:

- ALLOC** Same as the ALLOCATE statement in basic, but entered in command mode.
