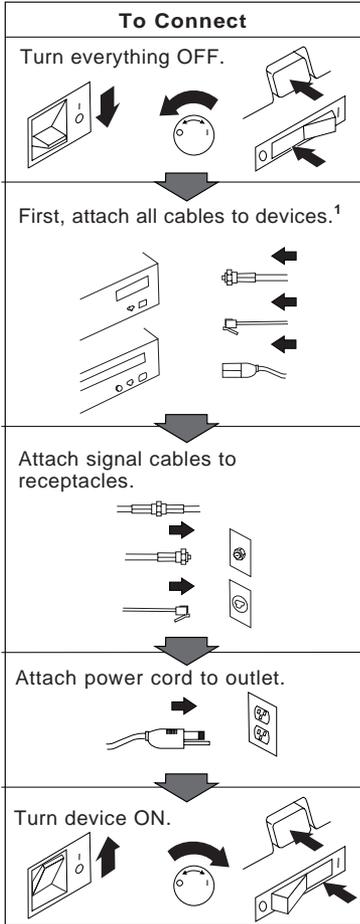

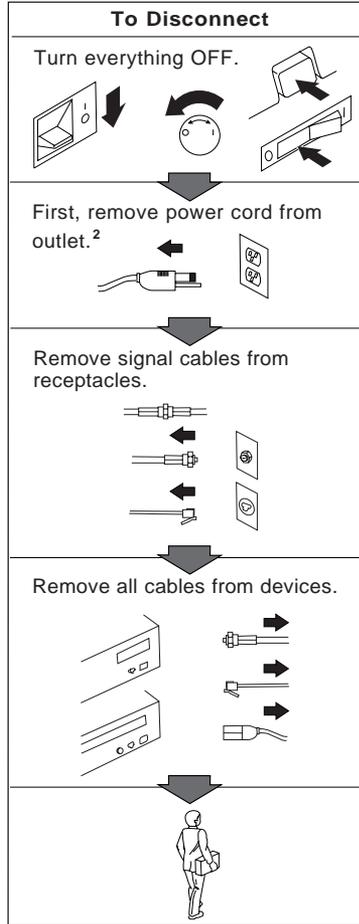

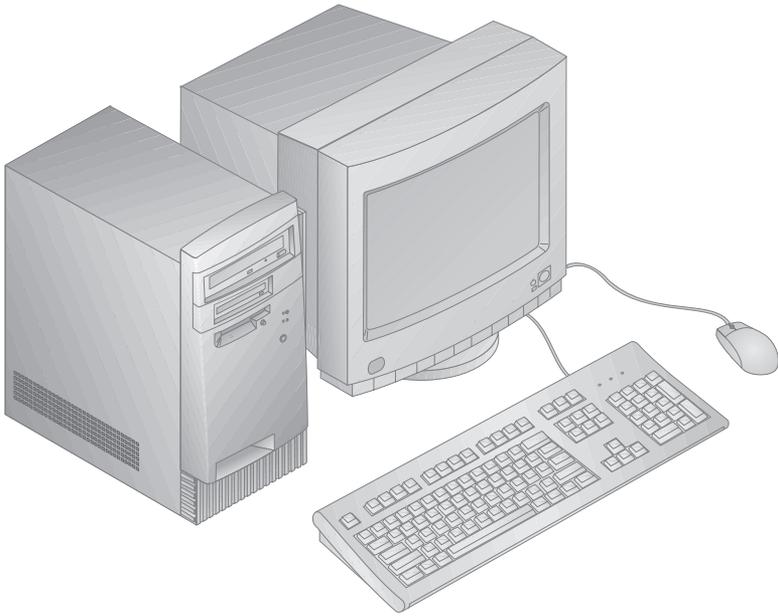

Chapter 1. IBM PC 300GL Overview



Thank you for selecting an IBM PC 300GL. Your computer incorporates many of the latest advances in computer technology and can be upgraded as your needs change.

This section provides an overview of the computer features, preinstalled software, and specifications.

Chapter 2. Setting Up Your Computer

This section provides information for connecting cables to your computer and turning on the power.

Before You Begin

Read “Safety Information” on page vii before setting up your computer.

You will need the following:

- Computer
- Computer power cord
- Keyboard
- Mouse
- Monitor (sold separately with signal cable and power cord)

If you are missing an item, contact your place of purchase.

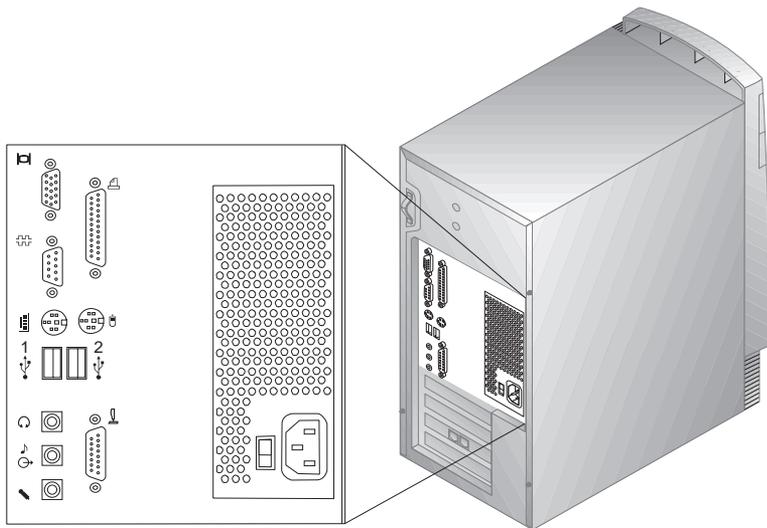
Selecting a Location for Your Computer

Make sure you have an adequate number of properly grounded electrical outlets for the computer, monitor, and any other devices. Select a location for the computer where it will remain dry. Leave about 50 mm (2 in.) of space around the computer for proper air circulation.

For information about arranging your computer for comfort and ease-of-use, refer to Chapter 3, “Arranging Your Workspace” on page 15.

Connecting Computer Cables

When you set up your computer, you will need to know where to find the connectors. The following illustration shows the location of the connectors on the back of the computer. You might not have all of the devices shown here.



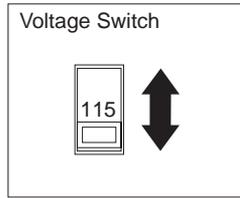
Note: Most of the connectors on the rear of the computer have icons. These will help you to determine where to connect the proper cables on your computer.

Important note for the United Kingdom

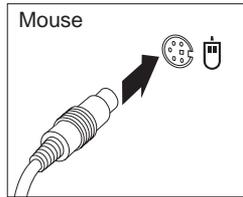
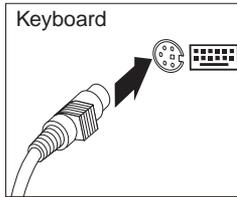
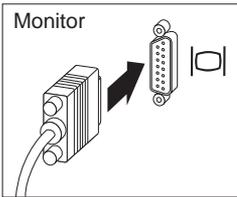
If you are in the United Kingdom, you must, by law, connect the telephone cable *after* the power cord.

Use the following steps to set up your computer.

1. Check the position of the voltage-selection switch. Use a ballpoint pen to slide the switch, if necessary.
 - If the voltage supply range is 90-137 V AC, set the voltage switch to 115 or 115 V.
 - If the voltage supply range is 180-265 V AC, set the voltage switch to 230 or 230 V.

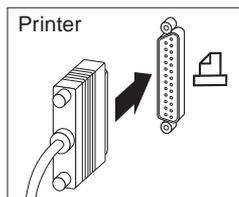


2. Connect the monitor cable to the monitor (if it is not already attached), then to the monitor connector and tighten the attachment screws. Connect the keyboard cable to the gray keyboard connector. Connect the mouse cable to the green mouse connector.

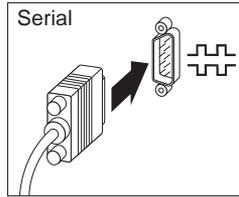


3. Connect any additional devices you have.

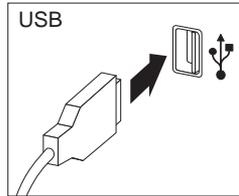
- Any printer or parallel device to the parallel port connector.



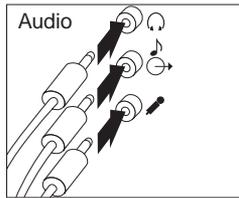
- Any serial device or external modem in the serial connector.



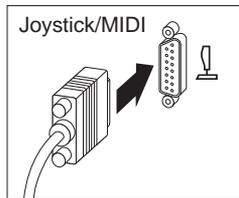
- Any universal serial bus (USB) devices.



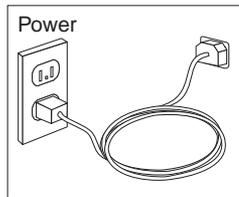
- Any optional devices, such as speakers, microphones, or headphones, for models with an audio device.



- Joystick/MIDI device for models with a joystick/MIDI connector.



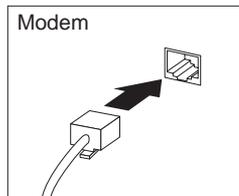
- Connect the power cord to the power connector. If there is a label covering the power connector, remove it. Connect the power cords to the computer, monitor, and other devices first, and then plug the cords into properly grounded electrical outlets.



Important:

- When the power cord is first plugged in, the computer powers on for a few seconds, then powers off. This is normal operation.
- In some circumstances, the computer might not power off immediately when the power switch is pressed. In this case, hold the power switch down until the power turns off.

- Connect the phone line connector for models with a modem.



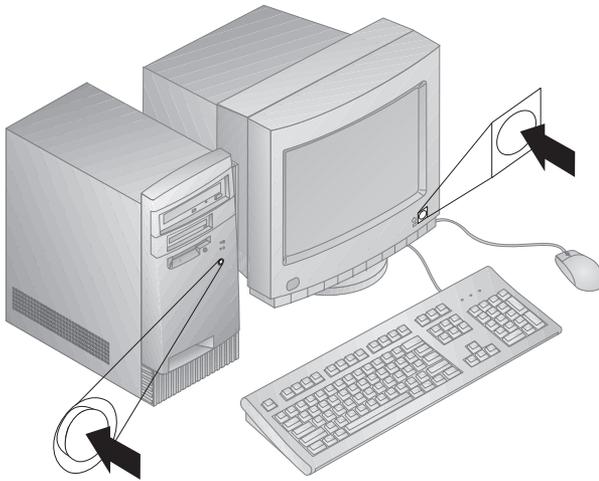
- If your computer came with an Ethernet adapter, connect the Ethernet cable.

Important Information

Class 5 Ethernet cabling must be used for operation of the system within FCC Class A limits.

Turn on Power

Turn on the monitor and other external devices first, and then turn on the computer. See the illustration below for the location of the power switches for the monitor and the computer. You see a logo screen while the computer performs a short self-test. Upon successful completion of the task the logo screen disappears, the BIOS is loaded, and the software is loaded (in models with preinstalled software).



Note: If you suspect a problem, see Chapter 8, “Troubleshooting” on page 83.

Finish the Installation

Chapter 3. Arranging Your Workspace

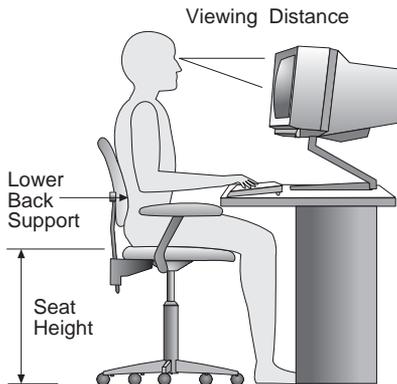
To get the most from your computer, arrange both the equipment you use and your work area to suit your needs and the kind of work you do. Your comfort is of foremost importance, but light sources, air circulation, and the location of electrical outlets also can affect the way you arrange your workspace.

Comfort

Although no single working position is ideal for everyone, the following guidelines will help you find a position that suits you best.

Choose a good chair to reduce the frequency of fatigue from sitting in the same position for a long time. The backrest and seat should adjust independently and provide good support. The seat should have a curved front to relieve pressure on the thighs. Adjust the seat so that your thighs are parallel to the floor and your feet are either flat on the floor or on a footrest.

When using the keyboard, keep your forearms parallel to the floor and your wrists in a neutral, comfortable position. Try to keep a light touch on the keyboard and your hands and fingers relaxed. You can change the angle of the keyboard for maximum comfort by adjusting the position of the keyboard feet.



Adjust the monitor so that the top of the screen is at, or slightly below, eye level. Place the monitor at a comfortable viewing distance, usually 51 to 61 cm (20 to 24 in.), and position it so that you can view it without having to twist your body.

Glare and Lighting

Position the monitor to minimize glare and reflections from overhead lights, windows, and other light sources. Place the monitor at right angles to windows and other light sources whenever possible. Reduce overhead lighting, if necessary, by turning off lights or using lower wattage bulbs. If you install the monitor near a window, use curtains or blinds to block the sunlight. You might have to adjust the Brightness and Contrast controls on the monitor as the room lighting changes throughout the day.

Where it is impossible to avoid reflections or to adjust the lighting, place an antiglare filter over the screen. However, these filters might affect the clarity of the image on the screen; try them only after you have exhausted other methods of reducing glare.

Dust buildup compounds problems associated with glare. Remember to clean your monitor screen periodically using a soft cloth moistened with a nonabrasive liquid glass cleaner.

Air Circulation

Your computer and monitor produce heat. The computer has a fan that pulls in fresh air and forces out hot air. The monitor lets hot air escape through vents. Blocking the air vents can cause overheating, which might result in a malfunction or damage. Place the computer and monitor so that nothing blocks the air vents; usually, 51 mm (2 in.) of air space is sufficient. Also, make sure the vented air is not blowing on someone else.

Electrical Outlets and Cable Lengths

The location of electrical outlets and the length of power cords and cables that connect to the monitor, printer, and other devices might determine the final placement of your computer.

When arranging your workspace:

- Avoid the use of extension cords. Whenever possible, plug the computer power cord directly into an electrical outlet.
- Keep power cords and cables neatly routed away from walkways and other areas where they might be kicked accidentally.

For more information about power cords, see “Power Cord Notice” on page 150.

Chapter 4. Operating Your Computer

This chapter provides information to help you in the day-to-day use of your computer.

Important Information

- When the power cord is first plugged in, the computer might appear to power on for a few seconds, then power off. This is a normal sequence.
- The power switch will normally operate with a single touch. However, in some circumstances the computer might not power off immediately. In this case, hold the power switch down for approximately 5 seconds. The computer will then turn off.
- Always shut down your operating system before turning off the computer. Refer to your operating system documentation for the proper procedure to shut down your operating system.
- Proper cooling is required for the reliable performance of internal components. Do not operate your computer with the cover off.

Starting Your Computer

What you see and hear when you start up your computer depends on the settings in the Start Options menu of the Configuration/Setup Utility Program. The default settings are **Power On Status** [*Disabled*] and **Power On Self Test** [*Quick*].

Note: Other selections also might change what is displayed when the computer starts up.

The following briefly describes what happens in the default mode when you turn on your computer:

1. The IBM logo appears.
2. The amount of system memory and extended memory appears in the top-left corner of screen.
3. The Press F1 for Configuration/Setup prompt appears.
4. If any errors were detected during POST, they are displayed.
5. If you have set a power-on password, a prompt appears on the screen. If you have set both power-on and administrator passwords, you can type either password at the password prompt. When you type your password at the prompt and press **Enter**, the first screen of your operating system or application program appears.

6. If the system hardware configuration has changed, the Configuration/Setup Utility Program menu may be displayed when you press **Enter**.

For more information, see “Power-On Self-Test (POST)” on page 84.

If **Power On Status** is [*Enabled*], and the power-on self-test (POST) finishes without detecting a problem, you hear one beep. If POST detects a problem when you start your computer, you hear multiple beeps or no beep. In most cases, an error code appears in the top-left corner of the screen, and in some cases a description of the error is displayed beside the code. (Note that the screen will sometimes display multiple error codes and descriptions.) Write down all error code numbers and descriptions.

If **Power On Self Test** is [*Enhanced*], numbers showing the amount of memory being tested appear in the top-left corner of the screen until the total amount of memory in the system is reached. Prompts for running a fast POST or accessing the Configuration/Setup Utility Program appear in the lower-left corner of the screen.

Shutting Down

When you are ready to turn off your computer, follow the shutdown procedure for your operating system to prevent the loss of unsaved data or damage to your software programs. See your operating system documentation for instructions.

Using System-Management Features

This section describes features that enable a network administrator or file server to remotely manage and control your computer. For more information about system management, refer to *Understanding Your Personal Computer* (provided on the *Software Selections* CD that comes with your computer).

Desktop Management Interface

Desktop Management Interface (DMI) is a method for gathering information about the hardware and software in your computer. In a network environment, network administrators can use DMI to remotely monitor and control your computer. For more information about DMI, refer to *Understanding Your Personal Computer* (provided on the *Software Selections* CD that comes with your computer).

Wake on LAN

The Wake on LAN feature requires a Wake on LAN network card. A network administrator can use this feature to turn on your computer from a remote location. When Wake on LAN is used in conjunction with network management software, such as Netfinity (provided on the *Software Selections* CD that comes with your computer), many types of functions, such as data transfers, software updates, and POST or BIOS updates to your computer can be initiated remotely. For more information, see the documentation that comes with your Ethernet adapter.

Note: If the computer power cord is plugged into a surge protector, make sure that when you turn off power you use the computer power switch and not the surge protector switch. Otherwise, the Wake on LAN feature will not work.

Wake on Ring

The wake on ring feature can be used to turn on your computer when a wake on ring supported modem receives a call from the telephone line to which it is connected. It is configured in the Configuration/Setup Utility Program.

Remote Program Load or Dynamic Host Configuration Protocol

If your computer comes with an Ethernet adapter, a network administrator can use Remote Program Load (RPL) and Dynamic Host Configuration Protocol (DHCP) to control your computer. If you use RPL in conjunction with software such as LANClient Control Manager, you can use a feature called *Hybrid RPL*, which installs hybrid images (or files) on the hard disk. Then, each time the computer starts from the network, LANClient Control Manager recognizes your computer as a Hybrid RPL client and a *bootstrap* program is downloaded to your computer hard disk. This bootstrap program is small, which helps prevent network congestion. An advantage to Hybrid RPL is that the network traffic associated with a standard RPL is avoided.

Remote Administration

A network administrator can use this feature to update remotely the POST and BIOS in your computer. Network management software, such as LANClient Control Manager, is required in order to take advantage of this feature. Refer to “Setting Remote Administration” on page 36 for configuration information.

Using Video Features

Your computer has a super video graphics array (SVGA) advanced graphics port (AGP) controller located on the system board. SVGA is a video standard for displaying text and graphic images on a monitor screen. Like other video standards, SVGA supports a variety of *video modes*. Video modes are different combinations of resolution, refresh rate, and color defined by a video standard for displaying text or graphics. For more information on video modes, refer to *Understanding Your Personal Computer* (provided on the *Software Selections* CD that comes with your computer).

Video Device Drivers

To take full advantage of the graphics adapter in your computer, some operating systems and application programs require custom software, known as video device drivers. These device drivers provide support for greater speed, higher resolution, more available colors, and flicker-free images.

Device drivers for the graphics adapters and a README file with instructions for installing the device drivers are provided on the *Software Selections* CD that comes with your computer. If your computer has IBM-preinstalled software, video device drivers have already been installed on the hard disk. However, you can use the device driver installation instructions if you ever need to reinstall the device drivers; if you want to change video resolution, color depth, or monitor settings; or if you need information on obtaining and installing updated device drivers.

See Chapter 9, “Getting help, service, and information” on page 121 for more information.

Changing Monitor Settings

To get the best possible image on your screen and to reduce flicker, you might need to reset the resolution and refresh rate of your monitor. You can view and change monitor settings through your operating system using the instructions provided in the README files on the *Software Selections* CD that comes with your computer. Refer to your operating system documentation for further information on monitor settings.

Attention

Before you change any monitor settings, be sure to review the information that comes with your monitor. Using a resolution or refresh rate that is not supported by your monitor might cause the screen to become unreadable and could damage the monitor. The information that comes with your monitor usually includes the resolutions and refresh rates that the monitor supports. If you need additional information, contact the manufacturer of the monitor.

To minimize screen flicker and jitter, set your monitor for the highest noninterlaced refresh rate that the monitor supports. If your monitor complies with the VESA Display Data Channel (DDC) standard, it is probably already set to the highest refresh rate that the monitor and video controller can support. If you are not sure if your monitor is DDC-compliant, refer to the documentation provided with the monitor.

Using Audio Features

Some models have an integrated ESS 1938 audio controller that supports Sound Blaster applications and is compatible with the Microsoft Windows Sound System. These models also have a single internal speaker and three audio ports. The audio controller provides you with the ability to play back and capture sound and music, and with the internal speaker you can enjoy sound with multimedia applications. Optionally, you can connect two stereo speakers to the audio connectors to enjoy better sound with multimedia applications.

The audio connectors in your computer are 3.5 mm (1/8-in.) mini-jacks. A description of the connectors follows. (For the location of the connectors, refer to “Connecting Computer Cables” on page 10.)

Headphone: This jack is used to send audio signals from the computer to external devices, such as stereo-powered speakers with built-in amplifiers, headphones, multimedia keyboards, or the Audio Line-In jack on a stereo system.

Note: The internal speaker in your computer is disabled when an external speaker is connected to the headphone port on your computer.

Audio Line Out: This jack is used to send audio signals from the computer to external devices, such as stereo-powered speakers with built-in amplifiers, headphones, multimedia keyboards, or the Audio Line-In jack on a stereo system.

Microphone: This port is used to connect a microphone to your computer when you want to record voice or other sounds on the hard disk. This port can also be used by speech recognition software.

Note: If you experience interference or speaker feedback while recording, try reducing the microphone recording volume (gain).

Procedures for recording and playing back sound vary by operating system. Refer to your operating system documentation for information and instructions.

Updating System Programs

System programs are the basic layer of software built into your computer. They include the power-on self-test (POST), the basic input/output system (BIOS) code, and the Configuration/Setup Utility Program. POST is a set of tests and procedures that is performed each time you turn on your computer. BIOS is a layer of software that translates instructions from other layers of software into electrical signals that the computer hardware can understand. You can use the Configuration/Setup Utility Program to view and change the configuration and setup of your computer.

Your computer system board has a module called *electrically erasable programmable read-only memory* (EEPROM, also referred to as *flash memory*). You can easily update POST, BIOS, and the Configuration/Setup Utility Program by starting your computer using a flash update diskette or by using the Remote Administration feature, if enabled. See “Setting Remote Administration” on page 36 for more information.

As part of the continuing work to improve quality, IBM might make changes and enhancements to the system programs. When updates are released, they are available as downloadable files on the World Wide Web or through the PC Company Bulletin Board Service (see Chapter 9, “Getting help, service, and information” on page 121). Instructions for using the system programs updates are available in a README file included in the update files.

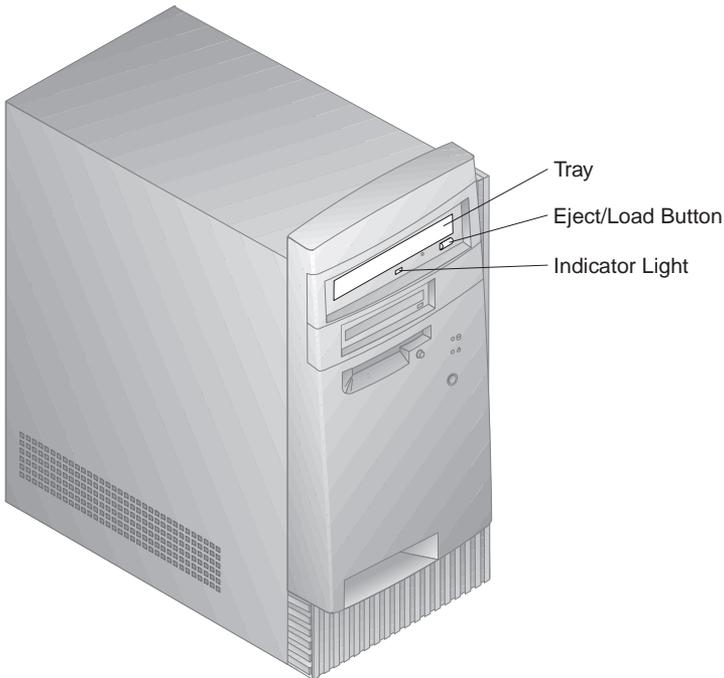
Using a CD-ROM Drive

Some models have a preinstalled CD-ROM drive. CD-ROM drives can play back or read from a CD, but cannot write information to it. CD-ROM drives use industry-standard, 12 cm (4.75-inch) CDs.

Follow these guidelines when using a CD-ROM drive:

- Do not place the drive where there is:
 - High temperature
 - High humidity
 - Excessive dust
 - Excessive vibration or sudden shock
 - An inclined surface
 - Direct sunlight
- Do not insert any object other than a CD into the drive.
- Before moving the computer, remove the CD from the drive.

The following is an illustration of the front bezel of the CD-ROM drive.



Handling a CD

When handling a CD, follow these guidelines:

- Hold the CD by its edges. Do not touch the surface.
- To remove dust or fingerprints, wipe the CD with a clean, soft cloth from the center to the outside. Wiping the CD in a circular direction might cause loss of data.
- Do not write or stick paper on the CD.
- Do not scratch or mark the CD.
- Do not place or store the CD in direct sunlight.
- Do not use benzene, thinners, or other cleaners to clean the disk.
- Do not drop or bend the CD.

Loading a CD

To load a CD into a CD-ROM drive:

1. Press the Eject/Load button. The tray slides out of the drive. (Do not manually force the tray open.)
2. Place the CD in the tray with the label facing up.
3. Close the tray by pressing the Eject/Load button, or by gently pushing the tray forward. When the tray is closed, the indicator light on the front of the drive will activate to indicate that the drive is in use.
4. To eject the CD, press the Eject/Load button. When the tray slides out, carefully remove the disk.
5. Close the tray by pressing the Eject/Load button, or by gently pushing the tray forward.

Note: If the tray does not slide out of the drive when you press the Eject/Load button, insert the pointed end of a large paper clip into the emergency-eject hole located above and to the left of the CD-ROM indicator light.

Using Your Zip Drive

Some models come with a Zip drive. This section provides information to help you use a Zip drive with your computer.

To access your Zip drive, insert a Zip 100 MB capacity disk into the drive and select the drive letter assigned to the Zip drive on your computer. Store and copy files to and from the Zip drive using the same methods you use for other drives on your system.

Inserting and Ejecting a Zip Disk

Always turn on power to the computer *before* inserting a Zip disk. When you insert a Zip disk, the drive-busy light will flash momentarily and go out. (If the light continues to blink slowly, push the disk eject button to eject the Zip disk, then reinsert it.)

To eject the disk on a Windows NT system, use the software eject command. To eject the disk on a Windows 98 system, push the disk eject button or use the software eject command.

It is not necessary to remove the Zip disk from the drive when you shut down your computer; however, if you want to remove the Zip disk, do so before turning off your computer. When you remove the Zip disk from the drive, store it in the protective case.

CAUTION:

Disconnect power from the computer before using the emergency-disk eject hole. Do not try to force a Zip disk out of the drive. If the disk does not eject immediately, repeat the emergency disk-eject procedure.

The computer must be powered on for normal disk ejection from the Zip drive. If you must remove a Zip disk from the drive during a power failure, access the rear of the Zip drive and push a straightened paper clip into the emergency-eject hole which is located just above the power connector.

Drive Sleep Mode

The Zip drive has an automatic sleep mode designed to reduce power consumption and prolong the life of Zip disks. Sleep mode automatically spins down a disk after 15 minutes of inactivity, and the disk automatically spins up again when it is accessed. You can change the sleep mode time using your tools software.

Additional information might have been provided with the drive. If so, refer to the documentation that comes with the drive.

Using Security Features

To deter unauthorized use of your computer, you can lock the cover and keyboard.

Locking the Cover

Your computer comes with a built in padlock loop. You can use this loop to lock the cover to your computer with a padlock.

Locking the Keyboard

You can disable the keyboard so that others are unable to use it. If a power-on password is set, the keyboard is locked when you turn on the computer. You must type the correct password before the keyboard will unlock. You can enable the power-on password feature with the Configuration/Setup Utility Program. See Chapter 5, “Using the Configuration/Setup Utility Program” on page 27.

Some operating systems have a keyboard and mouse lock-up feature. Check the documentation that comes with your operating system for more information.

Using a Security U-Bolt

Optionally, you can install a security U-bolt on the back of your computer to keep your computer bolted to the location you have selected for your computer. For instructions on installing a security U-bolt, see “Installing a Security U-bolt” on page 75.

Chapter 5. Using the Configuration/Setup Utility Program

The Configuration/Setup Utility Program is stored in the EEPROM (electrically erasable programmable read-only memory) of your computer. You can use the Configuration/Setup Utility Program to view and change the configuration and setup of your computer, regardless of which operating system you are using. However, the settings you select in your operating system might override any similar settings in the Configuration/Setup Utility Program.

This chapter contains information about starting, using, and exiting from the Configuration/Setup Utility Program. It also contains information about passwords, startup sequence, remote administration, and power management and concise step-by-step instructions for enabling network-related settings for your computer.

Starting and Using the Configuration/Setup Utility Program

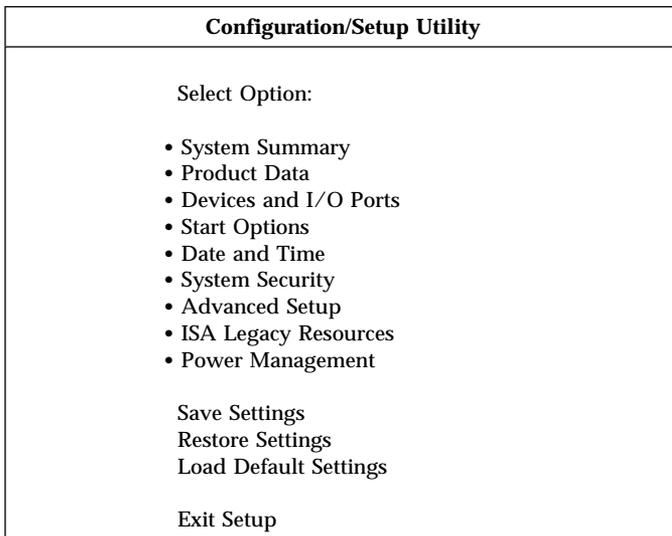
To start the Configuration/Setup Utility Program:

1. Turn on your computer. If your computer is already on when you start this procedure, you must shut down the operating system, turn off the computer, wait a few seconds until all in-use lights go off, and restart the computer. (Do not use **Ctrl+Alt+Del** to restart the computer.)
2. When the Configuration/Setup Utility Program prompt appears in the lower-left corner of the screen during startup, press **F1**. (This prompt appears on the screen for only a few seconds. You must press **F1** quickly.)
3. If you have *not* set an administrator password, the Configuration/Setup Utility Program menu appears on the screen. If you have set an administrator password, the Configuration/Setup Utility Program menu will not appear until you type your administrator password and press **Enter**. See “Power-On Password” on page 30 and “Administrator Password” on page 33 for more information.

Note: If new system hardware has been added *and* one or more of the following statements are true, the Configuration/Setup Utility Program menu will display before control is passed to the operating system:

- Enhanced POST is in effect
- Power-on password is enabled
- Administrator password is enabled

The menu you see on your computer might look slightly different from the menu shown here, but it will operate the same way.



Viewing and Changing Settings

The Configuration/Setup Utility Program menu lists items that identify system configuration topics. If a bullet (•) appears beside a menu item, an additional menu is available. If a right arrowhead (▶) appears beside a menu item, a change to that item has been made or the Configuration/Setup Utility Program detected an error and attempted to correct it. The system can automatically configure new devices if Quick POST is enabled *and* no form of security (passwords) exists on the system. Also, an additional menu might follow a menu item with a ▶ beside it. If an asterisk (*) appears next to a menu item, it indicates a system resource conflict. Resolve this conflict before exiting from the Configuration/Setup Utility Program so that your computer will function properly. For information and instructions on resolving system resource conflicts, refer to the documentation that comes with the hardware you want to install and see “Adapter Configuration” on page 67.

When working with the Configuration/Setup Utility Program menu, you must use the keyboard. Refer to the following table for the keys used to accomplish various tasks.

Keys	Function
↑ ↓	Use these arrow keys to move among menu items until the item you want is highlighted.
← →	Use these arrow keys to display and toggle among choices for a menu item.
Enter	Press this key to select a highlighted menu item.
Esc	Press this key to exit from a menu after viewing or making changes to the settings in the menu.
+	Use this key in some menus to increase the numerical value of a setting.
-	Use this key (the minus or hyphen key) in some menus to decrease the numerical value of a setting.
0-9	Use these number keys in some menus to change the numerical value of a setting.
F1	Press this key for help on a selected menu item.
F9	Press this key if you changed and saved the setting of a selected menu item and you want to restore the setting that was active before you made the change.
F10	Press this key to return the setting of a selected menu item to a default value.

Note: Active keys are displayed at the bottom of each screen; not all of the above keys are active on every menu.

In the Configuration/Setup Utility Program menus, the configuration information you can change is enclosed in brackets like these []. You cannot change information that is not surrounded by brackets.

Important Information:

In most cases, when you add or remove hardware from your computer or erase passwords, the BIOS (basic input/output system) detects the changes and then updates the configuration automatically. However, you must **save** these changes before the new configuration takes effect. To save the configuration, select **Save Settings** from the Configuration/Setup Utility Program menu.

Exiting from the Configuration/Setup Utility Program

When you finish viewing or changing settings in the Configuration/Setup Utility Program, follow these steps to exit the program:

1. Press **Esc** to return to the main Configuration/Setup Utility Program menu. (Depending on where you are in the program, you might have to press **Esc** several times to get back to the Configuration/Setup Utility Program menu.)
2. Before you exit the Configuration/Setup Utility Program menu, select **Save Settings** if you want to save all settings as they currently appear. If you do not complete this step, your settings will not be saved.
3. From the Configuration/Setup Utility Program menu, press **Esc**, and follow the instructions on the screen.

Passwords

You can use passwords to provide security for your computer and data. You can set two kinds of passwords: a power-on password and an administrator password. You do not have to set a password of either type to use your computer. However, if you decide to set one, read the following sections before you do so.

Power-On Password

Prompt Modes

The *power-on* password feature deters unauthorized persons from gaining access to the information stored in your computer. You do not need to set a power-on password, but doing so allows you to control who can use your computer. When a power-on password is set, you must type the password at a prompt that appears as the computer starts.

When you set the power-on password, you can choose one of three password prompt modes:

- On** In password prompt On mode, you are prompted for the power-on password when you turn on the computer. Until the correct password is entered, the computer's operating system will not start, and the keyboard will remain locked. If you have a mouse connected to the mouse port, it also will remain locked. If you have a mouse connected to a serial port, it will be activated when the computer is started, regardless of whether a password is set.

Note: If **Remote Administration** is enabled, you cannot select **On**. In this case, select **Dual**. If you set this mode to **On**, when **Remote Administration** is enabled, it will automatically be reset to **Dual**. For more information, see “Setting Remote Administration” on page 36.

Off

In password prompt off mode (sometimes referred to as unattended start mode), you are not prompted to enter your power-on password when you turn on the computer. The computer will start the operating system. However, if you have a mouse connected to the mouse port, refer to the following:

Important Information for Mouse Users

This information applies only to those who have a PS/2 mouse. A serial mouse is not affected by the password prompt Off mode.

Password prompt Off mode is useful for network servers and other computers that operate unattended. If a power failure occurs, the computer will automatically restart and resume operating when power is restored without operator intervention.

The password prompt Off mode prevents the computer from detecting a PS/2 mouse. In this mode, the mouse device driver will not be loaded automatically through the CONFIG.SYS or AUTOEXEC.BAT files. An error message informs you that the mouse connector is disabled.

If you are using Windows NT, Windows 95, or Windows 98, when the computer is started and the mouse-port-disabled error message appears, type either your power-on or administrator password to enable the keyboard. The mouse remains disabled. Use the keyboard to put a check mark in the **Do not display this message in the future** check box. When the operating system completes its loading routine, the mouse will be enabled.

If you have an operating system other than Windows 95, Windows 98, or Windows NT, check the documentation that comes with your operating system to enable the mouse on your computer.

Dual

In the password prompt Dual mode, the startup behavior of the computer depends on whether the computer is started from the computer power switch or by an unattended method, such as a modem or timer.

If you start the computer by using the power switch, the computer operates the same as it does in password prompt On mode. Refer to page 30 for further information.

If the computer is started by an unattended method, such as remotely over a LAN, the computer operates the same as it does in password prompt off mode. Refer to page 31 for further information.

Once you enter your power-on password, you will be able to view limited information in the Configuration/Setup Utility Program, but you will not be able to change any settings.

The password does not appear on the screen as you type it. If you type the wrong password, you receive a screen message telling you so. If you type the wrong password three times, you must turn off the computer and start again. When you type the correct password, the keyboard and mouse unlocks, and the computer begins normal operation.

Setting, Changing, and Deleting a Power-On Password

Use the Configuration/Setup Utility Program to set or change a power-on password. You can use any combination of up to seven characters (A–Z, a–z, and 0–9) for this password.

Attention

Keep a record of your power-on password in a secure place. When a power-on password has been set, you cannot activate the operating system without first using the password. If you lose or forget your password, you cannot change or delete it without removing the computer cover and moving a jumper on the system board. Refer to “Erasing a Lost or Forgotten Administrator Password” on page 34 for further information.

To set, change, or delete a power-on password:

1. Start the Configuration/Setup Utility Program (see “Starting and Using the Configuration/Setup Utility Program” on page 27).
2. From the Configuration/Setup Utility Program menu, select **System Security** and press **Enter**.
3. Select **Power-On Password** and press **Enter**.
4. To delete a power-on password, select **Delete Power-On Password** and go to step 9 on page 33.
5. Select **Change Power-On Password**, and follow the instructions on the screen.

6. To set a new password, type your new password and press Down Arrow (↓).
7. Type your new password again.
8. At **Password Prompt**, select **Off**, **On**, or **Dual**. Press Left Arrow (←) or Right Arrow (→) to toggle among selections.
Note: If **Remote Administration** is enabled, you cannot select **On**. In this case, select **Dual**. If you set this mode to **On**, when **Remote Administration** is enabled, the mode will automatically be reset to **Dual**.
9. Press **Esc** twice to return to the Configuration/Setup Utility Program menu.
10. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu.
11. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

Administrator Password

Setting an administrator password deters unauthorized persons from changing configuration settings using the Configuration/Setup Utility Program. If you are responsible for maintaining the settings of several computers, you might want to set an administrator password.

After you set an administrator password, a password prompt appears each time you try to access the Configuration/Setup Utility Program. If you type the wrong password, you receive a message telling you so. If you type the wrong password three times in succession, you must turn the computer off and start again.

If both a power-on and administrator password are set, you can type either of the passwords. However, in order to change any settings, you must use your administrator password.

Setting, Deleting, or Changing an Administrator Password

Use the Configuration/Setup Utility Program to set or change an administrator password. You can use any combination of up to seven characters (A-Z, a-z, and 0-9) for the password.

Attention

Keep a record of your administrator password in a secure place. If you lose or forget the administrator password, you will not be able to access the Configuration/Setup Utility Program. You must remove the computer cover and move a jumper on the system board to regain access to the Configuration/Setup Utility Program. (Refer to “Erasing a Lost or Forgotten Administrator Password” on page 34 for more information.)

To set, change, or delete an administrator password:

1. Start the Configuration/Setup Utility Program (see “Starting and Using the Configuration/Setup Utility Program” on page 27).
2. From the Configuration/Setup Utility Program Program menu, select **System Security** and press **Enter**.
3. Select **Administrator Password** and press **Enter**.
4. To delete an administrator password, select **Delete Administrator Password** and go to step 8.
5. To set an administrator password, type your password, press Down Arrow (↓), and type your password again.
6. At **Power-On Password Changeable by User**, select **Yes** or **No**. Press Left Arrow (←) or Right Arrow (→) to toggle between selections. (If you select **Yes** and an administrator password is set, the power-on password can be changed without having to enter the administrator password. If you select **No** and an administrator password is set, the power-on password cannot be changed unless the administrator password is entered.)
7. Select **Change Administrator Password** and follow the instructions on the screen.
8. Press **Esc** until you return to the Configuration/Setup Utility Program menu.
9. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu.
10. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

Erasing a Lost or Forgotten Administrator Password

Important

If possible, record the configuration information of your computer *before* moving the CMOS jumper.

To erase a lost or forgotten administrator password:

1. Turn off the computer and all attached devices.
2. Unplug the power cord.
3. Remove the cover. See “Removing the Cover” on page 54.
4. Refer to the system board label inside the computer to locate the *CMOS Clear Jumper*. See the jumper pin settings also on this label.

CAUTION:

Do not touch any components while power is on.

5. Move the jumper from its normal position (pins 1 and 2) to pins 2 and 3. It might be helpful to use needlenose pliers to move the jumper, but be careful not to damage any system board components or crush the jumper.
6. Replace the cover.
7. Plug in the power cord.
8. Restart the computer. The computer will enter the Configuration/Setup Utility Program.
9. Disable the power-on or administrator password settings or set new passwords.
10. Save password settings and turn off the computer.
11. Unplug the power cord and remove the cover. See “Removing the Cover” on page 54.
12. Move the jumper back to its normal position (pins 1 and 2).
13. Replace the computer cover.
14. Plug in the power cord.

After clearing CMOS memory, you must reconfigure the computer. After reassembling the computer, use the Configuration/Setup Utility Program to reset the date and time, reset any passwords, and reconfigure the computer.

Other Settings in the Configuration/Setup Utility Program

The information in this section includes instructions for changing other settings in the Configuration/Setup Utility Program, such as the keyboard speed, the startup sequence, remote administration, and power management.

Changing Keyboard Speed

You can change the speed at which the keyboard responds when you hold down a key. This setting can be found under Start Options in the Configuration/Setup Utility Program. The normal *typematic rate* is 30 characters per second (fast rate).

Setting the Startup Sequence

Your computer can be started from several devices including the hard disk drive, diskette drive, CD-ROM drive, or from the network. The startup program looks for these devices in a selected sequence. You can use Configuration/Setup Utility Program to select the startup sequence.

To set the startup sequence:

1. Start the Configuration/Setup Utility Program (see “Starting and Using the Configuration/Setup Utility Program” on page 27).
2. Select **Start Options** and press **Enter**.
3. Select **Startup Sequence** from the Start Options menu and press **Enter**.
4. Select **First Startup Device** and press **Enter**.
5. Use the arrow keys to make your selection and press **Enter**.
6. If necessary, repeat the above steps for **Second Startup Device**, **Third Startup Device**, and **Fourth Startup Device**.
7. If **Automatic Power On Startup Sequence** is *Enabled*, select the sequence and devices from the choices provided.
8. Press **Esc** until you return to the Configuration/Setup Utility Program menu.
9. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu and press **Enter**.
10. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

Setting Remote Administration

You can remotely update the system programs, such as POST and BIOS, from a network server by enabling remote administration. If you have set an administrator password for your computer, the password does *not* have to be entered in order to remote update from the server. Consult your network administrator for information on setting up your network server to perform POST and BIOS updates.

To set remote administration, follow these steps:

1. Start the Configuration/Setup Utility Program. See “Starting and Using the Configuration/Setup Utility Program” on page 27.
2. Select **System Security** and press **Enter**.
3. Select **Remote Administration** and press **Enter**.
4. To enable update remote administration, select **Enabled**. To disable, select **Disabled**. Press **Enter**.
5. Press **Esc** until you return to the Configuration/Setup Utility Program main menu.
6. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu.
7. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

ISA Legacy Resources

Adapters that are not Plug and Play are known as *legacy* adapters. If you install a legacy adapter, you must manually configure it by setting switches or jumpers on the adapter and by reserving its resources using the Configuration/Setup Utility Program.

In the Configuration/Setup Utility Program, the ISA Legacy Resources screen shows the computer resources that are typically required by adapters:

- Memory resources
- I/O port resources
- DMA resources
- Interrupt resources

You can select available resources for the adapter you are installing. Resources not being used by ISA legacy adapters are listed as [**Available**]. You must set the resources used by the newly installed ISA legacy adapter to [**ISA Resource**]. This notifies the Plug and Play software that these resources are in use.

To store the legacy resource information for an installed adapter:

1. Start the Configuration/Setup Utility Program (see “Starting the Configuration/Setup Utility Program” on page 80).
2. Select **ISA Legacy Resources** and press **Enter**.
3. As needed, select **Memory Resources**, **I/O Port Resources**, **DMA Resources**, or **Interrupt Resources**. See “Interrupt and DMA Resources” on page 38.

4. Set the appropriate resource to **ISA Resource** and press **Enter**.
5. Return to the Configuration/Setup Utility Program menu and select **Save Settings** to save the changes and press **Enter**. Exit from the Configuration/Setup Utility Program program.

Just as you change system resources for installed adapters, you must also change resources when you remove an ISA legacy adapter. If you remove a legacy adapter, change the resources it formerly used to [**Available**]. This allows the Plug and Play software to automatically use these resources for future configurations, or you can use these resources for future manual configurations.

Note: Refer to the documentation that comes with the adapter for information on required system resources.

For information on configuring ISA legacy adapters, see “ISA Legacy Resources” on page 37.

For information about error messages from resource conflicts, see Chapter 8, “Troubleshooting” on page 83.

Interrupt and DMA Resources

Power-Management Features

Your computer comes with built-in energy-saving capabilities. You can view and change energy-saving settings using the power-management menu in the Configuration/Setup Utility Program. This section describes the power-management features in your computer and provides instructions for using these features.

Attention

If a device, such as a monitor, does not have power-management capabilities, it can be damaged when exposed to a reduced-power state. Before you make energy-saving selections for your monitor, check the documentation that comes with your monitor to see if it supports Display Power Management Signaling (DPMS).

ACPI BIOS Mode

Automatic Configuration and Power Interface (ACPI) BIOS mode is always enabled so that the operating system can control the power-management features of your computer. Not all operating systems support ACPI BIOS mode. Refer to your operating system documentation to determine if ACPI is supported.

³ Can be modified to alternative settings or disabled.

Setting Power-Management Features

With power-management, the computer and monitor (if the monitor supports DPMS) can be set to go into a reduced-power state if they are inactive for a specified length of time.

- **Time to Low Power:** With this option, you can specify the amount of time that the computer must be inactive before power-management features take effect. You can select from 5 minutes to 1 hour.
- **System Power:** With this option, you can select **On** if you want the computer to remain on, or **Off** if you want the computer to shut down.
- **Display:** You can use this option to select one of the following reduced-power states:
 - **Standby:** In this mode, the screen is blanked, but the screen image is restored *immediately* when any activity is detected.
 - **Suspend:** In this mode, the monitor uses less power than in Standby mode. The screen is blanked, but the screen image is restored *within a few seconds* after any activity is detected.
 - **OFF:** In this mode, the monitor power is turned off. To restore power to the monitor, you must press the monitor power switch. On some monitors, you might have to press the power switch twice.

If **OFF** is selected, you must specify the **Time to Display 'off'**. You can select 5 minutes to 1 hour.

Note: *Time to display off* is the amount of time after the reduced-power state begins until the display turns off.
 - **Disable:** In this mode, the monitor is unaffected by the power management settings.
- **IDE Drives:** You can use this selection to specify if the IDE drives should be enabled or disabled when power management options take effect.

To set power-management features:

1. Start the Configuration/Setup Utility Program (see “Starting and Using the Configuration/Setup Utility Program” on page 27).
2. Select **Power Management** and press **Enter**.
3. Select **APM** and press **Enter**.
4. Set **Automatic Hardware Power Management** to **Enabled**.
5. Select values for power management (time to low power, system power, processor speed, display, and time to display off), as desired.
6. Select **Activity Monitor** and press **Enter**.

7. Set to **Enabled** or **Disabled** devices you want to be monitored for power management.
Note: If all devices are set to disabled, you must restart the computer to wake the system.
8. Set **IDE Drives** to **Enabled** or **Disabled**.
9. Press **Esc** twice to return to the Configuration/Setup Utility Program menu.
10. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu.
11. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

Setting Automatic Power-On Features

You can use the Automatic Power-On features on the Power Management menu to enable and disable features that automatically turn on your computer. You must also select the startup sequence you want to use for the type of power-on event selected.

- **Wake on LAN:** If you have remote-network-management software and a Wake on LAN supported network adapter, you can use the IBM-developed Wake on LAN feature. When you set Wake on LAN to **Enabled**, your computer will turn on when it receives a specific signal from another computer on your local area network (LAN). For more information, see the documentation that comes with your network adapter.
- **Serial Port Ring Detect:** If your computer has an *external* modem connected to a serial port and you want the computer to turn on automatically when a ring is detected on the modem, set this feature to **Enabled**. The modem must also support this feature.
- **Modem Ring Detect:** If your computer has a wake on ring supported modem and you want the computer to turn on automatically when a ring is detected on the modem, set this feature to **Enabled**.
- **Wake Up on Alarm:** With this feature, you can specify a date and time at which the computer will be turned on automatically. This can be either a single event, a daily event, or a weekly event.
- **PCI Wake Up:** If this setting enabled, your computer turns on in response to wake up requests from PCI devices that support this feature.

To set Automatic Power-On features, follow these steps:

1. Start the Configuration/Setup Utility Program (see “Starting and Using the Configuration/Setup Utility Program” on page 27).

2. Select **Power Management** and press **Enter**.
3. Select **Automatic Power On** and press **Enter**.
4. Select the menu item for the feature you want to set. Use Left Arrow (←) or Right Arrow (→) to select either **Enabled** or **Disabled**. Press **Enter**.
5. Select Startup Sequence for the feature. Use Left Arrow (←) or Right Arrow (→) to select either **Primary** or **Automatic**. If you select **Automatic**, make sure **Automatic Power On Startup Sequence** in the Startup Sequence menu is set to **enabled**. Otherwise, the system will use the **Primary** startup sequence.
6. Press **Esc** until you return to the Configuration/Setup Utility Program menu.
7. Before you exit from the program, select **Save Settings** from the Configuration/Setup Utility Program menu and press **Enter**.
8. To exit from the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.

Quick Reference for Network-Related Settings

Some models come with an Ethernet adapter. The following instructions are guidelines to help you if your computer is using an Ethernet adapter to network with other computers.

The following tables are not intended to help determine which settings to choose. They are only intended to help you quickly find the steps necessary to get to the choices for specific network settings. You can then view the current setting or select a different setting. When finished, you can either save the settings and exit the utility program or exit without saving the settings.

The steps in the following tables always start at the Configuration/Setup Utility Program main menu.

Chapter 6. Taking Care of Your Computer

This section provides guidelines for the proper handling and care of your computer.

Basics

Here are some basic points about keeping your computer functioning properly:

- Keep your computer in a clean, dry environment. Make sure it rests on a flat, sturdy surface.
- Do not place items on top of the monitor or cover any of the vents in the monitor or computer. These vents provide air flow to keep your computer from overheating.
- Keep food and drinks away from all parts of your computer. Food particles and spills might make the keyboard and mouse sticky and unusable.
- Do not get the power switches or other controls wet. Moisture can damage these parts and cause an electrical hazard.
- Always disconnect a power cord by grasping the plug, not the cord.

Cleaning Your Computer

It is a good practice to clean your computer periodically to protect the surfaces and ensure trouble-free operation.

CAUTION:

Be sure to turn the computer and monitor power switches off before cleaning the computer and monitor screen.

Computer and Keyboard

Use only mild cleaning solutions and a damp cloth to clean the painted surfaces of the computer.

Monitor Screen

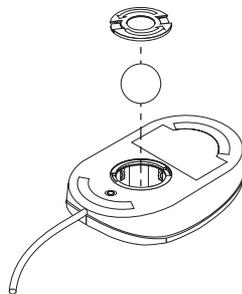
Do not use abrasive cleaners when cleaning the surface of the monitor screen. The screen surface is easily scratched, so avoid touching it with pens, pencil points, and erasers.

To clean the screen surface, wipe it gently with a soft, dry cloth, or blow on the screen to remove grit and other loose particles. Then use a soft cloth moistened with a nonabrasive liquid glass cleaner.

Mouse

If the pointer on the screen does not move smoothly with the mouse, you might need to clean the mouse. To clean your mouse:

1. Turn off the computer.
2. Disconnect the mouse cable from the computer.
3. Turn the mouse upside down. Unlock the retainer on the bottom of the mouse by moving it in the direction indicated by the arrow on the retainer.



4. Turn the mouse right-side up, and the retainer and ball will drop out.
5. Wash the ball in warm, soapy water, and dry it well.
6. Using a damp cloth, wipe the outside of the mouse and the retainer. Be sure to wipe the rollers inside the mouse.
7. Insert the ball and retainer. Lock the retainer by moving it in the opposite direction of the arrow.
8. Reconnect the mouse cable to the computer.

Moving Your Computer

Take the following precautions before moving your computer.

1. Back up all files and data from the hard disk.
Operating systems can vary in the way they perform backup procedures. Refer to your operating system documentation for information about software backup.
2. Remove all media (diskettes, compact discs, tapes, and so on) from the drives.
3. Turn off the computer and all attached devices. Your hard disk drive automatically parks the read/write heads in a nondata area. This process prevents damage to the hard disk.
4. Unplug the power cords from electrical outlets.
5. Note where you have attached your cables to the rear of the computer; then remove them.
6. If you saved the original shipping cartons and packing materials, use them to pack the units. If you are using different cartons, cushion the units to avoid damage.

Replacing the Battery

Your computer has a special type of memory that maintains the date, time, and settings for built-in features, such as serial- and parallel-port assignments (configuration). A battery keeps this information active when you turn off the computer.

The battery requires no charging or maintenance throughout its life; however, no battery lasts forever. If the battery fails, the date, time, and configuration information (including passwords) are lost. An error message is displayed when you turn on the computer.

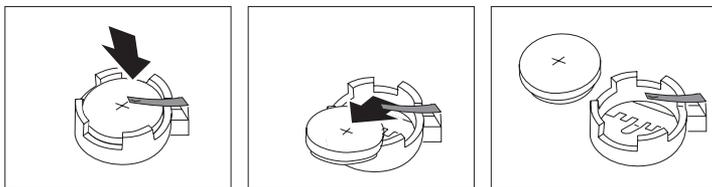
Refer to “Lithium battery notice” on page ix for information about replacing and disposing of the battery.

If you replace the original lithium battery with a heavy-metal battery or a battery with heavy-metal components, be aware of the following environmental consideration. Batteries and accumulators that contain heavy metals must not be disposed of with normal domestic waste. They will be taken back free of charge by the manufacturer, distributor, or representative, to be recycled or disposed of in a proper manner.

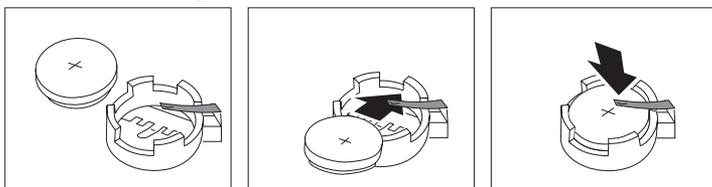

To change the battery

1. Turn off the computer and all attached devices.
2. Unplug the power cord and remove the cover. See “Removing the Cover” on page 54.
3. Locate the battery. Refer to the system board label inside your computer or see “Identifying Parts on the System Board” on page 60.
4. If necessary, remove any adapters that impede access to the battery. See “Installing Adapters” on page 66 for more information.
5. Remove the old battery.



6. Install the new battery.



7. Replace any adapters that were removed to gain access to the battery. See “Installing Adapters” on page 66 for instructions for replacing adapters.
8. Replace the cover and plug in the power cord.
Note: When the computer is turned on for the first time after battery replacement, an error message might be displayed. This is normal after replacing the battery.
9. Turn on the computer and all attached devices.
10. Use the Configuration/Setup Utility Program to set the date and time and any passwords.
11. Dispose of the old battery as required by local ordinances or regulations.

Chapter 7. Installing Options

You can expand the capabilities of your computer by adding memory, drives, or adapters. When adding an option, use these instructions along with the instructions that come with the option.

Important:

Before you install or remove any option, read the “Safety Information” on page vii. These precautions and guidelines will help you work safely.

Attention

The presence of 5 V standby power might result in damage to your hardware unless you disconnect the power cord from the wall before opening the computer cover.

CAUTION:

For your safety and to prevent damage to your computer, always do the following *before* removing the cover:

- 1. Shut down all programs as described in your operating system documentation.**
- 2. Turn off the computer and any attached devices, such as printers, monitors, and external drives.**

Note: Computer users in the United Kingdom who have a modem or fax machine attached to their computer must disconnect the telephone line from the computer *before* unplugging any power cords (also known as power cables). When the computer is reassembled, users must reconnect the telephone line *after* plugging in the power cords.

- 3. Unplug all power cords from electrical outlets.**
- 4. Disconnect all communication cables from external receptacles.**
- 5. Disconnect all cables and power cords from the back of the computer.**

Note: Do not reconnect any cables or power cords until you reassemble the computer and put the cover back on.

Handling Static-Sensitive Devices

Static electricity, although harmless to you, can seriously damage computer components and options.

Important

When you add an option, do *not* open the static-protective package containing the option until you are instructed to do so.

When you handle options and other computer components, take these precautions to avoid static electricity damage:

- Limit your movement. Movement can cause static electricity to build up around you.
- Always handle components carefully. Handle adapters and memory-modules by the edges. Never touch any exposed circuitry.
- Prevent others from touching components.
- When you install a new option, touch the static-protective package containing the option to a metal expansion-slot cover or other unpainted metal surface on the computer for at least two seconds. This reduces static electricity in the package and your body.
- When possible, remove the option and install it directly in the computer without setting the option down. When this is not possible, place the static-protective package that the option came in on a smooth, level surface and place the option on it.
- Do not place the option on the computer cover or other metal surface.

Available Options

The following are some available options:

- System memory, called dual in-line memory modules (DIMMs)
- Expansion adapters
 - Industry standard architecture (ISA) adapters
 - Peripheral component interconnect (PCI) adapters
- Internal drives
 - CD-ROM
 - Hard disk
 - Diskette drives, Zip drives, and other removable media drives.

To install or remove some options in your computer, you will need a flat-blade screwdriver. Additional tools might be needed for certain options. See the instructions that come with the option.

Removing the Cover

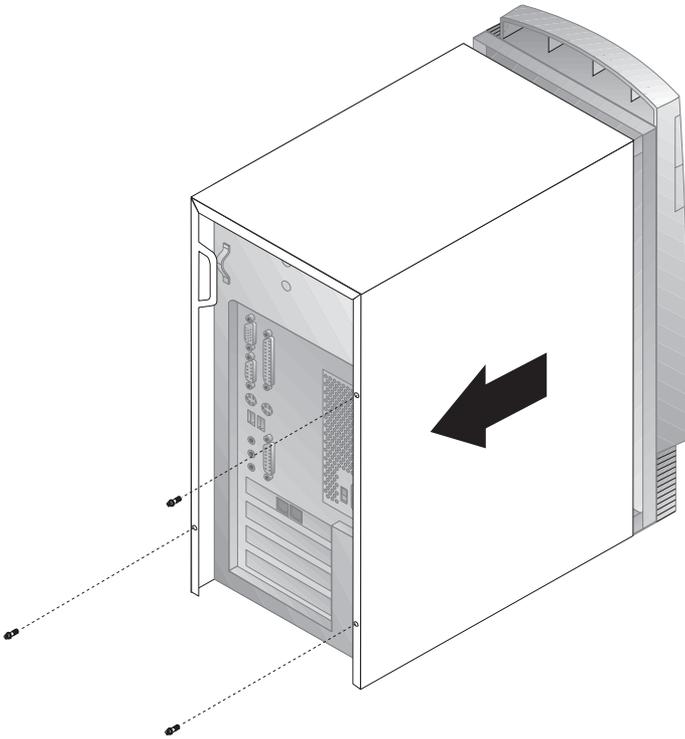
Important:

Read “Safety Information” on page vii and “Handling Static-Sensitive Devices” on page 52 before removing the cover.

To remove the cover:

1. Shut down your operating system, remove any media (diskettes, CDs, or tapes) from the drives, and turn off all attached devices and the computer.
2. Unplug all power cords from electrical outlets. If you have a modem or fax machine attached to your computer, disconnect the telephone line from the wall outlet and the computer.
3. Disconnect all cables attached to the computer. This includes power cords, input/output (I/O) cables, and any other cables connected to the computer.
4. Remove the three thumbscrews located on the rear of the computer that hold the cover onto the chassis. Use a coin or screw driver to loosen the thumbscrews if necessary.

5. Slide the cover straight toward the rear approximately one inch until it stops and lift the cover from the chassis.



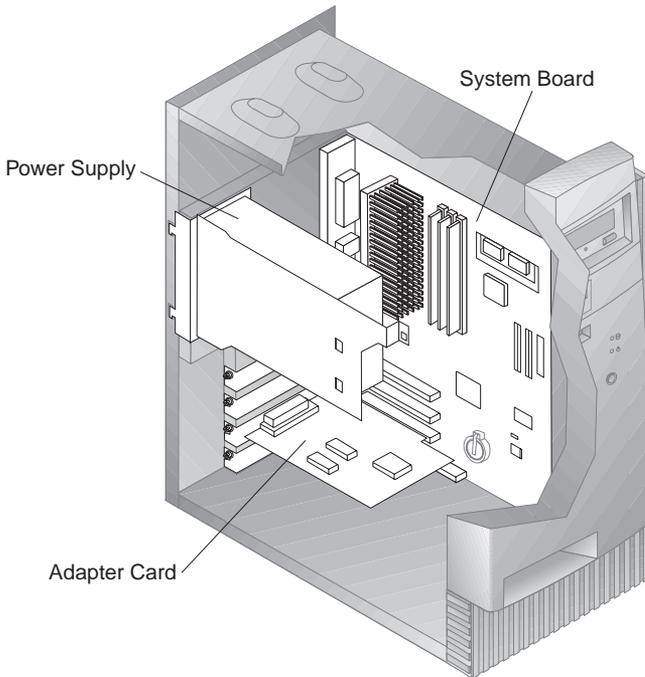
Attention

Proper cooling is required for the reliable performance of internal components. Do not operate your computer with the cover removed.

Locating Components

To install options in your computer, you will need to remove the cover. See “Removing the Cover” on page 54 . You also will need to locate components inside your computer.

The following illustration will help you locate the various components in your computer.



Note: If you prefer, you can place the computer on its side to install or remove options.

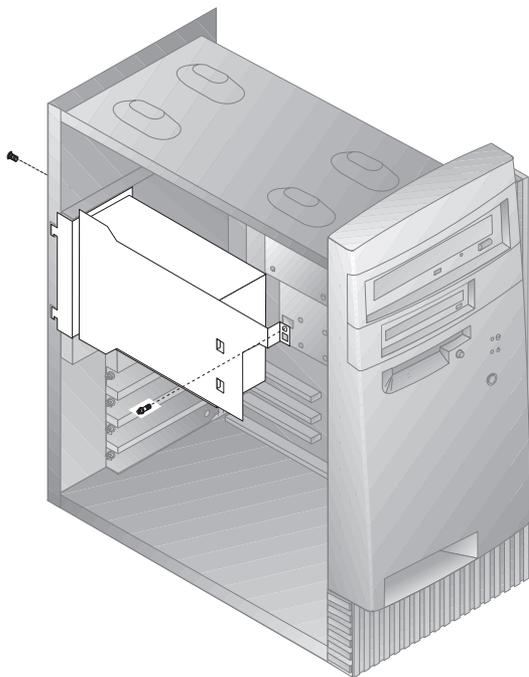
Moving the Power Supply

To perform some operations inside the computer, you might need to move the power supply to access parts of the system board that are difficult to see or hard to reach. Use the following procedure to provide easier access to the system board: Be sure to see “Safety Information” on page vii.

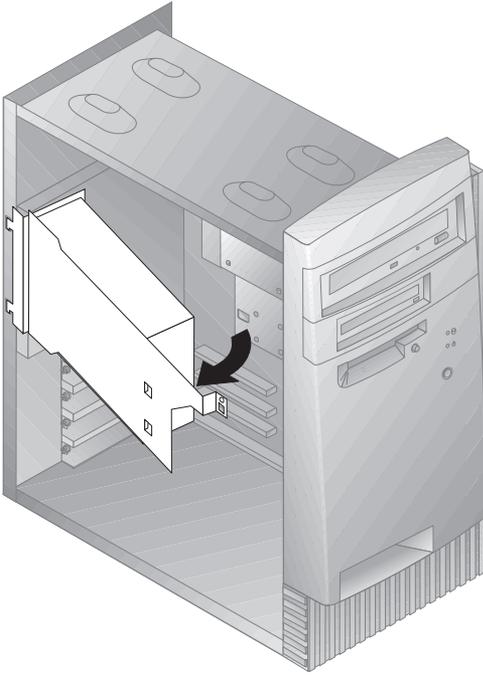
DANGER

Do not detach the power supply bracket from the power supply or remove any of the power supply screws.

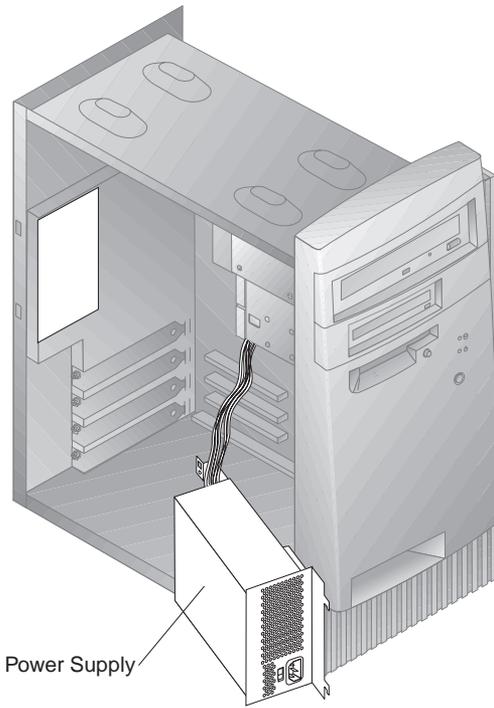
1. Remove the two screws securing the power supply to the chassis and the drive bays.
2. Slide the power supply unit up toward the top of the chassis.



3. Rotate the power supply toward you slightly.



4. Pull the power supply forward and carefully rotate it toward the front of the chassis. Lay it to the side.



5. To replace the power supply, reverse these steps.

Working with Options on the System Board

This section provides instructions for installing, removing, and replacing system memory.

Accessing the System Board

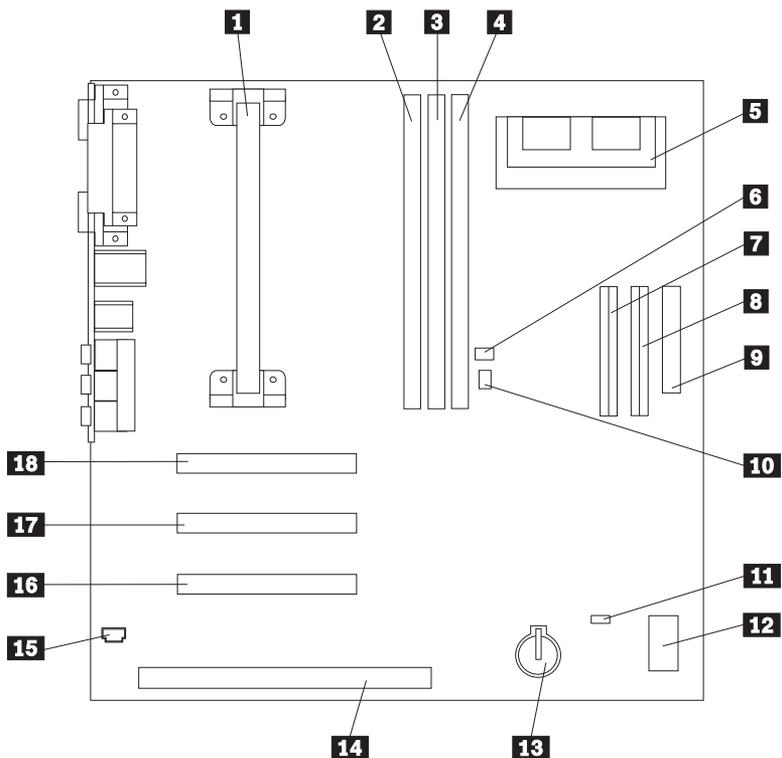
To access the system board, you must remove the computer cover. For information on removing the computer cover, see “Removing the Cover” on page 54. You might need to remove adapters in order to access some components of the system board. For information about expansion adapters, see “Working with Adapters” on page 66. When disconnecting cables, be sure to note where they attach, so you can correctly reattach them later.

Note: For easier access to the system board, it helps to place the computer on its side on a table.

Identifying Parts on the System Board

The system board, also called the *planar* or *motherboard*, is the main circuit board in your computer. It provides basic computer functions and supports a variety of devices that are IBM-installed or that you can install later. Refer to the following illustration for the location of parts on the system board.

Note: An illustration of the system board and additional information is provided on a label located on the inside of the computer chassis.

Working with System Memory

You can add memory to your computer to increase system performance. Your computer has either two or three connectors (depending on the model) for installing memory modules that provide up to a maximum of 256 MB or 384 MB (depending on the model).

Your computer uses dual inline memory modules (DIMMs). The IBM-installed DIMMs that come with your computer are unbuffered, synchronous dynamic random access memory (SDRAM).

When installing or replacing DIMMs, the following rules apply:

- Fill each system memory connector sequentially, starting at *DIMM 0*.
- Use only 3.3 V, 100 MHz, unbuffered, SDRAM DIMMs
- Use only 16, 32, 64, or 128 MB DIMMs in any combination of supported SDRAM DIMMs.

Note: To locate the memory connectors on the system board, see “Identifying Parts on the System Board” on page 60.

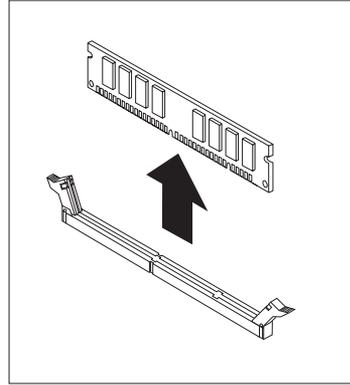
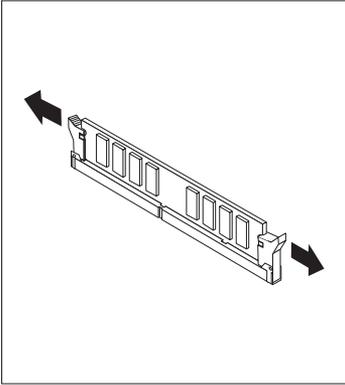
Installing and Removing a DIMM

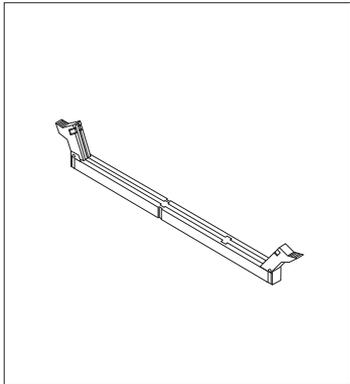
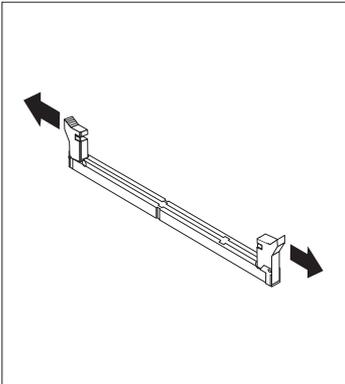

- Read the instructions that come with the new system memory.
- Turn off the computer and all other connected devices.
- Disconnect all cables attached to the computer and remove the computer cover (see “Removing the Cover” on page 54).
- Read “Accessing the System Board” on page 60 to learn the location of the parts on the system board.

To Install a DIMM:

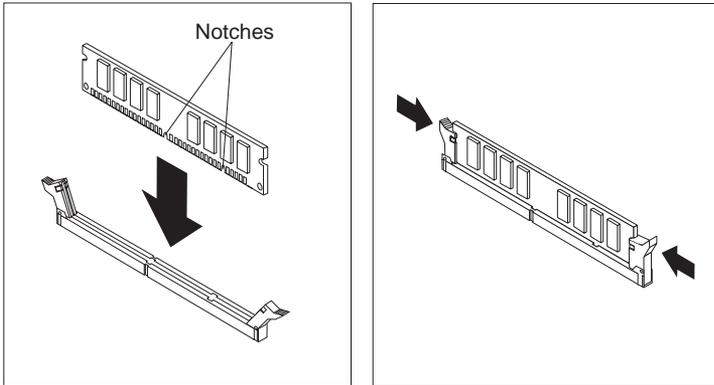
1. You may need to remove the power supply to gain access to the DIMM sockets. See “Moving the Power Supply” on page 57.
2. If you are replacing a DIMM that is already installed, press the retaining clips down and lift the DIMM out of the socket.



3. If the retaining clips are not already open, open them.



4. Install the DIMM straight down into the connector until the retaining clips close.



5. Reinstall the power supply if you removed it.

Working with Video Memory

This section provides information and instructions for installing and removing video memory from the video memory connector on the system board of some models.

For some models, you can add video memory to your computer to increase the video performance, resolution, and graphics capabilities. These models have a connector for installing a memory module that provides up to a maximum of 4 MB of video memory. Models without the connector already have 4 MB of video memory.

Installing a Video Memory Module

Before you begin:

- Read “Safety Information” on page vii and “Handling Static-Sensitive Devices” on page 52.
- Read the instructions that come with the new video memory.
- Turn off the computer and all other connected devices.
- Disconnect all cables attached to the computer and remove the computer cover (see “Removing the Cover” on page 54).
- Read “Accessing the System Board” on page 60 to learn the location of parts on the system board.

To install a video memory module:

1. Note the position of the power supply so that it can be reinstalled later. Move the power supply aside to gain access to the video memory socket. See “Moving the Power Supply” on page 57.
2. Install the video memory module into the connector at a 45 degree angle and then push it down until it snaps into place.
3. Reinstall the power supply. See “Moving the Power Supply” on page 57.

Working with Adapters

This section provides information and instructions for installing and removing adapters.

When installing or removing adapters, you must resolve any resource conflicts that are created as a result. For example, if you install an ISA legacy adapter, you might need to manually configure the adapter by setting a variety of switches on the adapter and by using the Configuration/Setup Utility Program program. For more information on using the Configuration/Setup Utility Program to configure adapters, see “Legacy Adapters” on page 68.

Adapter Types

Many adapters now use *Plug and Play* technology that enables the computer to automatically configure the adapter, provided that the required resources are available. Refer to the instructions that come with your adapter to determine if it is Plug and Play. For more information, see “Adapter Configuration” on page 67.

Adapter Slots

Your computer system board has expansion slots used to connect adapters to the industry standard architecture (ISA) and peripheral component interconnect (PCI) buses. Slots 1 through 3 are designed for PCI adapters. Slot 4 is an ISA slot. You can install an adapter up to 228 mm (9 inches) long in your computer.

Installing Adapters

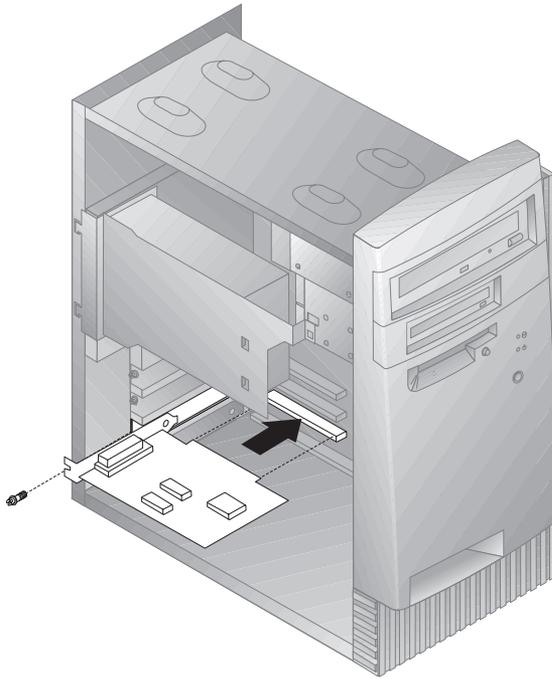
Before you begin:

- Read “Safety Information” on page vii and “Handling Static-Sensitive Devices” on page 52.
- Read the instructions that come with the new adapter.
- Turn off the computer and all other connected devices.
- Disconnect all cables attached to the computer and remove the computer cover (see “Removing the Cover” on page 54).

To install an adapter in a PCI or ISA expansion slot:

1. Review the instructions that come with the adapter to determine if it must be installed in an ISA or PCI expansion slot.

2. Move the power supply aside if necessary. See “Moving the Power Supply” on page 57.
3. Remove the screw and slot cover for the appropriate expansion slot.



4. Remove the adapter from its static-protective package.
5. Install the adapter into the appropriate slot on the system board.
6. Install the screw that secures the adapter.

Note: If you are installing a wake on LAN supported network adapter, attach the wake on LAN cable that came with the adapter to the wake on LAN connector on the system board. For the location of this connector, see the diagram of the system board on the inside of your computer.

7. If you moved the power supply aside, replace it. See “Moving the Power Supply” on page 57.
8. Replace the cover and continue with adapter configuration.

Adapter Configuration

Along with the documentation that comes with your adapter, use the following information to help with adapter configuration.

Plug and Play Adapters

Plug and Play is a configuration method that makes expanding your computer easier. Support for Plug and Play is built into the system board of your computer.

A Plug and Play adapter has no switches or jumpers that must be set. A Plug and Play adapter comes with configuration specifications set in memory. These specifications provide installation information to the computer during startup. When you install or remove Plug and Play adapters, this information is interpreted by the *basic input/output system (BIOS)*, which supports Plug and Play technology. If the required resources are available, the BIOS software automatically configures the adapter using resources *not* already used by other devices.

Adapters designed for PCI slots are Plug and Play devices. Most ISA adapters are not Plug and Play and are referred to as *legacy* adapters. See “Legacy Adapters.”

Note: See Chapter 8, “Troubleshooting” on page 83 for information on error messages resulting from resource conflicts.

Legacy Adapters

Adapters that are not Plug and Play are known as *legacy adapters*. If you install a legacy adapter, you must manually configure it by setting switches or jumpers on the adapter and by reserving its resources using the Configuration/Setup Utility Program.

In the Configuration/Setup Utility Program, the ISA Legacy Resources screen shows the computer resources that are typically required by adapters:

- Memory resources
- I/O port resources
- DMA resources
- Interrupt resources

See “ISA Legacy Resources” on page 37 for instructions to use the Configuration/Setup Utility Program to configure legacy adapters to work in your computer.

Working with Internal Drives

This section provides information and instructions for installing and removing internal drives.

When you install an internal drive, it is important to note what type and size of drive you can install in each bay. Also, it is important to correctly connect the internal drive cables to the installed drive.

Internal Drives

Internal drives are devices that your computer uses to read and store data. You can add drives to your computer to increase storage capacity and to enable your computer to read other types of media. Some of the different drives available for your computer are:

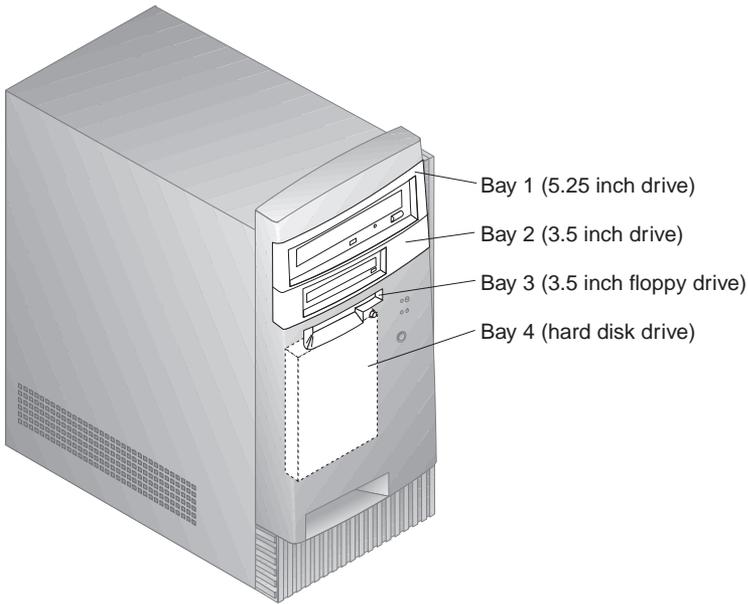
- Diskette drives
- Hard disk drives
- Tape drives
- CD-ROM drives
- Zip drives and other removable media drives

Internal drives are installed in *bays*. Within this book, the bays are referred to as bay 1, bay 2, and so on.

Your computer comes with the following IBM-installed drives:

- A CD-ROM drive in bay 1 (some models).
- A Zip drive in bay 2 (some models).
- A 3.5-inch diskette drive in bay 3.
- A 3.5-inch hard disk drive in bay 4.

Models that do not have drives installed in bays 1 and 2 have a static shield and bay panel installed.



Drive Specifications

The following table describes some of the drives you can install in each bay and their height requirements.

Bay 1 - Max Height: 41.3mm (1.6 in.)

CD-ROM drive
5.25-inch tape backup drive
5.25-inch hard disk drive

Bay 2 - Max Height: 41.3mm (1.6 in.)

3.5-inch tape backup drive
3.5-inch hard disk drive
Zip drive

Bay 3 - Max Height: 25.4mm (1.0 in.)

3.5-inch diskette drive

Bay 4 - Max Height: 25.4mm (1.0 in.)

3.5-inch hard disk drive

Notes:

1. Drives that are greater than 41.3 mm (1.6 in.) high cannot be installed.
2. Install removable media (diskettes, tapes, or CDs) drives in the accessible bays: bays 1 or 2.

Power and Signal Cables for Internal Drives

Your computer uses cables to connect integrated drive electronics (IDE) drives to the power supply and system board. The following cables are provided:

- Four-wire *power cables* connect most drives to the power supply. At the end of these cables are plastic connectors that attach to different drives; these connectors vary in size. Also, certain power cables attach to the system board.
- Flat *signal cables*, also called *ribbon cables*, for connecting IDE and diskette drives to the system board. There are two sizes of ribbon signal cables that come with your computer:
 - The wider signal cable has two or three connectors.
 - If the cable has three connectors, one of these connectors is attached to the drive, one is a spare, and the third attaches to the secondary IDE connector on the system board.
 - If the cable has two connectors, one of these connectors is attached to the hard disk drive, and the other attaches to the primary IDE connector on the system board.
 - Note:** If you want to add another device, and the signal cable has only two connectors, you will need a signal cable with three connectors.
 - The narrower signal cable has two connectors for attaching the diskette drive to the diskette-drive connector on the system board.

Note: To locate connectors on the system board, see “Identifying Parts on the System Board” on page 60.

The following are some important points to remember when connecting power and signal cables to internal drives:

- The drives that are preinstalled in your computer come with power and signal cables attached. If you replace any drives, it is important to remember which cable is attached to which drive.
- When you install a drive, ensure that the drive connector at the *end* of the signal cable is always connected to a drive; also, ensure that the drive connector at the other end is connected to the system board. This reduces electronic noise from the computer.
- If two IDE devices are used on a single cable, one must be designated as the primary or master device and the other as the secondary or subordinate device; otherwise, some of the IDE devices might not be recognized by the system. The primary or secondary designation is determined by switch or jumper settings on each IDE device.

- If two IDE devices are on a single cable, and only one is a hard disk drive, the hard disk drive must be set as the master device.
- If you have only one IDE device on a cable, it must be set as master.

For help in selecting drives, cables, and other options for your computer, do one of the following:

- Outside the United States and Canada, contact your IBM reseller or IBM marketing representative.

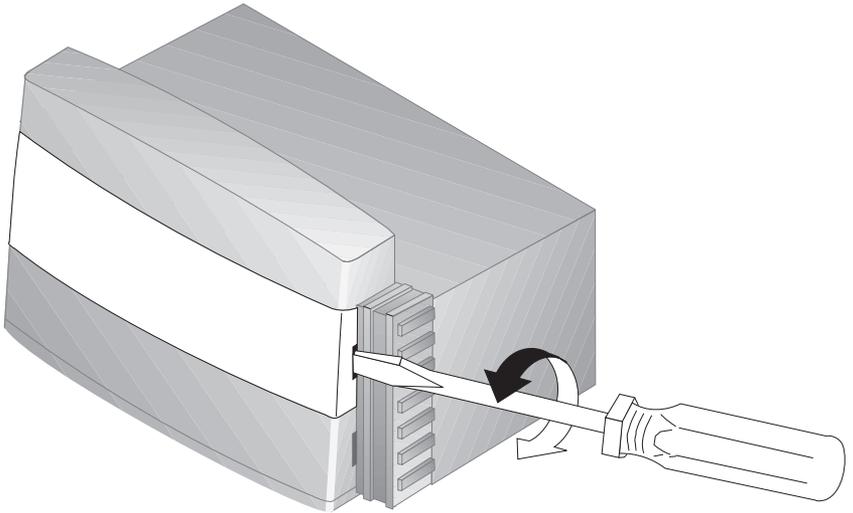
Installing Internal Drives

Before you begin:

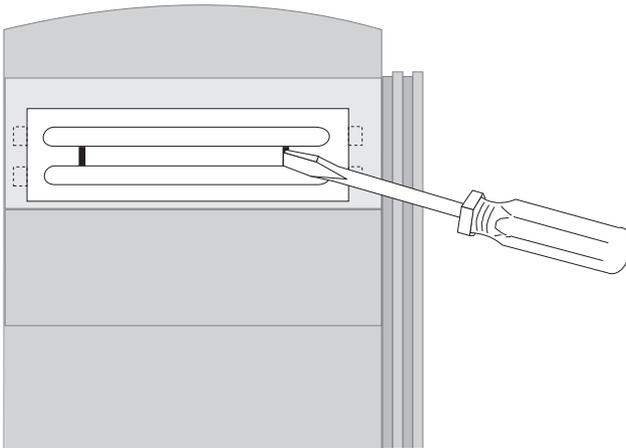
- Read “Safety Information” on page vii and “Handling Static-Sensitive Devices” on page 52.
- Turn off the computer and all other connected devices.
- Disconnect all external cables and power cords, and then remove the computer cover (see “Removing the Cover” on page 54).

To install an internal drive:

1. Place a medium flat-head screwdriver into the notch on the right side of the bay panel covering the bay where you want to install the drive and twist the screwdriver to pop the bay panel out of the bay.



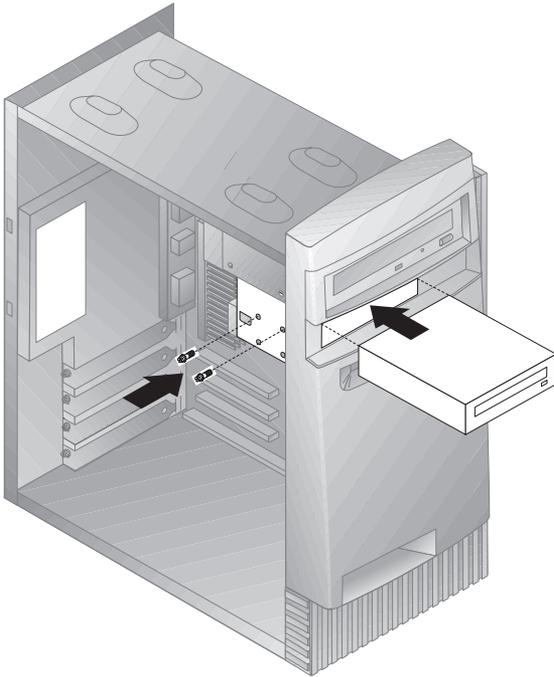
2. Insert a flat-head screwdriver into one of the slots on the static shield and pry the static shield loose from the drive bay.



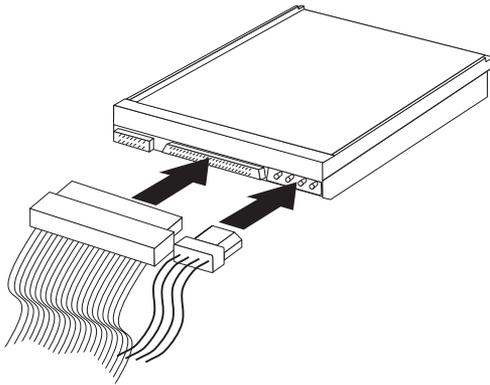
3. Inside the computer are one or two picture frame panels for use when you have installed a drive into one of the bays. The picture frame panel for the 3.5-inch drive bay is attached to the outside of the chassis.

The picture frame panel for the 5.25-inch drive bay is attached to the inside of the chassis. Remove the picture frame panel that was packed on the inside of the chassis to make room for installing the drive.

4. Install the drive into the bay. Align the screw holes and insert the two screws.



5. If the drive you installed has nonremovable media (such as a hard disk drive), replace the bay panel.
If the drive you installed is a removable media drive (such as a Zip drive), place the picture frame that came with your computer over the drive bay.
6. Connect the power and signal cables to the drive.

Installing a Security U-bolt

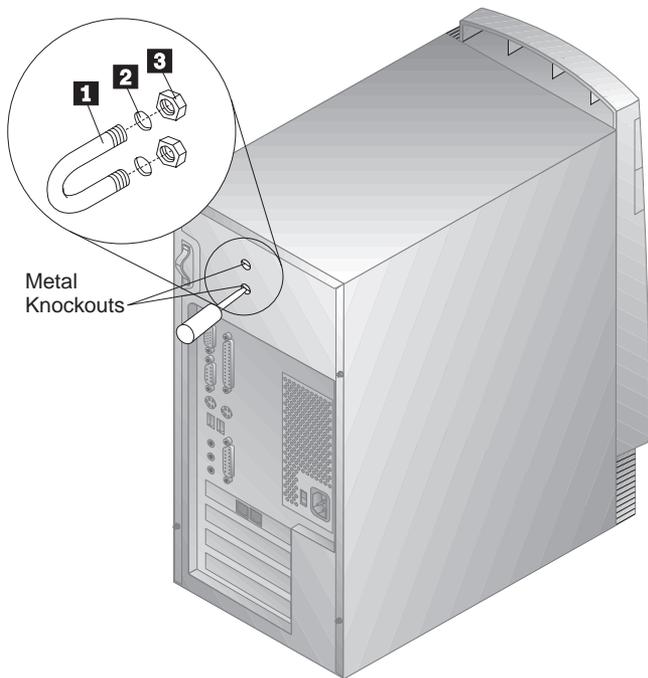
To help prevent hardware theft you can use the cover lock and add a security U-bolt and cable to your computer. After you add the security cable, make sure that it does not interfere with other cables that are connected to the computer.

Before you begin:

- Obtain the following:
 - A 19-mm (3/4 in.) U-bolt and threaded nuts that fit the U-bolt
 - A security cable
 - A lock, such as a combination lock or padlock
 - An appropriately sized or adjustable wrench
 - A small, flat-blade screwdriver
- Read “Safety Information” on page vii and “Handling Static-Sensitive Devices” on page 52.
- Turn off the computer and all other connected devices.
- Disconnect all external cables and power cords and remove the computer cover (see “Removing the Cover” on page 54).

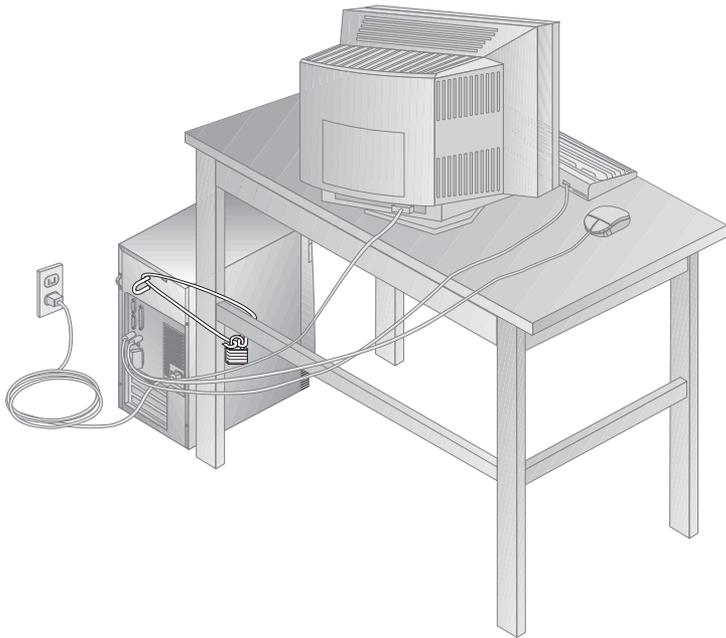
To install a U-bolt:

1. Use a tool, such as a screwdriver, to remove the two metal knockouts.



2. Insert the U-bolt **1** through the rear panel **2**; then attach and tighten the nuts **3** with an appropriately sized or adjustable wrench.
3. Replace the computer cover. For more information, see “Replacing the Cover and Connecting the Cables” on page 77.
4. Thread the cable through the U-bolt and around an object that is not a part of or permanently secured to the building structure or foundation, and from which it cannot be removed; then fasten the cable ends together with a lock.

The following illustration shows an example of how this might work.



Completing the Installation

After working with options, you need to install any removed parts, replace the cover, and reconnect any cables, including power cords and telephone lines. Also, depending on the option installed, you might need to update information in the Configuration/Setup Utility Program software.

The following list is a quick reference to these procedures:

Replacing the Cover and Connecting the Cables

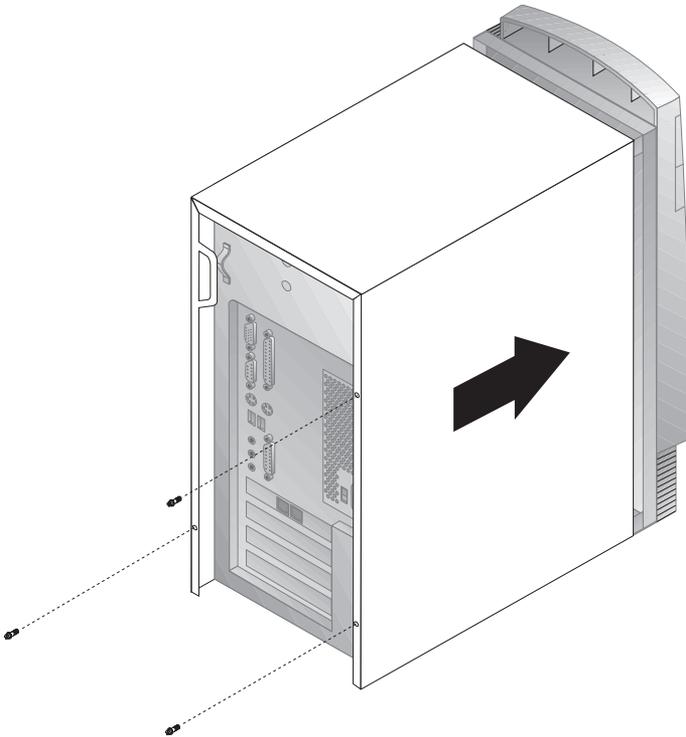
To replace the cover and connect cables to your computer:

1. Ensure that all components have been reassembled correctly and that no tools or loose screws are left inside your computer.
2. Clear any cables that might impede the replacement of the cover.
3. Position the cover over the chassis so that the front edge is approximately one inch away from the front bezel.

There are several rail guides at the bottom of the cover. To install the cover properly, these rail guides must engage the metal rails at the bottom of the chassis.

4. Lower the cover down over the chassis so that the rail guides engage the rails.
5. Slide the cover forward.

You might need to lift the front of the cover slightly to align it properly.



6. Insert the three thumbscrews into the holes in the cover and the chassis and tighten.
7. Reconnect the external cables and cords to the computer. See “Connecting Computer Cables” on page 10.

Important Information:

When the power cord is first plugged in, the computer might appear to power on for a few seconds, then power off. This is a normal sequence to enable the computer to self-initialize.

Important:

If you are in the U.K., plug in the power cords first and then connect the telephone line to the wall outlet and the computer. If you have a modem or fax machine attached to the computer, and you are not in the U.K., reconnect the telephone line to the wall outlet and the computer and then plug the power cords into properly grounded electrical outlets.

Updating the Computer Configuration

Important:

The configuration information in this section applies to installing options. For more information on using the Configuration/Setup Utility Program, see the Chapter 5, “Using the Configuration/Setup Utility Program” on page 27.

You might need to install device drivers after updating the configuration settings. For more information, see the instructions that come with the option to determine if device drivers are required and how to install them. Device drivers are included on the *Software Selections* CD that comes with your computer.

After adding, removing, or replacing options, the configuration settings must be updated. In most cases, this configuration is performed automatically using system programs. If the settings are not updated automatically, you can use the Configuration/Setup Utility Program program to reconfigure the appropriate settings. In either case, you must save the settings before exiting the Configuration/Setup Utility Program program.

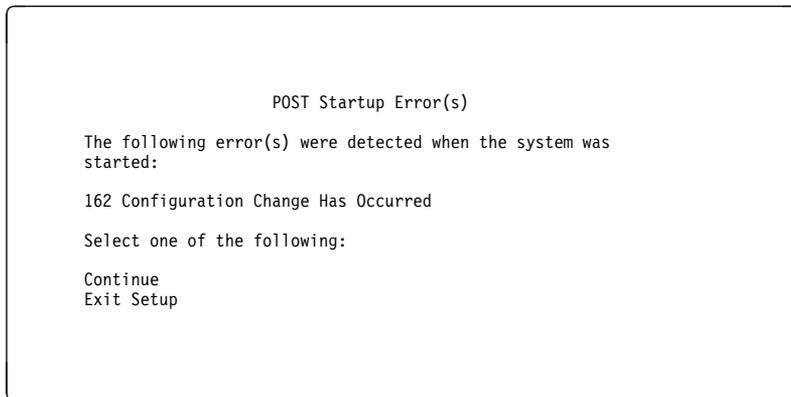
For example, when you start your computer after adding most internal hard disk drives, the settings might be updated. If the settings are not updated, use the Configuration/Setup Utility Program to make and save those changes. However, if a resource conflict arises after an ISA legacy adapter is installed or removed, you must manually update the computer configuration and save the information. For instructions, see “ISA Legacy Resources” on page 37.

Note: For more information on error messages from resource conflicts, see Chapter 8, “Troubleshooting” on page 83.

Starting the Configuration/Setup Utility Program

When you restart the computer for the first time after working with most options, a message may appear indicating that a configuration change has occurred. If such a message appears, you are then prompted to enter the Configuration/Setup Utility Program program to manually update the configuration settings or to confirm and save the settings that were automatically updated by the system programs.

After you change an option and restart the computer, the following screen might appear.



Note: Depending on the configuration changes that occurred, the error message you see might be different from the one shown here. If the preceding screen appears, select **Continue** until you reach the Configuration/Setup Utility Program menu (see Chapter 5, “Using the Configuration/Setup Utility Program” on page 27).

If the preceding screen does not appear, then see Chapter 5, “Using the Configuration/Setup Utility Program” on page 27.

Configuring an ISA Legacy Adapter

To configure an installed ISA legacy adapter, you might need to alter switch or jumper settings on the adapter. Also, you must use the Configuration/Setup Utility Program program to identify the ISA legacy resource requirements, such as memory locations, I/O assignments, and DMA and interrupt assignments.

Note: For more information about required resources and switch settings, refer to the documentation that comes with the adapter.

If you remove an ISA legacy adapter, you must set the system resources that are no longer being used to **Available**. To do this, follow the procedures in Chapter 5, “Using the Configuration/Setup Utility Program” on page 27 and select **Available** at step 4.

Note: For more information on adapters and resolving conflicts, see “Adapter Configuration” on page 67 and “Interrupt and DMA Resources” on page 38.

For more detailed instructions on configuring ISA legacy adapters, see “ISA Legacy Resources” on page 37.

Configuring Startup Devices

When your computer is turned on, it looks for an operating system. The order in which it searches devices for the operating system is the startup sequence. After adding new devices to the computer, you might want to change the startup sequence. You can use the Configuration/Setup Utility Program program to configure startup devices. See “Setting the Startup Sequence” on page 36.

Chapter 8. Troubleshooting

This chapter describes diagnostic tools that are available to you. You can use these tools to identify and correct problems that might come up as you use your computer. This chapter also contains information about option diskettes and how to recover from a BIOS update failure.

Note: If your computer does not start when you press the power switch, do the following:

- Make sure all cables are securely connected to the correct locations.
- Make sure the computer cover is installed properly (pushed all the way on).

If this does not correct the problem, have the computer serviced.

Using Diagnostic Tools

Computer problems can be caused by hardware, software, or user error (for example, pressing the wrong key). You can use the diagnostic aids discussed in this chapter to help you solve such problems yourself or gather helpful information you can pass on to a service technician.

You can check the hardware by following the procedures in this chapter. You can also use the diagnostic programs provided with your computer (see “IBM Enhanced Diagnostics” on page 116 for a description of these programs).

If the hardware checks out, and you have not made a user error, you might have a software problem. If you suspect that you have a software problem and your computer came with IBM-preinstalled software, see the *About Your Software* publication and the operating system documentation supplied with your computer. If you have installed software applications yourself, see the documentation supplied with the software.

The following tools are available to diagnose hardware-related problems:

- Error messages
- Power-on self-test (POST)
- Troubleshooting charts
- Diagnostic programs

Power-On Self-Test (POST)

Each time you turn on your computer, it performs a series of tests that check the basic operation of the base computer. This series of tests is called the *power-on self-test (POST)*.

POST does the following:

- Checks basic system-board operations
- Checks the memory operation
- Compares the current system configuration with that established by the Configuration/Setup Utility Program
- Starts the video operation
- Verifies that the diskette drives are working
- Verifies that the hard disk drive and the CD-ROM drive are working

If **Power-On Self-Test** is set to [*Enhanced*], numbers showing the amount of memory being tested appear in the top-left corner of the screen until the total amount of memory in the system is reached. Options for running a quick POST or accessing the Configuration/Setup Utility Program appear in the lower-left corner of the screen. Quick mode is the default mode of operation.

Note: The amount of available memory shown might be somewhat less than expected because of basic input/output system (BIOS) shadowing in random access memory (RAM).

If POST finishes without detecting any problems, the first screen of your operating system or application program appears if you have not set a power-on password. If you have set a power-on password, a password prompt appears. You must enter your password before the first screen of your operating system or application program will appear. (For more information on using passwords, see “Power-On Password” on page 30.)

If **Power On Status** is *Enabled* and POST detects a problem, you will hear multiple beeps or no beep. In most cases, an error code appears in the top left corner of the screen, and in some cases a description of the error is displayed beside the code. (Note that the screen will sometimes display multiple error codes and descriptions.) For more information about what caused an error message to appear and what action to take, see “Solving POST Error Message Problems” on page 86 and “POST Message Charts” on page 88.

If you hear no beep at all during POST, see “Troubleshooting Charts” on page 105. You might need to have your computer serviced.

Error Messages

Error messages that appear on the screen might be text, numeric, or both. There are several types of error messages.

POST error messages

These messages appear when POST finds problems with the hardware during startup or when a change in the hardware configuration is found. POST error messages are 3-, 4-, 5-, 8-, or 12-character alphanumeric messages and include brief explanations (except I999XXXX errors).

For more information about what caused an error message to appear and what action to take, see “Solving POST Error Message Problems” on page 86 and “POST Message Charts” on page 88.

Software-generated error messages

These messages appear if a problem or conflict is detected by the application program, the operating system, or both. Error messages for operating-system and other software problems are usually text messages, but they also can be numeric messages. For information about these software error messages, see the information supplied with the operating system and application program.

Diagnostic error codes and messages

These codes and messages appear if a hardware problem is detected by one of the IBM Enhanced Diagnostics test programs. Along with error codes, the messages present text information that can be used to identify a failing part. See “IBM Enhanced Diagnostics” on page 116.

Solving POST Error Message Problems

If you receive an error message during the POST, you might be able to solve the problem by completing the steps outlined in this section.

Note

If you have just added, removed, or changed the location of a device and you receive an error message, make sure you save the configuration before exiting the Configuration/Setup Utility Program. If this does not eliminate the error message, then proceed with the following instructions.

1. Write down all error-code numbers and descriptions that appear on the screen as you start your computer. Note that a single problem can cause several error messages to appear. When you correct the cause of the first error message, the other error messages probably will not appear on the screen the next time you turn on your computer.
2. If you have set a power-on password, a password prompt appears. If you have set both power-on and administrator passwords, you can type either of the passwords at the password prompt. However, if you think you might need to change any settings in the Configuration/Setup Utility Program, you must type your administrator password at the password prompt.
3. In the case of most errors, the Configuration/Setup Utility Program starts automatically so that you can attempt to identify and correct the problem. When the Configuration/Setup Utility Program starts, a screen titled POST Startup Errors appears. (Note that the POST Startup Errors screen does not appear immediately. You must wait approximately one minute.) If the POST Startup Errors screen does not appear, proceed to step 6.
4. At the POST Startup Errors screen, select **Continue** if you want to access the Configuration/Setup Utility Program menu. Select **Exit Setup** if you want to exit the Configuration/Setup Utility Program. (See the **Important** text box in step 5 for information on exiting the Configuration/Setup Utility Program without making any changes to current settings.) To select an item, press Up Arrow (↑) or Down Arrow (↓) to highlight the item, and then press **Enter**.
5. If you selected **Continue** in step 4, the Configuration/Setup Utility Program menu appears on the screen. You will see a pointer next to any menu items that are malfunctioning or that have been changed since the last time you turned on your computer. If you did not knowingly make a change to a flagged menu item, there is probably a malfunction in that item. If you made a change, continue here. If you

did not make a change, go to the **Important** text box which follows step 5d.

To use the Configuration/Setup Utility Program, do the following:

- a. Select the menu item that is flagged (or that you wish to view) by pressing Up Arrow (↑) or Down Arrow (↓), and then press **Enter**.
- b. A new menu specific to the item that you selected appears. Press Left Arrow (←) or Right Arrow (→) to toggle between choices for a menu item. (Note that each menu item has a Help screen. To view the Help screen, select the menu item, and then press **F1**.)
- c. When you finish viewing and changing settings, press **Esc** to return to the Configuration/Setup Utility Program menu.
- d. Before you exit from the program, select **Save Settings**. When you exit from the Configuration/Setup Utility Program menu (see step 5e), your operating system will start automatically (unless there is an unresolved problem with the startup device).

— **Important** —

If you did *not* change any settings in the Configuration/Setup Utility Program, note the following:

- You will get an error message if you exit from the Configuration/Setup Utility Program without selecting **Save Settings**. Your operating system will not start, but the computer will automatically restart. When the computer restarts, you will get a POST error message, and then the Configuration/Setup Utility Program will again start automatically.
- You will *not* get an error message if you select **Save Settings**, and then exit from the Configuration/Setup Utility Program. Your system saves all settings as they currently appear in the Configuration/Setup Utility Program and your operating system starts (unless there is an unresolved problem with the startup device).

- e. To exit the Configuration/Setup Utility Program, press **Esc** and follow the instructions on the screen.
6. For more information about what caused an error message to appear and what action to take, see the following chart.

POST Message Charts

The computer might display more than one error message. Often, the first error to occur causes subsequent errors. When using the POST message charts in this section, always begin by following the suggested action for the *first* error message that appears on your computer screen. Note that, in these charts, “X” can be any alphanumeric character.

Important

If you find it necessary to remove the computer cover, first read “Safety Information” on page vii and “Removing the Cover” on page 54 for important safety information and instructions.

POST Message	Description
101 102 106	A failure occurred during testing of the system board and microprocessor. Action: Have the computer serviced.
114	An adapter read-only memory (ROM) error occurred. Action: Remove all adapters that are not required for system startup and reinstall them one at a time, powering on after each is reinstalled. When this message displays, replace the adapter just installed. If the problem cannot be corrected, have the computer serviced.
121	A hardware error occurred. Action: Have the computer serviced.
151	A real-time clock error occurred. Action: Have the computer serviced.

IBM Enhanced Diagnostics

IBM Enhanced Diagnostics is provided on your hard disk drive and on the *Product Recovery CD*. It is a self-extracting file that runs independently of the operating system. You can run *IBM Enhanced Diagnostics* to diagnose hardware and some software problems. The user interface for running these diagnostic and utility programs is provided by WaterGate Software PC Doctor.

The IBM Enhanced Diagnostics will isolate your computer hardware from software that was preinstalled (or that you have installed) on your hard disk. The programs run independently of the operating system, and must be run either from CD or diskette.

You can use this program to test the hardware (and some software) components of your computer. This method of testing is generally used when other methods are not accessible or have not been successful in isolating a problem suspected to be hardware related.

To create a startable diagnostic diskette from the pre-installed program on your hard disk drive:

1. From the Windows 98 desktop, double-click on **IBM Welcome Center**.
2. In the IBM Welcome Center window, click on **Customize your system software**
3. Click on **Run the Software Selections program from the hard drive**. The program initializes.
4. Click on **Install Software**.
5. Check **IBM Enhanced Diagnostics** in the menu box.
6. Click on **Install** in the bottom right corner of the screen.
7. click on **Install** in the Software Selections Install Progress menu box. A DOS window appears.
8. Press **Enter** to continue and read the license information. Follow the instructions that appear at the bottom of the window.
9. When prompted, insert a blank, high-density diskette into the diskette drive and press **Enter**.
10. When the process is complete, remove the diskette and label it.
11. Click on **Return**.

To download the latest image of the IBM Enhanced Diagnostics from the Web site and create a startable Enhanced Diagnostics Diskette:

1. Go to the following Web site:

2. Download the .EXE file to a hard disk directory (not to a diskette).
3. Go to a DOS prompt and change the directory to where the file was downloaded.
4. Insert a blank high-capacity diskette in diskette drive A.
5. Type the following and press Enter:

Where filename is the name of the file you downloaded from the Web.

The downloaded file is self-extracting and will be copied to the diskette. When the copy completes you have a startable *IBM Enhanced Diagnostics* diskette.

To start the IBM Enhanced Diagnostics program using the diagnostic diskette, do the following:

1. Turn off your computer and any attached devices.
2. Insert the *IBM Enhanced Diagnostics* diskette into diskette drive A.
3. Turn on all attached devices; then turn on your computer.
4. Follow the instructions on the screen.

Other Diagnostic Programs on the *Software Selections* CD:

The *Software Selections* CD supplied with your computer also contains diagnostic programs designed specifically for certain operating environments (Windows 95, Windows 98, and Windows NT). Because these versions work with the operating system, they not only test the hardware, but also analyze certain software components of your computer. They are especially useful in isolating problems related to the operating system and device drivers.

To start the IBM Enhanced Diagnostics program using the *Product Recovery* CD, do the following:

1. Turn off your computer and any attached devices.
2. Turn on all attached devices; then turn on your computer.
3. When you see Press F1 For Configuration/Setup, press the **F1** key.
4. When the Configuration/Setup Utility Program menu appears, select **Start Options**.
5. Select **Startup Sequence** and press **Enter**.
6. Write down the device currently selected as the First Startup Device. Then write down the devices selected as Second Startup Device, Third Startup Device, and Fourth Startup Device. You must restore these settings when you finish running diagnostics.
7. Select the First Startup Device. To start from the CD, select **CD-ROM**.
8. Press **Esc** two times to return to the Configuration/Setup Utility Program menu.
9. Select **Save Settings** and follow the prompts.
10. Select **Exit Setup** and follow the prompts.
11. Place the *Product Recovery* CD in the CD-ROM drive.
12. Shut down and restart the computer. The *Product Recovery* CD will load.
13. Select Diagnostics on the option menu and press **Enter**.
14. When you finish running the diagnostic program, press **Esc**, remove the CD from the CD-ROM drive, and turn off the computer. You must restore the First Startup Device back to the original setting. Follow steps 2 through 9

To start the enhanced diagnostic program:

1. Shut down Windows 95 (or Windows NT) and turn off the computer.
2. Turn off any attached devices.
3. Insert the *IBM Enhanced Diagnostic* diskette into drive A.
4. Turn on all attached devices; then turn on your computer.
5. Follow the instructions that appear on the screen. For help, press F1.

CoSession Remote for UMA

CoSession availability varies by computer model and country. CoSession is a remote-control program that can be used by another individual, such as your in-house administrator, to help diagnose problems with your computer from a remote location. CoSession is part of the Universal Management Agent (UMA) Plus software provided on the *Software Selections* supplied with your computer. To use CoSession, this program must be installed in your computer, and your computer must have a modem or a LAN connection.

Important

Before attempting to use CoSession, contact IBM or your in-house administrator for specific instructions on setting up and using the program.

Recovering From a POST/BIOS Update Failure

If power to your computer is interrupted while POST/BIOS is being updated (flash update), your computer might not restart correctly. If this happens, perform the following procedure to recover:

1. Turn off the computer and any attached devices, such as printers, monitors, and external drives.
2. Unplug all power cords from electrical outlets and remove the cover. See "Removing the Cover" on page 54.

CAUTION:

Do not touch internal components of the computer while the power is on.

3. Locate the ROM Recovery switch (Switch 5 on the rocker switch) on the system board, removing any adapters that impede access to the rocker switch. See the system board label inside your computer for the location of the switch. See also "Working with Options on the System Board" on page 60.
4. Move the ROM Recovery switch to the **on** position.
5. Replace any adapters that were removed and replace the cover. See "Replacing the Cover and Connecting the Cables" on page 77.
6. Reconnect the power cords for the computer and monitor to electrical outlets.
7. Insert the POST/BIOS update (flash) diskette into drive A and turn on the computer and the monitor.

8. After the update session completes, turn off the computer and monitor.
9. Unplug the power cords from electrical outlets.
10. Remove the diskette from drive A.
11. Remove the cover. See “Removing the Cover” on page 54.
12. Remove any adapters that impede access to the switch.
13. Move the ROM Recovery switch to the **off** position.
14. Replace any adapters that were removed.
15. Install the cover and reconnect any cables that were disconnected.
16. Turn on the computer to restart the operating system.

Installing Files from Option Diskettes

An optional device or adapter might come with a diskette. Diskettes that are included in option packages usually contain files that the system needs for recognizing and activating the options. Until you install the necessary files, the new device or adapter might cause error messages.

If your optional device or adapter comes with a diskette, you might need to install some configuration (.CFG) files or diagnostic files (.EXE or .COM) from the diskette to your hard disk. See the documentation that comes with the option to determine if you need to install files.

Be sure to retain your proof of purchase to obtain warranty service.

If possible, be at your computer when you call.

The following items are not covered:

If you suspect a software problem, consult the documentation (including README files) for the operating system or application program.
