


Major components of the Netfinity 4500R server

The orange color on components and labels in your server identifies hot-swap or hotplug components. This means that you can install or remove the components while the system is running, provided that your system is configured to support this function. For information about installing or removing a hot-swap component, see "Chapter 2. Installing Options," on page 5.

The blue color on components and labels identifies touch points where a component can be gripped, a latch moved, and so on.

Chapter 2. Installing Options

This chapter provides the basic information needed to install hardware options in your server. This section is for all users, but is written with the experienced user in mind. If you need more detailed installation information, refer to the *User's Reference* on the *IBM Netfinity Documentation* CD.

Working inside a server with power on

Your server supports hot-swap drives, fans, and power supplies and is designed to operate safely while turned on with the cover removed. Follow these guidelines when you work inside a server that is turned on:

- Avoid loose-fitting clothing on your forearms. Button long-sleeved shirts before
 working inside the server; do not wear cuff links while you are working inside
 the server.
- Do not allow your necktie or scarf to hang inside the server.
- Remove jewelry, such as bracelets, rings, necklaces, and loose-fitting wrist watches.
- Remove items from your shirt pocket (such as pens or pencils) that could fall into the server as you lean over it.
- Take care to avoid dropping any metallic objects, such as paper clips, hair pins, or screws, into the server.

Installing adapters

This section describes how to install PCI adapters. Before you continue with the adapter-installation procedure, review the following:

- Your server supports 5.0 V and universal PCI adapters; it does not support 3.3 V adapters.
- The system scans PCI slots 1 through 5 to assign system resources; then, if you have not changed the boot precedence from the default, the system starts (boots) the PCI devices in the following order: PCI slots 1 and 2, system board SCSI devices, and then PCI slots 3 through 5.

Note: You can use the Configuration/Setup Utility program to change the boot precedence for your server. Select Start Options from the Configuration/Setup Utility main menu.


You can install a 32-bit adapter in any of the PCI slots, but you might want to
install it in a 32-bit slot and use the 64-bit slots for 64-bit adapters.


Installing adapters

The following illustration shows the installation of an adapter.




To install an adapter:

Attention: When you handle Electrostatic Discharge-Sensitive devices (ESD), take precautions to avoid damage from static electricity. For details on handling these devices, refer to the following Web site and use a search term of ESD: http://www.ibm.com/

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server. Disconnect the signal cables; then disconnect the power cords.
- 3. Remove the cover.
- 4. Select a slot and remove the expansion-slot cover.
- 5. Install the adapter in the slot; then, install the retaining screw.
- 6. Install the cover.
- 7. Reconnect the cables and power cords; then, turn on the server.

Installing adapters

The following illustration shows the rerouting of the SCSI cable if you install an IBM $\,$ ServeRAID adapter.



- 1. Disconnect the cable from SCSI connector B on the system board.
- 2. Connect the cable to the connector on the ServeRAID adapter.


Installing a drive in a hot-swap bay

Your server supports three 1-inch (26 mm) slim-high hot-swap hard disk drives in the hot-swap bays.

Note: Refer to the *User's Reference* on the *IBM Netfinity Documentation* CD for information about installing devices in the non-hot-swap bays.

To install a drive in a hot-swap-bay:

- 1. Remove the filler panel.
- 2. Place the drive handle in the open position and slide the drive into the bay.
- 3. Close the drive handle.


Installing a microprocessor

Your server comes with one microprocessor installed in the microprocessor connector that is farther away from the memory slots (connector U3). This is the startup (boot) microprocessor. A microprocessor installed in connector U17 is microprocessor 2. If more than one microprocessor is installed, the microprocessor installed in connector U17 is the startup processor and the microprocessor installed in U3 is the application processor.


Attention: To avoid damage and ensure proper server operation when you install a new or an additional microprocessor, use microprocessors that have the same cache size and type, and the same clock speed. Microprocessor internal and external clock frequencies must be identical. See the ServerProven™ list on the World Wide Web at http://www.ibm.com/pc/compat for a list of microprocessors for use with your server.

To install an additional microprocessor:

Attention: When you handle Electrostatic Discharge-Sensitive devices (ESD), take precautions to avoid damage from static electricity. For details on handling these devices, refer to the following Web site and use a search term of ESD: http://www.ibm.com/

Note: Each microprocessor connector must contain either a terminator card or a microprocessor.

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server. Disconnect the signal cables; then disconnect the power cords.
- 3. Remove the cover.
- 4. Remove fan 3.
- 5. Remove the air baffle.
- 6. Remove the terminator card from the connector.
- 7. Install the microprocessor.
- 8. Install the voltage regulator module (VRM).
- 9. Remove the break-away section from the air baffle.
- 10. Install the air baffle.
- 11. Install fan 3.
- 12. Install the cover.
- 13. Reconnect the cables and power cords; then, turn on the server.

Installing a hot-swap power supply

If you install or remove a power supply, observe the following precaution.

Statement 8



CAUTION:

Never remove the cover on a power supply or any part that has the following label attached.





Hazardous voltage, current, and energy levels are present inside any component that has this label attached. There are no serviceable parts inside these components. If you suspect a problem with one of these parts, contact a service technician.


Installing a hot-swap power supply

Refer to the following illustrations to install an additional power supply.

Note: The illustrations in this document might differ slightly from your hardware.







Power supply 2 power cord connector

To install a power supply:

1. Remove the filler panel.

Note: During normal operation, each power-supply bay must have either a power supply or filler panel installed for proper cooling.

- 2. Place the power supply handle in the open position.
- 3. Slide the power supply into the chassis and press the handle to the closed position.
- 4. Plug the power cord into the power cord connector on the rear of the server; and then, into a properly grounded electrical outlet.
- 5. Verify that the DC power light and AC power light on the power supply are lit, indicating that the power supply is operating correctly.


Installing memory modules

Before you install memory, review the following:

- Your server comes with a dual inline memory module (DIMM) installed in DIMM connector 1 (J23). Install additional DIMMs as instructed in the documentation that comes with your option.
- Your server supports 128MB, 256MB, 512MB, and 1GB DIMMs. Your server supports a minimum of 128 MB and a maximum of 4 GB of system memory. See the ServerProven™ list on the World Wide Web at http://www.ibm.com/pc/compat for a list of memory modules for use with your server.
- Installing or removing DIMMs changes the configuration information in the server. Therefore, after installing or removing a DIMM, you must save the new configuration information using the Configuration/Setup Utility program. Refer to the User's Reference on the IBM Netfinity Documentation CD for more information.

See the following illustration to install additional memory.





- 6. Install the cover.
- 7. Reconnect the cables and power cords; then, turn on the server.

Chapter 3. Starting the server

Use the following procedure to start your server.

1. Turn on all external devices, such as the monitor.


Note: After you plug the power cord into an outlet, wait 20 seconds before pressing the power control button. During this time, the power control button will not respond because the Advanced System Management Processor is being initialized.

2. Press the power control button on the front of the server. The power control light comes on and the power-on self-test (POST) begins.

Controls and indicators

The following illustration shows the controls and lights on the front of the server.

Note: The illustrations in this document might differ slightly from your hardware.



System power light: When this green light is on, system power is present in the server. When this light flashes, the server is in standby mode (the system power supply is turned off and AC current is present). When this light is off, either a power supply, AC power, or a light has failed.

Attention: If this light is off, it does not mean there is no electrical current present in the server. The light might be burned out. To remove all electrical current from the server, you must unplug the server power cords from the electrical outlets or from the UPS.

Power control button: Press this button to manually turn the server on or off.

Note: A power-control-button cover is provided with your server. You can install this circular disk over the power control button to prevent accidental manual power-off.

You can start the server in several ways:

• You can turn on the server by pressing the power control button on the front of the server.

Note: After you plug the power cord of your server into an electrical outlet, wait 20 seconds before pressing the power control button. During this

time the system-management processor is initializing and the power control button does not respond.

- If the server is turned on, a power failure occurs, and unattended-start mode is enabled in the Configuration/Setup utility program, the server will start automatically when power is restored.
- If AC power is present, the server is off, and the wake-up feature is enabled in the Configuration/Setup utility program, the wake-up feature will turn on the server at the set time.
- If AC power is present, the server is off, and ring-signal detect is enabled in the Configuration/Setup utility program, you can turn on the server by telephone input.
- The Netfinity Advanced System Management Processor also can turn on the server.

You can turn off the server as follows:

You can turn off the server by pressing the power control button on the front of the server. Pressing the power control button starts an orderly shutdown of the operating system, if this feature is supported by your operating system, and places the server in standby mode.

Note: After turning off the server, wait at least 5 seconds before pressing the power control button to power the server on again.



CAUTION:

The power control button on the device and the power supply do not turn off the electrical current supplied to the device. The device also might have more than one power cord. To remove all electrical current from the device, ensure that all power cords are disconnected from the power source.



- You can press and hold the power control button for more than 4 seconds to cause an immediate shutdown of the server and place the server in standby mode. You can use this feature if the operating system stops.
- You can disconnect the server power cords from the electrical outlets to shut off all power to the server.

Note: Wait about 15 seconds after disconnecting the power cords for your system to stop running. Watch for the system power light on the operator information panel to stop blinking.

Reset button: Press this button to reset the server and run the power-on self-test (POST).

Controls and indicators

AC power light: This green light provides status information about the power supply. During normal operation, both the AC and DC power lights are on. For information about any other combination of lights, refer to the *User's Reference* on the IBM Netfinity Documentation CD. See the illustration in "Installing a hot-swap power supply" on page 12 for the location of this LED.

Operator information panel: The lights on this panel give status information for your server. See "Operator information panel" on page 20 for more information.

DC power light: This green light provides status information about the power supply. During normal operation, both the AC and DC power lights are on. For information about any other combination of lights, refer to the *User's Reference* on the IBM Netfinity Documentation CD. See the illustration in "Installing a hot-swap power supply" on page 12 for the location of this LED.


Hard disk drive status light: Each of the hot-swap drive bays has a hard disk drive status light. When this amber light is on continuously, the drive has failed.

If a ServeRAID adapter is installed and this light flashes slowly (one flash per second), the drive is being rebuilt. When the light flashes rapidly (three flashes per second), the controller is identifying the drive.

Hard disk drive activity light: Each of the hot-swap drive bays has a hard disk drive activity light. When this green light is flashing, there is activity on that hard-disk drive.

Operator information panel

The following illustration shows the operator information panel on the front of the server. (See "Controls and indicators" on page 17 for the location of the operator information panel.)



SCSI hard disk drive activity light: This green light is on when there is activity on a hard disk drive.

Ethernet link status light: When this green light is on, there is an active connection on the Ethernet port.

Ethernet transmit/receive activity light: When this green light is on, there is transmit or receive activity to or from the server.

Information light: This amber light is on when the information log contains information about certain conditions in your server that might affect performance.

System error light: This amber light is lit when a system error occurs. An LED on the diagnostic LED panel will also be on to further isolate the error.

Chapter 4. Configuring your server

The ServerGuide CDs provide software setup tools and installation tools that are specifically designed for your IBM Netfinity server. Use these CDs during the initial installation of your server to configure basic hardware features and to simplify your network operating system installation. (See "Using the ServerGuide CDs" for more information.) The ServerGuide CDs also contain a collection of application programs, which you can install after your server is up and running.

In addition to the ServerGuide CDs, you can use the following configuration programs to customize your server hardware:

• Configuration/Setup Utility

The Configuration/Setup Utility program is part of the *basic input/output system* (*BIOS*) code that comes with your server. You can use this program to configure serial and parallel port assignments, change interrupt request (IRQ) settings, change the drive startup sequence, set the date and time, and set passwords.

SCSISelect Utility

With the built-in SCSISelect Utility program, you can configure the devices that are attached to the integrated SCSI controller. Use this program to change default values, resolve configuration conflicts, and perform a low-level format on a SCSI hard disk drive.

ServeRAID programs

If you have a ServeRAID adapter installed in your server, you must use the ServeRAID configuration program to define and configure your disk-array subsystem before you install your operating system.

Attention: Refer to the *User's Reference* on the *IBM Netfinity Documentation* CD for detailed instructions for using the configuration programs and ServerGuide CDs.

Using the ServerGuide CDs

The ServerGuide CDs provide state-of-the-art programs to detect the server model and hardware options that are installed, configure Netfinity server hardware, provide device drivers, and install your network operating system (NOS).

Note: If the ServerGuide CD does not start, see "ServerGuide startup problems" on page 26.

- 1. Insert the *Netfinity Setup and Installation* CD, and restart the server.
- 2. Follow the instructions on the screens to:
 - a. Select your language.
 - b. Select your keyboard layout and country.
 - c. View the Overview to learn about ServerGuide features.

Netfinity systems management solutions

Your IBM Netfinity server includes the Advanced System Management Processor. This systems management subsystem monitors your Netfinity server and notifies you when problems occur. It performs automated actions if specified thresholds are reached and enables you to resolve system problems remotely (using a serial or Advanced System Management Interconnect connection), even if the server is powered down or the operating system has locked up.

Your server comes with the following Netfinity management software products: the IBM Netfinity Manager™ program and Client Services for Netfinity Manager version 5.2.

Some versions of the ServerGuide package contain the IBM Netfinity Manager software. For information about how to install applications that are included in the ServerGuide package, see the ServerGuide information.

IBM Netfinity Manager is a comprehensive set of hardware management utilities. These utilities enable you to manage industry-standard, Intel-processor-based, server, desktop, workstation, and notebook systems over network operating systems from Microsoft, SCO, Novell, and IBM. These utilities support multiple protocols, including TCP/IP, IPX, NetBIOS, SNA, SLIP, and HTTP. This robust set of systems management software tools delivers comprehensive local and remote system control over the entire life cycle of the system.

Chapter 5. Solving problems

This section provides basic troubleshooting information to help you resolve some common problems that might occur while setting up your server.

If you cannot locate and correct the problem using the information in this section, refer to the "Solving problems" section on the *IBM Netfinity Documentation* CD and the "Support for Netfinity Servers" flowchart in the front of this booklet.

POST beep code descriptions

POST emits one beep to signal successful completion. If POST detects a problem during startup, other beep codes might occur. You can use the following beep code descriptions to help identify and resolve problems that are detected during startup.

Note: See the "Solving problems" section of the *User's Reference* on the *IBM Netfinity Documentation* CD for more information about the POST beep codes.

Beep code	Descriptions of the POST beep codes
No beep	Call for service.
Continuous	If no video appears, the startup microprocessor failed. Verify that the startup microprocessor is installed correctly. If it is, replace the startup microprocessor. If the problem persists, call for service.
One short	POST completed successfully. One beep also occurs after POST if you enter an incorrect password.
Two short	Follow the instructions that appear on the screen.
Three short	POST detected a system memory error. Verify that the memory is installed correctly. If it is, replace the failing memory module.
Repeating	The system board might contain a failing component.
short	1. Verify that the keyboard and pointing devices are connected properly.
	2. Ensure that nothing is resting on the keyboard.
	3. Disconnect the pointing device; then, restart the server. If the problem goes away, replace the pointing device. If the problem remains, call for service.
One long and one short	If the video controller on the system board is being used, call for service. If you installed an optional video adapter, replace the failing adapter
One long and two short	A video I/O adapter ROM is not readable, or the video subsystem is defective. If you installed an optional video adapter, replace the failing adapter. If the problem remains, call for service.
One long and three short	The system-board video subsystem has not detected a monitor connection to the server. Ensure that the monitor is connected to the server. If the problem persists, replace the monitor.


