

Chapter 1. 4Ux20D Tower-to-Rack Kit introduction

The IBM[®] 4Ux20D Tower-to-Rack Kit contains the parts needed to convert a 4U computer or server that is 50.8 cm (20 in.) deep from a tower model to a rack model. You can then install the system in a rack cabinet that is 58.4–71.1 cm (23–28 in.) deep.

Note: Throughout this book, the word system refers to a computer or server.

The following parts come with the 4Ux20D Tower-to-Rack Kit:

- Two release-latch-bracket assemblies (one left and one right)
- One server bottom cover
- One rack-model trim bezel
- One Universal Serial Bus (USB) bezel insert
- · Four rack-support wheels
- Two slide rails
- One cable-management arm
- One hinge bracket
- One hinge pin
- Miscellaneous hardware kit (includes screws, cage nuts, and clip nuts to install the system in a rack cabinet)
- Cable straps
- One rack installation template and instructions
- One small computer system interface (SCSI) ID label
- Warranty information (contained in this document)

Note: The illustrations in this documentation might differ slightly from your hardware.

Tool requirements

You will need the following tools to install the 4Ux20D Tower-to-Rack Kit:

- A small flat-blade screwdriver
- A medium Phillips screwdriver
- A 10-mm nut driver

Installation overview

Use the following general steps to prepare your system and install the 4Ux20D Tower-to-Rack Kit:

- 1. Read "Safety" on page iii and "Handling static-sensitive devices" on page 2. These guidelines help you work safely with your system.
- 2. Follow the instructions in Chapter 2, "Installing the tower-to-rack kit," on page 3 to prepare your system.
- Use the rack installation template and instructions that come with this kit to install your system in a rack cabinet.
- 4. Attach all cables and neatly route them before turning on your system.

Handling static-sensitive devices

Attention: Static electricity can damage electronic devices and your system. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and possibly damage the device.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the system unit for at least 2 seconds. (This drains static electricity from the package and from your body.)
- Remove the device from its package and install it directly into your system unit without setting it down. If it is necessary to set the device down, place it in its static-protective package. Do not place the device on your system unit cover or on a metal table.
- Take additional care when handling devices during cold weather because heating reduces indoor humidity and increases static electricity.

Chapter 2. Installing the tower-to-rack kit

This chapter provides instructions for preparing your system and installing the towerto-rack kit.

Preparing your system

Complete the following steps to prepare your system.

1. Shut down the operating system and remove all media from the drives, such as diskettes, CDs, optical disks, or tapes.

2. Turn off the system and attached devices.



- 3. Disconnect all power cords from the system and electrical outlets.
- Note the location of the remaining cables; then, disconnect the cables from the system.

Removing the covers, support-bracket assembly, door, bezel, and feet

Complete the steps in this section to:

- Remove the left-side cover
- Remove the support-bracket assembly
- Remove the front door and bezel
- Remove the feet

1. Unlock the left-side cover, if necessary; then, open the cover-release latch and slide the left-side cover toward the rear of the system to remove it.




Figure 1. Removing the left-side cover

- 2. Remove the support-bracket assembly.
 - a. If there is a fan attached to the support-bracket assembly, note where the fan cable is connected to the system board; then, disconnect the fan cable from the system board.

Note: Refer to the system service label for system-board connector locations.

b. Grasp the rear of the support-bracket assembly and rotate it away from the system.




Figure 2. Removing the support-bracket assembly

c. Pull the front of the support-bracket assembly away from the system and set the assembly aside for later installation.

- 3. Remove the front door and bezel assembly.
 - a. Grasp the end of the blue bezel-release lever inside the system; then, move the lever forward to release the front door and bezel assembly.




Figure 3. Removing the front door and bezel assembly

b. Swing the assembly away from the front of the system; then, with a downward motion, press on the front door and bezel assembly to release the bezel tabs from the openings on the bottom of the server. Store the assembly for possible future use.

- 4. Remove the four feet from the system.
 - a. Carefully turn the system open-side up on a flat surface.
 - b. If the front feet on the system do not already face outward, rotate them as shown in the following illustration.




Figure 4. Rotating the front feet

Carefully use a flat-blade screwdriver to push in the tabs on each of the four feet and remove them from the system. Store the feet for possible future use.




Figure 5. Removing the system feet

Relocating and installing the hardware, covers, and bezel

Complete the steps in this section to:

- Remove and relocate the power-switch and LED panel
- Replace the support-bracket assembly
- Install the top cover
- Remove the top handle
- Remove the right-side cover
- Install the new bottom cover
- Install the new bezel
- Install the release-latch bracket assembly
- Attach the rack-support wheels

- 1. Move the power-switch and LED assembly to the rack-orientation location.
 - a. If your system has hot-swap drives installed, note their locations; then, remove them according to the documentation that comes with your system.

Note: Be sure to remove the hot-swap drive bay filler panels so that they are not damaged.

- Rotate the drive cage outward until it locks in the vertical position, so that you can reach through to the other side of the power-switch and LED assembly cable.
- c. To remove the power-switch and LED assembly, press in on the tab on the left side of the panel; then, squeeze the top and bottom of the right side of the panel and carefully pull the assembly away from the system.




Figure 6. Relocating the power-switch and LED assembly

d. Note where the power-switch and LED assembly cable connects to the system board; then, carefully disconnect the cable from the system board.

Notes

- You might need to remove the diskette and integrated drive electronics (IDE) cables to access the power-switch and LED assembly cable connector.
- 2) Some cables might have two connectors that you must disconnect.
- 3) Refer to the system service label for system-board connector locations.
- e. Gently pull the cable through the opening on the front of the system.
- f. Carefully push the cable through the opening in the new rack-orientation location in the top left of the front of the chassis. If your cable has two connectors, be sure to push the System Error LED connector (attached to the amber LED) through the small opening and push the power-switch connector through the large opening, as shown in Figure 6.

g. Connect the cable to the system board where you disconnected it earlier.

Note: If your cable has two connectors, make sure that you connect both of them to the system board.

- h. Align the power-switch and LED assembly with its new location; then, carefully snap the assembly into place on the front of the system.
- Lower the drive cage back to its normal position; then, in the appropriate drive bays, install the hot-swap drives that you removed.

Note: To be sure that the air-baffle assembly is replaced correctly, you might need to route the cable underneath the drive cage.

- 2. Replace the support-bracket assembly and connect the power cable.
- 3. Install the top cover.
 - a. Open the cover latch.
 - b. Align the top cover with the top of the system.
 - c. Slide the cover toward the front of the system until the cover snaps into place.

Note: Ensure that the tabs on the back of the cover fit into the slots on the back of the system. Be sure that the front edge of the cover is flat against the system.




Figure 7. Installing the top cover

- 4. Remove the top handle.
 - a. Turn the system back to the tower orientation.
 - b. Carefully use a flat-blade screwdriver to push in the tabs inside the plastic cover on the top of the system; then, remove the plastic cover. Store the cover for possible future use.




Figure 8. Removing the plastic cover from the handle

c. Grasp the metal handle and slide it toward the rear of the system to remove it from your system. Store the metal handle for possible future use.




Figure 9. Removing the top handle

- 5. Remove the right-side cover.
 - a. From the rear of the system, remove the four screws that hold the right-side cover in place. Save all four screws for installing the new bottom cover.




Figure 10. Removing the right-side cover

- b. Slide the right-side cover toward the rear of the system to remove it. Store the cover for possible future use.
- 6. Install the new bottom cover that comes with this kit.
 - a. Carefully turn the system so that the cover-release-latch side is down on a flat surface; then, align the bottom cover with the frame of the system.




Figure 11. Installing the new bottom cover

- b. Slide the cover toward the front of the system, making sure that the tabs on the front and rear of the cover fit into the slots on the system.
- c. Use three of the screws that you removed earlier to secure the bottom cover; then, use the fourth screw to secure the power supply.
- 7. Turn over the system to the upright rack-mount orientation.

8. If your system has hot-swap drives installed, remove the hot-swap drive bay filler panel from the new bezel that comes with this kit.

Note: Attach the SCSI ID label that comes with this kit on the front of the bezel, just above where you removed the hot-swap drive bay filler panel.




Figure 12. Removing the hot-swap drive bay filler panel from the bezel

- 9. If your system does not have Universal Serial Bus (USB) support, install the USB bezel insert over the empty USB block on the front of your system.
 - a. Align the top of the USB bezel insert with the top of the USB block. Make sure that the side of the USB bezel insert that will extend into the new system bezel is facing away from the system.




Figure 13. Installing the USB bezel insert

b. Rotate the bottom of the USB bezel insert toward the server; then, push until it snaps into place.

10. Install the new system bezel that comes with this kit.

Note: Make sure the front of the system extends approximately 2.54 cm (1.0 in.) beyond the surface on which you are working.

- a. With the bezel tilted slightly downward, align the tab on the back of the bezel with the tab opening on the left front of the system.
- b. Swing the bezel up to a horizontal position facing toward the system; then, press the bezel until it snaps into place.




Figure 14. Installing the new system bezel

- 11. Install the release-latch-bracket assemblies on the system.
 - a. Align the bracket marked with an **L** with the holes on the left side of the system; then, use two M3.5 screws to attach the bracket to the system.




Figure 15. Installing the release-latch-bracket assemblies

- b. Repeat this step to install the other release-latch-bracket assembly on the right side of the system.
- 12. Remove the screws from the left side of the chassis.

13. Attach the four rack-support wheels to the uppermost holes on the sides of the system.




Figure 16. Attaching the rack-support wheels

- 14. Using the rack installation template and instructions that comes with this kit, install the system in a rack cabinet.
- 15. Before turning on the system, attach all cables and neatly route them.

- Identification of non-IBM software problem sources.
- Installation of customer replaceable units (CRUs).
- Installation and configuration of machine code or licensed internal code that is designated as customer installable.

If you do not register your server with IBM, you might be required to present proof of purchase to obtain warranty service.

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 -Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Items Not Covered by Warranty: IBM does not warrant uninterrupted or error-free operation of a Machine. The arbitration tribunal will consist of three arbitrators. The language to be used therein will be English and Chinese. An arbitral award will be final and binding on all the parties, and will be enforceable under the Convention on the Recognition and Enforcement of Foreign Arbitral Awards (1958).

The arbitration fee will be borne by the losing party unless otherwise determined by the arbitral award.

During the course of arbitration, this Agreement will continue to be performed except for the part which the parties are disputing and which is undergoing arbitration.
