


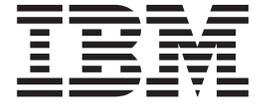

About this book

This book provides instructions for installing and customizing the configuration of your IBM® FAStT FC-2 Host Bus Adapter and connected devices. It also provides information on troubleshooting your IBM FAStT FC-2 Host Bus Adapter.

How this book is organized

Chapter 1, “Preparing and installing the IBM FAStT FC-2 Host Bus Adapter” on page 1 describes the IBM FAStT FC-2 Host Bus Adapter. This chapter includes an overview of the IBM FAStT FC-2 Host Bus Adapter features and contains the information and instructions needed to prepare and install the IBM FAStT FC-2 Host Bus Adapter.

Chapter 2, “Troubleshooting” on page 7 covers the types of installation problems that can cause the IBM FAStT FC-2 Host Bus Adapter to function incorrectly.

Chapter 3, “Installing the FAStT FC-2 Adapter device drivers and updating the BIOS code” on page 9 provides information for updating the IBM FAStT FC-2 Host Bus Adapter BIOS code.

Chapter 4, “Using IBM Fast!UTIL” on page 15 provides detailed configuration information for users who want to customize the configuration of the IBM FAStT FC-2 Host Bus Adapter and connected Fibre Channel devices.

Chapter 5, “Adapter operating environment and specifications” on page 21 contains the IBM FAStT FC-2 Host Bus Adapter operating environment and specification information.

Appendix A, “Getting help, service, and information” on page 23 describes how to obtain help, service, and information about IBM products.

Chapter 1. Preparing and installing the IBM FAStT FC-2 Host Bus Adapter

This chapter contains instructions for preparing and installing the IBM FAStT FC-2 Host Bus Adapter and describes the adapter components.

Overview

The IBM FAStT FC-2 Host Bus Adapter is a 2 Gb high-performance, direct memory access (DMA), bus master, Fibre Channel host adapter designed for high-end systems. The function and performance are derived from the ISP2310 chip (see Figure 2 on page 4), making this IBM FAStT FC-2 Host Bus Adapter a leading-edge host adapter.

The ISP2310 chip combines a powerful, reduced instruction set computer (RISC) processor, a Fibre Channel protocol manager (FPM) with one 2 Gb Fibre Channel transceiver, and a peripheral component interconnect (PCI) or peripheral component interconnect-extended (PCI-X) local bus interface in a single-chip solution. The IBM FAStT FC-2 Host Bus Adapter supports all Fibre Channel (FC) peripheral devices that support private-loop direct attach (PLDA) and fabric-loop attach (FLA).

The IBM FAStT FC-2 Host Bus Adapter connects the following:

- Mainframe computers
- Super computers
- Workstations
- Storage devices
- Servers

The IBM FAStT FC-2 Host Bus Adapter is referred to throughout this book as the FAStT FC-2 Adapter.

Fibre Channel defined

Fibre Channel technology is outlined in the *SCSI-3 Fibre Channel Protocol* (SCSI-FCP) standard. Fibre Channel is a high-speed data transport technology used for mass storage and networking.

Using a Fibre Channel Arbitrated loop (FC-AL), 126 Fibre Channel devices can be supported, compared to 15 SCSI devices with Ultra SCSI.

The FAStT FC-2 Adapter uses a multimode shortwave optical interface for distances up to 500 meters.

The FAStT FC-2 Host Adapter is a 2Gb Fibre Channel device that supports data transfer rates up to 200 MB per second half-duplex and 400 MB per second full-duplex on optical interfaces.

FASTt FC-2 Adapter features

The FASTt FC-2 Adapter has the following features:

- Compliance with Intel® PCI Local Bus version 2.2 specification
- Compliance with peripheral component interconnect-extended (PCI-X) addendum, revision 1.0 to the Intel PCI Local Bus version 2.2 specification
- Compliance with Third Generation Fibre Channel Physical and Signaling Interface (PC-PH-3), revision 9.2
- Compliance with Fibre Channel Arbitrated Loop (FC-AL-2) standard
- Compliance with U.S. and international safety and emissions standards
- Support for direct memory access (DMA)
- Support for bus master
- Fast!UTIL basic input/output system (BIOS) utility program to customize the configuration parameters on the FASTt FC-2 Adapter and attached drives
- Support for Fibre Channel protocol SCSI (FCP-SCSI) and Fibre Channel Internet protocol (FCP-IP)
- Support for point-to-point fabric connection (F-PORT FABRIC LOGIN)
- Support for Fibre Channel service (Classes 2 and 3)

Preinstallation procedures

Before you begin the FASTt FC-2 Adapter installation, do the following:

- Read “Handling static-sensitive devices” on page 3.
- Read “What you need for the installation” on page 3.




Figure 1. FASTt FC-2 Adapter serial number label

- Write down the serial number of the FASTt FC-2 Adapter. Each adapter has a unique serial number. If the nonvolatile random access memory (NVRAM) is damaged, the system will prompt you for the FASTt FC-2 Adapter serial number. Figure 1 shows the serial number label location.

Handling static-sensitive devices

Attention: Static electricity can damage electronic devices and your system. To avoid damage, keep static-sensitive devices in their static-protective package until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and possibly damage the device.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the system unit for at least 2 seconds. (This drains static electricity from the package and from your body.)
- Remove the device from its package and install it directly into your system unit without setting it down. If it is necessary to set the device down, place it in its static-protective package. Do not place the device on your system unit cover or on a metal table.
- Take additional care when handling devices during cold weather because heating reduces indoor humidity and increases static electricity.

What you need for the installation

To install the FAStT FC-2 Adapter in your server, you need the following two items:

- A small Phillips screwdriver
- An LC-LC Fibre Channel Cable¹

1. This option does not come with the IBM FAStT FC-2 Host Bus Adapter and must be ordered separately.

FASTt FC-2 Adapter components




Figure 2. FASTt FC-2 Adapter components

Figure 2 identifies the FASTt FC-2 Adapter (QLA2310) components that are referred to in this chapter.

Installing the FAStT FC-2 Adapter

Attention: To avoid damage to your fiber-optic cables, follow these guidelines:

- Do not route the cable along a folding cable-management arm.
- When attaching fiber-optic cables to a Fibre Channel device on slide rails, leave enough slack in the cables so that they do not bend to a radius smaller than 38 mm (1.5 in.) when extended or become pinched when retracted.
- Route the cable away from places where it can snag on other Fibre Channel devices in the rack.
- Do not overtighten the cable straps or bend the cables to a radius smaller than 38 mm (1.5 in.).
- Do not put excess weight on the cable at the connection point and be sure that the cable is well supported.

The FAStT FC-2 Adapter comes with an attached standard 3U adapter bracket as shown in Figure 2 on page 4. An additional Low Profile 2U bracket also comes with the adapter. Before you install the FAStT FC-2 Adapter, verify whether you need the Fibre Channel Low Profile 2U adapter bracket. If you need to install the Low Profile 2U bracket, go to step 1. Otherwise go to step 2.

1. To install the Fibre Channel Low Profile 2U adapter bracket, do the following:
 - a. Remove your FAStT FC-2 Adapter from the static-protective package. Set the adapter down on a nonconductive, static-protected surface (place it component side up). Do not place the adapter on your system unit cover or on a metal table.
 - b. Use your small Phillips screwdriver to carefully remove the two bracket screws from your 3U adapter (you will reuse the two adapter screws). Take off the 3U bracket and set it aside.
 - c. Align the two screw holes in the 2U adapter bracket with the two screws holes on the adapter. Using the two screws you removed in step 1a, secure the bracket to the adapter.
 - d. Return the adapter to the static-protective package until you are ready for installation.
2. Check the system board and make any configuration changes needed to accommodate the FAStT FC-2 Adapter.

Note: The FAStT FC-2 Adapter is self-configuring; however, some system boards require manual configuration. For example, some systems have a PCI Device Configuration menu in the system board setup BIOS code where you must enable host adapters, bus-master slots, and interrupt request (IRQ) levels. If the system board supports triggering, use level triggering for the FAStT FC-2 Adapter. For system specific configuration, refer to the documentation that comes with your server, or contact your IBM technical support representative to determine if your system board requires configuration.

3. Turn off the peripheral devices, then the server.
4. Disconnect the power cords.
5. Remove the server cover.
6. Remove the expansion slot cover. Refer to the documentation that comes with the server to determine the expansion slot cover type and detailed instructions. Choose any PCI bus-master slot that supports bus mastering. Most system boards automatically assign an IRQ level and interrupt line. If your system

board does not automatically assign an IRQ level and interrupt line, you must assign an IRQ level and use interrupt line A for this PCI bus-master slot.

- Some system boards have two kinds of PCI bus slots: master and subordinate. The FAStT FC-2 Adapter must be in a PCI bus-master slot. (Some system boards have PCI bus-master slots that are shared with on-board devices. The FAStT FC-2 Adapter does not work in shared PCI bus-master slots.)
- PCI connectors vary among system board manufacturers. The FAStT FC-2 Adapter is a 64-bit PCI device that can function in a 32-bit PCI bus-master slot.

Attention: If you try to install the FAStT FC-2 Adapter into a PCI bus-master slot that does not conform to the PCI specification, you might damage the FAStT FC-2 Adapter.

- The FAStT FC-2 Adapter is designed and tested to operate at PCI bus speeds of up to 66 MHz.
 - The FAStT FC-2 Adapter is designed and tested to operate at PCI-X bus speeds up to 100 MHz.
 - PCI and PCI-X slots look the same. If the server contains both PCI and PCI-X bus-master slots, refer to the documentation that comes with the server to determine the slot type.
7. Align the adapter with the expansion slot. Carefully press the adapter into the PCI bus-master slot until it is fully seated and secure.
 8. Connect one end of an LC-LC Fibre Channel cable to the optical interface connector (located at J1) on the FAStT FC-2 Adapter. Connect the other end to a Fibre Channel device. (See Figure 2 on page 4 for the location of the J1 connector.)
 9. Carefully install and secure the server cover.
 10. Connect the power cables.
 11. Turn on all external Fibre Channel devices; then, turn on the server. The following information is displayed:

To display the Fibre Channel devices, press Ctrl+Q, and then use the Fast!UTIL program. See Chapter 4, “Using IBM Fast!UTIL” on page 15 for detailed utility information.

If the information displayed is not correct and you have checked the adapter configuration, go to Chapter 2, “Troubleshooting” on page 7 for problem solving information.

If the information displayed is correct, go to Chapter 3, “Installing the FAStT FC-2 Adapter device drivers and updating the BIOS code” on page 9 for detailed instructions on how to update the FAStT FC-2 Adapter BIOS code.

Chapter 2. Troubleshooting

There are three types of installation problems that might cause your FAStT FC-2 Adapter to function incorrectly:

- Hardware problems
- System configuration problems
- Fibre Channel problems

If you are having problems, use the following information to help you determine the cause of the problem and the action to take.

Hardware problems

Take the following actions to determine if your installation problem is caused by the hardware:

- Verify that all adapters are installed securely.
- Verify that all cables are attached securely to the correct connectors. Be sure that one end of the LC-LC Fibre Channel cable is attached to the optical interface connector (located at J1 on the adapter) and that the other end is connected to the Fibre Channel device.
- Verify that the FAStT FC-2 Adapter is installed correctly and is fully seated in the expansion slot. Check for interference due to nonstandard PCI connectors.
- Verify that the Fast!UTIL data-rate setting is correct. Refer to “Extended Firmware Settings” on page 18. The Fast!UTIL data-rate setting must match the speed of the device to which you are connected.
- Verify that all peripheral devices are turned on. See “Scan Fibre Channel devices” on page 20 for information about displaying attached Fibre Channel devices.

System configuration problems

To verify that your installation problem is caused by the system configuration, check your server to ensure that it is configured properly (see “Installing the FAStT FC-2 Adapter” on page 5).

Note: All PCI-compliant and PCI-X-compliant systems automatically detect 32-bit or 64-bit adapters and set the appropriate bus speed (for example, 33 MHz or 66 MHz).

If you still have a system configuration problem, refer to the documentation that comes with your server, or contact your IBM technical-support representative to determine if your system board requires special configuration.

Fibre Channel problems

To determine if your installation problem is caused by an attached Fibre Channel device, do the following:

- Verify that all of the Fibre Channel devices were turned on before you turned on the server.
- Ensure that all cables are connected properly.
- Verify that you configured your RAID storage subsystems using the utilities provided by the manufacturer.

- If your Fibre Channel switch supports zoning, make sure that your peripheral device is configured to the same switch zone as the FAStT FC-2 Adapter. For more information, refer to your Fibre Channel switch documentation.

Chapter 3. Installing the FASTT FC-2 Adapter device drivers and updating the BIOS code

After you install your FASTT FC-2 Adapter, you are ready to install the device drivers for the adapter and update the adapter BIOS code.

After you install the adapter device drivers, you must update the FASTT FC-2 Adapter BIOS code using the BIOS Update Utility that is provided on the Support CD. To update the adapter BIOS code, you can use the BIOS Update Utility from the bootable Support CD or you can create and use a BIOS Update Utility diskette.

Installing the FASTT FC-2 Adapter device drivers

To install the IBM FASTT FC-2 Host Bus Adapter device drivers, refer to the *IBM FASTT FC-2 Host Bus Adapter Support CD* that comes with the adapter for the following:

- Adapter device drivers
- Installation instructions (see README)

Updating the FASTT FC-2 Adapter BIOS code from the Support CD

To update the FASTT FC-2 Adapter BIOS code and non-volatile random access memory (NOVRAM) using the BIOS Update Utility on the Support CD, use one of following two methods:

- The flasutil command prompt
- The flasutil BIOS Update Utility menu

Using the flasutil command prompt (from the Support CD)

To update your FASTT FC-2 Adapter BIOS code and NOVRAM, do the following:

1. Insert the *IBM FASTT FC-2 Host Bus Adapter Support CD* into the CD-ROM drive. Restart the server. Your server will start to a DOS prompt.
2. From the DOS prompt, type:
`flasutil /f /1`
3. Press Enter.
4. Type:
`flasutil /u`

5. Press Enter.
6. Type:
flasutil /?

To write NOVRAM on all FAStT Host Adapters in a system without being prompted for I/O address, type:

```
flasutil /L
```

To write NOVRAM and flash to all adapters, type:

```
flasutil /L /F
```

To make the new settings the defaults, type:

```
flasutil /U
```

To write NOVRAM to the adapter at I/O address f400, type:

```
flasutil /L f400
```

To write NOVRAM and flash an adapter at I/O address f800, type:

```
flasutil /L f800 /F f800
```

Using the flasutil BIOS Update Utility menu (from the Support CD)

To update the FAS^T FC-2 Adapter BIOS code using the flasutil BIOS Update Utility menu, do the following:

1. Insert the *IBM FAS^T FC-2 Host Bus Adapter Support CD* into the CD-ROM drive. Restart the server. Your server will start to a DOS prompt.
2. From the DOS prompt, type:

```
flasutil
```

3. Press Enter.

If you have more than one adapter, a list of adapters and their I/O addresses displays. If you have only one adapter, the following list of options displays.

L = Write NOVRAM

F = Write Flash

A = Write NOVRAM and defaults

D = Copy NOVRAM to file:QLxxNVRM.SAV

W = Copy Flash to file: QLxxROM.SAV

U = Update BIOS NOVRAM defaults

S = Display serial number

V = Display current BIOS version

C = Verify Flash

X = Verify NOVRAM

4. At the command prompt, type the appropriate I/O address and press Enter.

Note: You can run the utility from the command line with the options as /y, where y is the option required.

Updating the FAS^T FC-2 Adapter BIOS code from the BIOS Update Utility diskette

If you can not use the bootable Support CD to update the adapter BIOS code, you can create a diskette using the Support CD. Instructions for creating and using the diskette are described in the following sections.

Creating the BIOS Update Utility diskette

Create the BIOS Update Utility diskette by copying the image you need from the *IBM FAS^T FC-2 Host Bus Adapter Support CD* or from the <http://www.ibm.com/pc/support/> IBM Web site.

For Microsoft Windows 95, Windows 98, Windows NT 4.0, or Windows 2000

To create a BIOS Update Utility diskette for Microsoft Windows 95, Windows 98, Windows NT 4.0, or Windows 2000 from the *IBM FAS^T FC-2 Host Bus Adapter Support CD*, do the following:

1. Insert the *IBM FAS^T FC-2 Host Bus Adapter Support CD* into the CD-ROM drive.
2. At the command prompt, type:

```
d:\tools\dsk4w32 d:\images\biosnvrn\23x0\2300_xxx.img a:
```

Where *d* is the CD-ROM drive and *a* is the diskette drive.

3. Press Enter.

4. Remove the *IBM FAStT FC-2 Host Bus Adapter Support* CD from the CD-ROM drive.
5. Remove the diskette from the diskette drive and label the diskette appropriately.

For Linux

To create a BIOS Update Utility diskette for Linux from the *IBM FAStT FC-2 Host Bus Adapter Support* CD, do the following:

1. Insert the *IBM FAStT FC-2 Host Bus Adapter Support* CD into the CD-ROM drive and restart the server.

2. At the command prompt, type:

```
mount -t iso9660/dev/cdromdevicefile /mnt
```

Where *cdromdevicefile* is the specific device file for the CD-ROM block device.

3. Press Enter.

4. Type:

```
dd if=/mnt/images/biosnvrn/23x0/2300_xxx.img of=/dev/diskettefile bs=32
```

5. Press Enter.

6. Unmount the CD-ROM by typing:

```
umount /mnt
```

7. Remove the *IBM FAStT FC-2 Host Bus Adapter Support* CD from the CD-ROM drive.

8. Remove the diskette from the diskette drive and label the diskette appropriately.

9. To update your adapter BIOS code, go to “Using the flasutil command prompt (from the diskette)” or “Using the flasutil BIOS Update Utility menu (from the diskette)” on page 13.

Using the flasutil command prompt (from the diskette)

To update your FAStT FC-2 Adapter BIOS code and NOVRAM using the flasutil command prompt, do the following:

1. Insert the BIOS Update Utility diskette that you created into drive A and restart the server. Your server will start to a DOS prompt.

2. From the DOS prompt, type:

flasutil /f /1
```

3. Press Enter.

4. Type:

```
flasutil /u
```

5. Press Enter.

6. Type:

```
flasutil /?
```

Command-line options

The following are additional command-line options that you can use.

To update your FAStT FC-2 Adapter BIOS code and NOVRAM using the flasutil BIOS Update Utility, do the following:

3. At the command prompt, type the appropriate I/O address and press Enter.

Note: You can run the utility from the command line with the options as /y, where y is the option required.

Chapter 4. Using IBM Fast!UTIL

This chapter provides detailed configuration information for advanced users who want to customize the configuration of the FASTt FC-2 Adapter and the connected Fibre Channel devices. You can configure the adapter using the Fast!UTIL utility.

Starting Fast!UTIL

To access Fast!UTIL, press Ctrl+Q during the adapter BIOS initialization (it might take a few seconds for the Fast!UTIL menu to appear). If you have more than one FASTt FC-2 Adapter, Fast!UTIL prompts you to select the adapter you want to configure. After changing the settings, Fast!UTIL restarts your system to load the new parameters.

Important: If the configuration settings are incorrect, your FASTt FC-2 Adapter will not function properly.

Fast!UTIL options

This section describes the Fast!UTIL options. The first option on the Fast!UTIL Options menu is Configuration Settings. The settings configure the Fibre Channel devices and the FASTt FC-2 Adapter to which they are attached.

Host Adapter Settings

You can access this option from the Configuration Settings menu in Fast!UTIL by selecting **Host Adapter Settings**. The current default settings for the host adapter are listed in Table 2 and are described in this section.

Table 2. Host adapter settings

Host adapter BIOS: When this option is set to Disabled, the ROM BIOS code on the FASTt FC-2 Adapter is disabled, freeing space in upper memory. This setting must be enabled if you are starting from a Fibre Channel hard disk that is attached to the FASTt FC-2 Adapter. The default is Disabled.

Frame size: This setting specifies the maximum frame length supported by the FASTt FC-2 Adapter. The default size is 2048. If you are using F-Port (point-to-point) connections, the default is best for maximum performance.

Loop reset delay: After resetting the loops, the firmware does not initiate any loop activity for the number of seconds specified in this setting. The default is 5 seconds.

Adapter hard loop ID: This setting forces the adapter to use the ID specified in the Hard loop ID setting. The default is Enabled.

Hard loop ID: When the adapter hard loop ID is set to Enabled, the adapter uses the ID specified in this setting. The default ID is 125.

Note: The FAStT FC-2 Host Adapter settings and default values will vary, based on the version of BIOS code installed for the adapter.

Selectable Boot settings

You can access the Selectable Boot settings option from the Configuration Settings menu. When this option is set to Enabled, you can select the node name from which you want to start up (boot). When this option is set to Enabled, the node will start from the selected Fibre Channel hard disk, ignoring any IDE hard disks attached to your server. When this option is set to Disabled, the Boot ID and Boot LUN parameters have no effect.

The BIOS code in some new systems supports selectable boot, which supersedes the Fast!UTIL selectable boot setting. To start from a Fibre Channel hard disk attached to the FAStT FC-2 Adapter, select the attached Fibre Channel hard disk from the system BIOS menu.

Note: This option applies only to disk devices; it does not apply to CDs, tape drives, and other nondisk devices.

Adapter Hard ID settings

You can access this option from the Configuration Settings menu. It forces the FAStT FC-2 Adapter to use the selected hard ID (0-125). The default is set to 125.

Restore Default settings

You can access this option from the Configuration Settings menu. It restores the FAStT FC-2 Adapter default settings.

Raw NVRAM data

This option displays the adapter nonvolatile random access memory (NVRAM) contents in hexadecimal format. This is a troubleshooting tool; you cannot modify the data.

Advanced Adapter Settings

You can access this option from the Configuration Settings menu by selecting **Advanced Adapter Settings**. The current default settings for the FAStT FC-2 Adapter are listed in Table 3 and are described in this section.

Execution throttle: This setting specifies the maximum number of commands executing on any one port. When a port reaches its execution throttle, Fast!UTIL does not run any new commands until the current command is completed. The valid options for this setting are 1-256. The default (optimum) is 256.

Fast command posting: This setting decreases command execution time by minimizing the number of interrupts. The default is Enabled.

>4GByte addressing: Enable this option when the system has more than 4 GB of memory available. The default is Disabled.

LUNs per target: This setting specifies the number of LUNs per target. Multiple logical unit number (LUN) support is typically for redundant array of independent disks (RAID) enclosures that use LUNs to map drives. The default is 0.

Enable LIP reset: This setting determines the type of loop initialization process (LIP) reset that is used when the operating system initiates a bus reset routine. When this option is set to Yes, the device driver initiates a global LIP reset to clear the target device reservations. When this option is set to No, the device driver initiates a global LIP reset with full login. The default is No.

Enable LIP full logon: This setting instructs the ISP chip to log into all ports after any LIP. The default is Yes.

Enable target reset: This setting enables the device drivers to issue a Target Reset command to all devices on the loop when a SCSI Bus Reset command is issued. The default is Yes.

Login retry count: This setting specifies the number of times the software tries to log into a device. The default is 30 retries.

Port down retry count: This setting specifies the number of times the software retries a command to a port that is returning port-down status. The default is 30 retries.

Drivers load RISC code: When this option is set to Enabled, the FAST FC-2 Adapter uses the RISC firmware that is embedded in the software device driver. When this option is set to Disabled, the software device driver loads the RISC firmware found in the adapter BIOS code. The default is Enabled.

Note: To load the embedded device driver software, the device driver being loaded must support this setting. If the device driver does not support this setting, the result is the same as if this option is set to Disabled, regardless of the

setting. Leaving this option enabled ensures a certified combination of software device driver and RISC firmware.

Enable database updates: When this option is set to Enabled, the software can save the loop configuration information in flash memory as the system powers down. The default is No.

Disable database load: When this option is set to Enabled, the device database is read from the Registry during driver initialization. When this option is set to Disabled, the device database is created dynamically during device driver initialization. The default is No.

Note: This option usually applies to the Windows NT and Windows 2000 operating system environments.

IOCB allocation: This option specifies the maximum number of buffers from the firmware buffer pool that are allocated to any one port. The default setting is 256 buffers.

Extended error logging: This option provides additional error and debugging information to the operating system. When this option is set to Enabled, events are logged into the Windows NT Event Viewer or Windows 2000 Event Viewer (depending on the environment you are in). The default is Disabled.

Extended Firmware Settings

You can access this option from the Configuration Settings by selecting **Extended Firmware Settings**. The current default settings for the host adapter are listed in Table 4 and are described in this section.

Extended control block: This setting enables all other extended firmware settings. The default is Enabled.

RIO operation mode: This setting specifies the reduced interrupt operation (RIO) modes, if supported by the software device driver. RIO modes enable posting

multiple command completions in a single interrupt (see Table 5). The default is 0.

Connection options: This setting defines the type of connection (loop or point-to-point) or connection preference (see Table 6). The default is 2.

Table 6. Connection options

1	Point-to-point only
2	Loop preferred; otherwise, point-to-point

Nonparticipating hard ID: This setting is reserved. The default is Disabled.

Class 2 service: This setting enables Class 2 service parameters to be provided during all automatic logins (loop ports). The default is Disabled.

ACK0: This setting determines the type of acknowledgment (ACK) used. When this option is set to Enabled, sequence ACK is used. When this option is set to Disabled, frame ACK is used. The default is Disabled.

Note: You must enable the Class 2 service setting to use the ACK0 setting.

Fibre Channel tape support: This setting is reserved for Fibre Channel tape support. The default is Disabled.

Fibre Channel confirm: This setting enables the host to send the FCP confirmation frame when requested by the target. The default is Disabled.

Command reference number: This setting is reserved for Fibre Channel tape support. The default is Disabled.

Read transfer ready: This setting is reserved. The default is Disabled.

Response timer: This setting contains the value (in 100-microsecond increments) used by a timer to limit the wait time for accumulating multiple responses. For example, if this field is 8, the time limit is 800 microseconds. The default is 0.

Interrupt delay timer: This setting contains the value (in 100-microsecond increments) used by a timer to set the wait time between accessing (DMA) a set of handles and generating an interrupt. The default is 0.

Data rate: This setting determines the data rate. When this setting is 1, the FAST FC-2 Adapter runs at 2 Gb per second. When set to 2, the Fast!UTIL determines

what rate your system can accommodate and sets the rate accordingly. The default is 2 (the FASiT FC-2 Adapter runs at 1 Gb per second).

Scan Fibre Channel devices

Use this option to scan the Fibre Channel loop and list all the connected devices by loop ID. Information about each device is listed, for example, vendor name, product name, and revision. This information is useful when you are configuring your FASiT FC-2 Adapter and attached devices.

Fibre Channel disk utility

Attention: Performing a low-level format removes all data on the disk.

Use this option to scan the Fibre Channel loop bus and list all the connected devices by loop ID. You can select a disk device and perform a low-level format or verify the disk media.

Select host adapter

Use this option to select, configure, or view a specific adapter if you have multiple adapters in your system.

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines: IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty: The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Items Not Covered by Warranty: IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND.**

Warranty Service: To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability: Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other

contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

UNDER NO CIRCUMSTANCES IS IBM LIABLE FOR ANY OF THE FOLLOWING: 1) THIRD-PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, YOUR RECORDS OR DATA; OR 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES, LOST PROFITS OR LOST SAVINGS, EVEN IF IBM, ITS SUPPLIERS OR YOUR RESELLER IS INFORMED OF THEIR POSSIBILITY. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law: Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Agreement, without regard to conflict of law principles.

ASIA PACIFIC

AUSTRALIA

The IBM Warranty for Machines: *The following paragraph is added to this Section:* The warranties specified in this Section are in addition to any rights you may have under the Trade Practices Act 1974 or other similar legislation and are only limited to the extent permitted by the applicable legislation.

Limitation of Liability: *The following is added to this Section:* Where IBM is in breach of a condition or warranty implied by the Trade Practices Act 1974 or other similar legislation, IBM's liability is limited to the repair or replacement of the goods or the supply of equivalent goods. The arbitrator or arbitrators designated in conformity with those rules shall have the power to rule on their own competence and on the validity of the Agreement to submit to arbitration. The English language version of this Agreement prevails over any other language version.

Any disputes arising from or in connection with this Agreement will first be resolved by friendly negotiations, failing which either of us has the right to submit the dispute to the China International Economic and Trade Arbitration Commission in Beijing, the PRC, for arbitration in accordance with its arbitration rules in force at the time. The arbitration tribunal will consist of three arbitrators. The language to be used therein will be English and Chinese. An arbitral award will be final and binding on all the parties, and will be enforceable under the Convention on the Recognition and Enforcement of Foreign Arbitral Awards (1958).

The arbitration fee will be borne by the losing party unless otherwise determined by the arbitral award.

During the course of arbitration, this Agreement will continue to be performed except for the part which the parties are disputing and which is undergoing arbitration.

EUROPE, MIDDLE EAST, AFRICA (EMEA)

THE FOLLOWING TERMS APPLY TO ALL EMEA COUNTRIES: The terms of this Statement of Limited Warranty apply to Machines purchased from IBM or an IBM reseller.

Applicability of suppliers and resellers (unchanged).

The following replaces the third paragraph of this Section: Unless otherwise provided by mandatory law, IBM and your reseller are not liable for any of the following: *(items 1 and 2 unchanged)* 3) indirect damages, even if IBM or your reseller is informed of their possibility.

SOUTH AFRICA, NAMIBIA, BOTSWANA, LESOTHO AND SWAZILAND

Limitation of Liability: *The following is added to this Section:* IBM's entire liability to you for actual damages arising in all situations involving nonperformance by IBM in respect of the subject matter of this Statement of Warranty will be limited to the charge paid by you for the individual Machine that is the subject of your claim from IBM.
