Chapter 1. General information

The 87691VX Tape Autoloader is a SCSI external storage device that can be connected to a server that uses a low voltage differential (LVD) interface. It provides storage for up to 10 data cartridges. Each data cartridge is capable of storing up to 160 GB of native data, or 320 GB of compressed data, on a 230-meter tape using VXA technology.

See Appendix C, "IBM Statement of Limited Warranty Z125-4753-08 04/2004," on page 71 for the warranty terms. If a tape drive stops functioning due to a component failure during the tape drive warranty or maintenance time, IBM[®] will replace the tape drive unit. IBM will replace any defective tape drive under the terms and conditions of the IBM warranty or service agreement. It is our objective to work with you to identify the cause of any tape drive problems and provide a solution. The 87691VX Tape Autoloader is a Customer Replaceable Unit (CRU).

Status LED

The 87691VX Tape Autoloader has a status LED (see Figure 2), which is located to the right of the operator panel buttons. This LED is lit during normal autoloader activity and flashing when a fault condition occurs.

Operator controls

The 87691VX Tape Autoloader has a five-button operator panel and an LCD screen (see Figure 2) that you can use to monitor the autoloader operations, control tape cartridge movement, and select configuration options. The operator panel is also used to control the insertion and removal of tape cartridges through the access door. See "Using the operator panel" on page 21 for more information about the operator panel.

Use the two emergency access holes to open the access door and remove tape cartridges in the event of a power failure. See "Removing tape cartridges manually" on page 40 for information about this procedure.

Rear components

Tape drive environment and use

Tape drives require specific maintenance and environmental conditions to operate well. Using high-quality, data-grade media, handling and storing this media correctly, operating the tape device in a clean environment, and keeping the tape drive clean can help you to avoid problems.

Tape handling and storage

Most tapes are supplied in sealed cartridges so that the tapes will remain in a clean environment. Opening the cartridge allows dirt and airborne particles to enter. The cartridge should be opened only by the tape drive.

The tape is held under correct tension inside the cartridge. If the cartridge is dropped, this tension is relaxed. Inserting a dropped cartridge into a tape device can cause incorrect loading and jamming, which can ruin the tape and can cause physical damage if the cartridge is not removed correctly.

Store tapes in their protective containers and store them on end. The storage area must be clean, dry, at normal room temperature, and away from magnetic fields.

Environmental issues

Tape devices are designed to operate in a clean environment. Problem factors are dirt, dust, fibers and airborne particles. Airborne particles are the most difficult to address. When a tape is installed in the tape device, the clearance between the heads and the tape is measured in microns. Particles can damage the tape or the head if they come in contact with either. You are responsible for providing a clean operating environment for the tape drive and system.

Tape drive cleaning

No matter how clean the environment is, debris might build up on the heads of any tape drive. Every time a tape moves, some of the media surface comes off onto the heads. Over time, this builds up and causes errors in reading and writing. You are responsible for cleaning the tape drive in accordance with the cleaning procedure in "Cleaning the tape drive" on page 36.

Firmware updates

IBM occasionally releases firmware updates for the tape drives. To download firmware updates, go to http://www.ibm.com/pc/support/site.wss/document.do?lndocid=TAPE-FILES

Installing firmware updates is your responsibility.

Chapter 2. Mounting the 87691VX Tape Autoloader in a rack

The 87691VX Tape Autoloader is designed to be installed in a rack, using 1 U of rack space. Rack-mounting hardware is included with the autoloader.

Note: Racks are measured in vertical increments of 4.45 cm (1.75 inches) each. Each increment is call a "U". A 1-U-high device is 1.75 inches tall.

To install the autoloader in a rack, you need the following tools:

- #1 Phillips screwdriver
- #2 Phillips screwdriver
- 8 mm wrench
- Tape measure

Before you start the installation, read the entire installation procedure.

Removing the shipping key

The robotic cartridge loader inside the autoloader is secured with a small metal shipping key to keep the loader from moving during shipping. Before you operate the autoloader, you must remove this shipping key. To remove the shipping key, complete the following steps:

____1. Remove the adhesive label that secures the shipping key to the autoloader.

____2. Lift the shipping key up and out of the autoloader.

Assembling the rails

To assemble the rails, complete the following steps:

- ____1. Using a tape measure, measure the distance from the outside of the front mounting holes of your rack to the outside of the back mounting holes. Record this measurement.
- **2**. Locate the front and back rails for the left side. Position the rails as shown in Figure 6, with the front rail on top of the back rail. Spread the rails to the distance that you measured in 1.
- ____3. Using a #2 Phillips screwdriver, attach the rails together with two M5 screws (the larger silver screws from the kit), as shown in Figure 6. Leave the screws loose so that you can adjust the reach of the rails, if necessary.

4. Assemble the rails for the right side in the same way (see Figure 7 on page 10).

Attaching the rails to the rack

To attach the rails to the rack, complete the following steps:

____1. Position the left-side set of rails in the rack so that the front flange is inside the front screw holes in the rack (see Figure 8).

- ____2. Insert two M5 screws (the black screws from the kit) through the front flange of the rail (see Figure 8). Attach a nut to each screw. If your rack has square mounting holes or the holes are much larger than the screws that are provided in the kit, use a washer with the nut. Finger-tighten the nut.
- **____3.** Adjust the reach of the rails as necessary to position the back flange of the rail outside of the screw holes at the back of the rack (see Figure 9).

____4. From the back of the rack, insert an M5 screw (the silver screws from the kit) through the back flange of the rail (see Figure 9). Attach a nut to the screw. If your rack has square mounting holes or the holes are much larger than the screws that are provided in the kit, use a washer with the nut. Finger-tighten the nut.

- **Note:** Before you tighten the screws further, make sure that the horizontal shelf that is created by the rails is level.
- ____ 5. Using a #2 Phillips screwdriver and an 8 mm wrench, tighten the screws that secure the rails to the front and back of the rack.
- ____6. Using a #2 Phillips screwdriver, tighten the two screws holding the set of rails together.
- ____7. Repeat step 1 on page 11 through step 6 for the right-side rails.

Attaching the 87691VX Tape Autoloader to the rails

To attach the autoloader to the rails, complete the following steps:

____1. From the front of the rack, place the autoloader onto the shelf that is created by the rails (see Figure 10).

____2. Slide the autoloader all the way back until it makes contact with the small flanges near the back of the rails. The front edge of each shelf piece slides under the metal tabs at the bottom front edge of the autoloader.

____3. From the back of the rack, attach the autoloader to the rails by inserting an M3 screw into each of the small flanges (see Figure 11). Tighten the screws, using a #1 Phillips screwdriver.

Chapter 3. Installing and setting up the 87691VX Tape Autoloader

This chapter provides step-by-step instructions for installing and setting up the 87691VX Tape Autoloader. If you need assistance with the installation, contact IBM service.

Before you install the 87691VX Tape Autoloader, let it acclimate to the operating environment for as long as it has been away from the environment or for 24 hours, whichever is less.

Because the autoloader is a low-voltage differential (LVD) device, all other devices on the SCSI bus should also be LVD. These devices include the controller cards, cables, terminators, and any other devices on the bus. Do not mix LVD and high voltage differential (HVD) devices on the same bus.

Attention: The 87691VX Tape Autoloader is a precision device that requires reasonable care in handling to prevent data loss or permanent damage to the device. Avoid bumping or dropping the 87691VX Tape Autoloader.

To install the 87691VX Tape Autoloader, complete the following steps:

Step 1. Performing a parts inventory

Make sure that you received the following items:

- 1. Power cable
- 2. The 87691VX Tape Autoloader User's Guide (this document)
- **3**. SCSI bus cable
- 4. Terminator
- 5. Cleaning cartridge
- 6. Package of sample bar code labels
- 7. Rack mounting hardware

Step 2. Checking the electrical outlets

Make sure that the electrical outlets are properly grounded.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

Step 3. Determining the SCSI address

The SCSI address identifies the device to the bus and the system. Be careful not to set two devices to the same SCSI address because this will cause errors. The selected address sets the priority of the device on the bus. Tape drives are usually slow devices, compared to hard disk drives, so a tape drives should be set to a high priority to ensure that it gets access to the bus in a timely manner.

The host system has 16 available SCSI address settings. From highest to lowest, the SCSI bus priority is as follows: Highest 7 6 5 4 3 2 1 0 15 14 13 12 11 10 9 8 Lowest.

Before you install the 87691VX Tape Autoloader, make sure that its SCSI address is not being used by another device. The 87691VX Tape Autoloader is a wide (16 bit) SCSI device and uses SCSI addresses from 0 through 15 (usually, address 7 is reserved for the SCSI I/O controller).

Note: The 87691VX Tape Autoloader is supported only on an LVD SCSI bus.

To determine an unused SCSI address, you need the following information:

- The name and the port number of the host system SCSI I/O controller that you want to connect the autoloader to
- The SCSI address of that SCSI I/O controller
- The SCSI addresses of other devices that are connected to that SCSI I/O controller

Step 4. Setting the SCSI address

The SCSI address is a unique address that identifies the 87691VX Tape Autoloader and drive to your system. The autoloader and the drive that is installed in it each must have its own unique SCSI address. The 87691VX Tape Autoloader is shipped with the autoloader SCSI address set to 0 and the drive address set to 5. If you want to change these settings, use the operator panel and display screen on the front of the device (see Figure 2 on page 2).

To set the autoloader SCSI ID, complete the following steps:

- 1. On the operator panel, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Change a Configuration** menu is displayed.
- **3**. Press the Down a Level button once, and then press the Next Choice button until the **Change Library ID** screen is displayed.
- 4. Press the Down a Level button to set the autoloader SCSI ID.
- 5. Press the Next Choice or Previous Choice button to scroll through the available values. When the SCSI address that you want to use is shown, press the Select button to select the value. A confirmation screen is displayed.
- 6. Press the Select button to set the SCSI ID to the selected value or press the Up a Level button to cancel the change. The library SCSI inquiry string is IBM 87691VX.

To set the drive SCSI ID, complete the following steps:

- 1. On the operator panel, press the Down a Level button to access the main menus
- 2. Press the Next Choice button to scroll through the menus until the **Change a Configuration** menu is displayed.
- **3**. Press the Down a Level button once, and then press the **Next Choice** button until the Change Drive ID screen is displayed.
- 4. Press the Down a Level button to set the drive SCSI ID. Set the device at the highest available address. Do not select a SCSI address that is already in use.
- 5. Press the Next Choice or Previous Choice button to scroll through the available values. When the SCSI address that you want to use is displayed, press the Select button to select the value. A confirmation screen is displayed.
- 6. Press the Select button to set the SCSI ID to the selected value or press the Up a Level button to cancel the change. The tape drive SCSI inquiry string is IBM VXA-3.

Step 5. Connecting the SCSI bus cable

To connect the SCSI bus cable, complete the following steps:

- 1. Before you attach the cable, ensure that no connector pins are bent.
- 2. On the rear of the 87691VX Tape Autoloader (see Figure 12 on page 18), attach the device connector end of the SCSI bus cable to one of the SCSI connectors. Make sure that the connector is fully engaged.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

- **3**. Secure the cable to the 87691VX Tape Autoloader using the thumbscrews on the cable (finger-tighten them only).
- 4. Connect the other end of the SCSI bus cable as follows:
 - If the 87691VX Tape Autoloader is the only device that is attached to the system, connect the cable to the host system (see Figure 12).
 - If the 87691VX Tape Autoloader is part of a multiple-device configuration, connect the cable to the next device.

Step 6. Installing the SCSI bus terminator

A terminator must be installed on the last device in the configuration.

Note: Before you attach the terminator, make sure that no pins on the connector are bent or damaged.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

To install the SCSI terminator, align it with the unused SCSI connector on the 87691VX Tape Autoloader and push in until the terminator is seated. Secure the terminator with the thumbscrews on the terminator (finger-tighten them only).

• If the 87691VX Tape Autoloader (see Figure 12) is the only SCSI device that is attached to the host system, install the terminator on one of the dual connectors.



Figure 12. Example of attaching one SCSI device to the system unit

• If more than one device is attached to the host system, move the terminator to the last device on the bus.



Figure 13. Example of attaching multiple SCSI devices to the system unit

Notes:

1. The terminator and the SCSI bus cable can be connected to either the top or the bottom SCSI connector on the 87691VX Tape Autoloader.

- 2. When the 87691VX Tape Autoloader is the last device on the bus that is attached to a host system, use the terminator that comes with the 87691VX Tape Autoloader.
- **3.** Use only one external terminator to terminate the SCSI bus. You do not have to use the terminator that comes with the 87691VX Tape Autoloader if an IBM-approved terminator has been previously installed.

Step 7. Connecting the power cables

To connect the power cables, complete the following steps:

1. Connect the 87691VX Tape Autoloader power cable to an electrical outlet.

Attention:

- a. Connect the 87691VX Tape Autoloader power cable directly to an electrical outlet to ensure proper grounding. Using extension cords or power strips to supply power to the 87691VX Tape Autoloader does not ensure proper grounding.
- b. Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.
- **2**. Connect the power cables for all external devices and the system unit to electrical outlets.
- **3**. Turn on the power to all of the external devices, except the 87691VX Tape Autoloader.
- 4. Review the information in "Status LED" on page 2.
- 5. Turn on the power to the system unit.
- 6. While you observe the LCD screen, turn on the power to the 87691VX Tape Autoloader and watch for the messages that the power-on procedure has been completed successfully.

Step 8. Installing a backup application

If you are using a separate backup application, install it now using the instructions that came with the application. If you are using the native Windows[®] backup applet, go to the following Web site to get the device drivers: http://www.ibm.com/pc/support/site.wss/document.do?lndocid=TAPE-FILES.

Chapter 4. Using the 87691VX Tape Autoloader

This chapter describes the operator controls on the 87691VX Tape Autoloader and how to use them.

Using the operator panel

Use the five-button operator panel to navigate through the configuration, operation, and information menus. The 87691VX Tape Autoloader menus are organized in a tree structure (see Figure 15 on page 23) that consists of four main menus with submenus and selections. Use the operator panel buttons to move up and down between menu levels, view choices within menus, and make selections.

Figure 14 shows the operator panel buttons on the 87691VX Tape Autoloader.

| Button | Function |
|---------------------------------|---|
| Next Choice (right arrow) | Press the Next Choice button to move forward through the selections in a menu. Note: If you are entering a password, press the Next Choice button to move forward through the available values at a character position. Press and hold the button to move rapidly through the available values. |
| Previous Choice (left arrow) | Press the Previous Choice button to move backward through the selections in a menu. Note: If you are entering a password, press the Previous Choice button to move backward through the available values at a character position. Press and hold the button to move rapidly through the available values. |

| Up a Level (up arrow) | Press the Up a Level button to return to the previous level of menus. At the top level of menus, pressing the Up a Level button returns to the Home screen.Note: If you are entering a password, press the Up a Level button to move backward through the character positions of the password. |

| Down a Level (down arrow) | Press the Down a Level button to move down into a lower level of a menu. For example, if the LCD screen is displaying one of the main menus, press this button to view the submenu for that menu.Note: If you are entering a password, press the Down a Level button to move forward through the character positions of the password. |
| Select | Press the Select button to cause an operation displayed on the LCD screen to take effect. For example, if you are changing a SCSI ID, pressing the Select button causes the new value you have entered to take effect. As confirmation, after you press the Select button, the original LCD screen displays the new value. |

Using the 87691VX Tape Autoloader menus

During normal operation, the Home screen displays the operating status of the autoloader and tape drive. If the autoloader has no current error condition, the status of the tape drive is displayed.

If a menu is displayed on the LCD screen and you want to view the Home screen, press the Up a Level button until the Home screen is displayed.

Figure 15 on page 23 shows the menus and submenus that can be used to control the 87691VX Tape Autoloader. The menu tree shows the basic structure of the options. Many of the submenus have several options within them.

Overview of the main menus

Below the Home screen are four main menus. Press the Down a Level button on the operator panel to display the main menus. Then, use the Next Choice or Previous Choice buttons to scroll through the main menus. Press the Down a Level button to display submenus within a main menu option.

The following main menus are available.

| Change a Configuration | Use this option to view and change the SCSI IDs, operating mode, emulation mode, autoclean settings, and Ethernet settings. Also use this option to set up a password to restrict access to the operator panel menus. |
| Run a Diagnostic | Use this option to run demonstrations, perform diagnostic tests, and reset the autoloader. |

Setting password protection

You can set up a password for accessing operator panel menus. When you have set a password, access to the following operator panel functions is password-protected:

- Changing configuration settings
- Importing and exporting cartridges
- Loading and unloading the tape drive
- Cleaning the tape drive
- Running demos
- Resetting the autoloader

A password can be up to six characters in length and is not case sensitive.

When password protection is in effect, you must enter the password before you can use the operator panel menus. Each time you return to the Home screen and press the Up a Level button an additional time (or wait 2 minutes), password protection is reactivated; you must enter the password again to access the menus.

Attention: If you set a password, record it in a secure location. The operator panel functions cannot be used without the password.

Setting an operator panel password

To set a password for the operator panel, complete the following steps:

- ____1. On the operator panel, press the Down a Level button to display the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Change a Configuration** menu is displayed.
- ____3. Press the Down a Level button once and then press the Next Choice button until the **Change Password Entry?** screen is displayed.
- _____4. Press the Down a Level button. The **Select Password Protection** screen is displayed.
- ____ 5. Press the Next Choice button until 0N is displayed.
- ____6. Press the Select button. The **Select New Password** screen is displayed.
- ____ 7. Press the Next or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When you have entered the password, press the Select button. The message Set Password Now? is displayed.
Note: You can enter a password of up to six characters, including blanks. The password is not case-sensitive.

- **8**. Press the Select button to accept the password (or press the Up a Level button to cancel setting the password).
- ____9. Press the Up a Level button until the Home screen is displayed. Press the Up a Level button again or wait 2 minutes without pressing any buttons for the password to take effect.
- **Note:** If you want to continue using menus after you have set a password, do not press the Up a Level button an additional time after the Home screen is displayed. The password will not take effect until you have pressed the Up a Level button an additional time at the Home screen or you have pressed no buttons for 2 minutes.

Accessing password-protected operator panel menus

If you want to have access to the operator menus when the password protection is in effect, complete the following steps:

- On the operator panel, press the Select, Next Choice, Previous Choice, or Down a Level button. The password entry screen is displayed.
- ____2. Enter the password. Press the Next Choice or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When you have entered the password, press the Select button. You can now access the menus.
- ___3. After you have finished using the menus, press the Up a Level button until the Home screen is displayed. Then, press the Up a Level button again or wait 2 minutes without pressing any buttons for password protection to be reactivated.
- **Note:** You can try to enter the password 5 times. On the sixth attempt, the autoloader displays an encrypted version of the password. Contact IBM service to have the password decrypted.

Turning off the operator panel password

To turn off password protection for the operator panel, complete the following steps:

- On the operator panel, press the Select, Next, Previous, or Down a Level button. The password entry screen is displayed.
- 2. Enter the password. Press the Next Choice or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When you have entered the password, press the Select button. You can now access the menus.
- 3. Press the Next Choice button to scroll through the menus until the Change a Configuration screen is displayed.
- _____ 4. Press the Down a Level button once.
- 5. Press the Next Choice button until the Change Password Entry? screen is displayed.
- Press the Select button. The Select Password Protection screen is displayed.
- ____ 7. Press the Next Choice button until 0FF is displayed.
- Press the Select button. The message Set Password Protection Off? is displayed.

- 9. Press the Select button to turn off the password protection (or the Up a Level button to cancel the operation).
- ____10. Press the Up a Level button until the Home screen is displayed.

Setting the operating mode

The autoloader can operate in either random or sequential mode. In random mode, the tape cartridges are moved into the tape drive according to the commands of a control program. In sequential mode, the tape cartridges are used in sequential order. The default mode that the autoloader comes configured to use is random mode.

Sequential mode can be configured to use the Restart option and Loop option.

| Option | Description |
|---------|---|
| Restart | The Reset option determines what the autoloader will do after it is reset or the power is turned off and then on. To have the autoloader start at the beginning of the cartridge sequence, select ON. To have the autoloader start with the cartridge that was being used before the power interruption occurred, select OFF. |
| Loop | The reset option will determine what the autoloader does after it has used the last tape cartridge in the sequence. To have the autoloader start using the first cartridge again, select ON. To have the autoloader wait for operator intervention, select OFF. Operator intervention typically means removing the cartridges and inserting new cartridges. |

Table 2. Sequential mode options

Changing from Random mode to Sequential mode

To change the autoloader from Random to Sequential mode, complete the following steps:

- 1. On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the Change a Configuration menu is displayed.
 - **3**. Press the Down a Level button once.
- 4. Press the Next Choice button until the **Change Op. Mode? Now Random** screen is displayed.
- ____ 5. Press the Select button. The Select Op. Mode Random Mode screen is displayed.
- 6. Press the Next Choice button or Previous Choice button to change from Random mode to Sequential mode.
- 7. Press the Select button. The message Set Op.Mode to Sequential Now? is displayed.
- **8.** Press the Select button. The **Restart at First Address: NO** screen is displayed.
- 9. Press the Next Choice button or Previous Choice button to change from YES to NO.
- ____ 10. Press the Select button. The Loop When Done Set Looping Off screen is displayed.
- ____ 11. Press the Next Choice button or Previous Choice button to change from OFF to ON.

- ____12. Press the Select button. The message Set Op. Mode to SEQUENTIAL Now? is displayed.
- ____ **13**. Press the Select button.
- _____14. Press the Up a Level button until the Home screen is displayed.

Changing from Sequential mode to Random mode

To change the autoloader from Sequential mode to Random mode, complete the following steps:

- ____1. On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Change a Configuration** menu is displayed.
- **____3**. Press the Down a Level button once.
- ____4. Press the Next Choice button until the **Change Op. Mode? Now Sequential** screen is displayed.
- ___ 5. Press the Select button. The Select Op. Mode Sequential Mode screen is displayed.
- ___6. Press the Next Choice button or Previous Choice button to change from Sequential to Random mode.
- ___7. Press the Select button. The message Set Op.Mode to Random Now? is displayed.
- ____8. Press the Select button.
- ____9. Press the Up a Level button until the Home screen is displayed.

Using the 87691VX Tape Autoloader Ethernet connection

You can connect the 87691VX Tape Autoloader to an Ethernet network to remotely monitor operations through the remote management utility. You can also create diagnostic listings and upgrade autoloader firmware.

Connecting the 87691VX Tape Autoloader to an Ethernet network

To connect the autoloader to an Ethernet network using an Ethernet cable, complete the following steps:

- 1. Insert one end of the cable into the 87691VX Tape Autoloader Ethernet connector until you hear it snap into place. The Ethernet connector is on the back of the autoloader (see Figure 3 on page 3).
- ____2. Connect the other end of the cable to the network or directly to the server you will use to run the 87691VX Tape Autoloader remote management utility or to upload firmware.

Setting the Ethernet configuration options

You can use the 87691VX Tape Autoloader Ethernet interface to remotely monitor operations, upgrade firmware, and create diagnostic listings. Configuring the 87691VX Tape Autoloader Ethernet interface typically involves specifying the autoloader IP address, subnet mask, and gateway address. The IP address is used to route information from the autoloader to the server. You can choose between dynamic (server-assigned) or static (user-assigned) addressing for the IP address. If you select dynamic addressing, you can view the current server-assigned IP

address through the **Status** menu. The subnet mask is used to route information to designated devices within the network. The gateway address is used to route information outside the subnet.

The autoloader also includes an FTP interface that you can use to transfer firmware files or create diagnostic listings. You can set up an FTP user name and password for this interface or use the autoloader defaults. You can view and change the FTP settings only through the autoloader remote management utility.

If you plan to use the Ethernet interface, you must obtain an Ethernet cable. Use a shielded Category 5 (10/100BaseT connection) data-grade cable or similar Category 5 cable that is compliant with EIA/TIA 568. The 87691VX Tape Autoloader Ethernet port connector is a pin-through-hole RJ-45 shielded connector. All Ethernet cables that are used with the autoloader must be properly shielded.

Setting the Ethernet addresses

To set Ethernet addresses, complete the following steps:

- On the operator panel, press the Down a Level button to display the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Change a Configuration** menu is displayed.
- ____3. Press the Down a Level button once and then press the Next Choice button until the **Change IP Address?** screen is displayed.
- _____4. Press the Down a Level button. Select DHCP is displayed.
- ____ 5. Specify that the IP address is to be server-assigned, or enter a specific IP address.
 - To specify that the address is to be server-assigned, complete the following steps:
 - a. Press the Next Choice or Previous Choice button to toggle to ON, and press the Select button. The message Set DHCP to ON Now? is displayed.
 - b. Press the select button to confirm.
 - To enter a specific IP address, complete the following steps:
 - a. Press the Next Choice or Previous Choice button to toggle to OFF, and press the Select button. The message Set IP Address is displayed.
 - b. Press the Next Choice or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When the IP address that you want has been entered, press the Select button. The message Set Subnet Address is displayed.
 - c. Press the Next Choice or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When the Subnet address that you want has been entered, press the Select button. The message Set Gateway Address is displayed.
 - d. Press the Next Choice or Previous Choice button to scroll through the available characters for each position. Press the Down a Level or Up a Level button to change character positions. When the Gateway address that you want has been entered, press the Select button. The message Set DHCP Off and New IP Address Now? is displayed.
 - e. Press the select button to confirm.
- ____6. Press the Up a Level button until the Home screen is displayed.

Chapter 5. Using the media

The 87691VX Tape Autoloader uses data cartridges with VXA technology for saving and restoring system data. It only supports VXA X tape cartridges. If any other cartridge is inserted in the drive, it will be ejected.

Types of tape cartridges

The 87691VX Tape Autoloader supports the following media cartridges.

Data cartridge Use VXA data cartridges to save or restore programs or data.

Cleaning cartridge

Use a specially labeled cleaning cartridge to clean the 87691VX Tape Autoloader. For instructions for cleaning the 87691VX Tape Autoloader, see "Cleaning the tape drive" on page 36.

Attention: Use of other than IBM-supported VXA cleaning cartridges can damage your 87691VX Tape Autoloader and might void your warranty.

For a list of supported media, see http://www.ibm.com/pc/support/site.wss/document.do?lndocid=MIGR-39931.

Guidelines for using tape cartridges

The following guidelines will help to protect your data and prolong the life of your tape cartridges and the 87691VX Tape Autoloader:

- Use only IBM-recommended tape cartridges.
- Remove the tape cartridge from the drive when the drive is not in use.
- Back up and then discard any tape cartridge that repeatedly produces error messages. (The error information is in the system error log.)
- On the tape cartridge, do not open the door that covers the tape. The door protects the tape from dirt, dust, and damage.
- Do not touch the tape. Any substance that is transferred to the tape by touching could cause loss of data.
- To avoid problems with loading and unloading, use only one label on a cartridge. Multiple or poorly placed labels can obstruct the drive load mechanism.
- Do not use poor-quality tape cartridges. They can cause excessive read or write errors, and might damage the tape drive.
- Discard any tape cartridges that are dropped, because the impact might damage the tape internally.
- Make sure that the environment is kept clean and constant. Do not operate the autoloader in a dusty environment, and always maintain a constant environment.

Attention:

- 1. Use only the recommended cleaning cartridge to clean the tape drive. Use of other than recommended cleaning cartridges can damage your drive and might void the warranty.
- 2. Operating the autoloader outside of the recommended environment can result in possible loss of data or failure of the drive.
- Printers and copiers can produce paper and toner dust. Locate the autoloader away from these items. High-traffic areas near hallways and doors can also produce excess dust and dirt.
- Record all important information on the tape label. Include information such as the model and number of the system or tape drive, the date, the density, any error statistics, and a log number. The operating environment and compression mode should also be noted.

Erasing a tape cartridge

Most bulk eraser devices do not have the capability to erase a tape cartridge. To properly erase a VXA tape cartridge with a bulk eraser device, the erasure coercivity rating must be a minimum of 4000 Oersted.

Storage and shipping tape cartridges

Before using a tape cartridge, let it acclimate to the operating environment by placing the cartridge in the operating environment for as long as it has been away from the environment or for 24 hours, whichever is less. (To determine the appropriate operating environment, see "Specifications" on page 3.)

Acclimation is necessary for any data cartridge that is exposed to a different humidity environment or to temperature changes of 11°C (20°F) or more.

Retrieve archived data on a tape unit that is clean and fully operational. Try to make the recovery environment the same as the operating environment. Let the tapes acclimate to the environment of the tape unit for at least 24 hours.

The recommended environment for storage and shipment of VXA data cartridges is shown in Table 3.

Tape drives record data using densities that are similar to those of hard disk drives. Because most computer systems are not in a dust-free, climate-controlled environment, you must use special care when dealing with tape cartridges and tape drives.

Use the following guidelines for storing tape cartridges:

- Keep temperature and humidity constant at a level that is comfortable for you.
- Store tape cartridges in their protective cases. The storage case helps prevent damage from dust and physical misuse. When the tape cartridges are not in use or being stored, they should be in their storage cases and stood on edge in a designated storage location. Do not stack cartridges on the flat side or stack other items on top of the tape cartridges. Handle your tape cartridges with care to reduce archival problems.
- Keep tape cartridge protective cases closed except when you insert or remove a cartridge. Contamination can build up and be transferred to the tape cartridge if the protective case is left open.
- Exercise stored tapes at least once every 12 months. Run the tape from Beginning of Data (BOD) to End of Data (EOD) and back to BOD at normal operating speeds. Tapes that are stored in a warmer environment should be exercised more frequently.
- Sunlight can damage the tape and the cartridge shell. Store tape cartridges out of the direct sunlight

Operating in harsh environments

Do not use as an archival tape any tape that has been used outside of the operating ranges that are specified in Table 1 on page 3 for an extended period of time. The magnetic and physical strength of the tape will have deteriorated as a result of its exposure to the environment. Do not store important data on such a tape; transfer the data to a newer tape for reliable archiving.

Attention: Do not operate the 87691VX Tape Autoloader in a poor air-quality environment. If your environment contains an excessive amount of particulates, contact your IBM service representative for more information.

Setting the write-protect switch

The position of the write-protect switch on the VXA tape cartridge determines when you can write to the tape (see Figure 16).

- When the switch is set to the left, data can be written to and read from the tape.
- When the switch is set to the right, data can only be read.



Figure 16. Setting the Write-protect switch

Placing the cartridge labels

Use care when you place the cartridge label on a VXA tape cartridge. Use the following guidelines for tape cartridge labels:

- Use only labels that are provided with the cartridge and place them only in the designated locations.
- IBM VXA tape cartridges come with labels adhered to them. Do not adhere a label on top of an existing label. Poorly placed or multiple labels can clog the drive mechanism.
- Place the larger label on the end of the cartridge in the designated area.
- Place the smaller label on the top of the cartridge in the designated area.

Attention: Use only IBM-supported tape cartridges and labels.

Importing and exporting cartridges in the autoloader

Use the operator panel and menus to import and export (load and unload) tape cartridges in the 87691VX Tape Autoloader. See "Using the operator panel" on page 21 for information about using the operator panel.

Note: To avoid problems with loading and unloading, use only one label in each label location on a cartridge. Multiple or poorly placed labels can obstruct the drive load mechanism.

Importing tape cartridges

To import cartridges, complete the following steps:

- On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next button to scroll through the menus until the *Choose a Command* menu is displayed.
- **___ 3**. Press the Down a Level button once.
- _____ 4. Press the Next Choice button until the **Import Cartridge** screen is displayed.

- ____ 5. Press the Select button to display the cell selection display.
- 6. Press the Next Choice or Previous Choice button to scroll through the available cartridge cells. When the cell number in which you want to install the cartridge is displayed, press the Select button. The autoloader positions the selected cell and the cartridge access door will open.
- ____ 7. Position the cartridge with the VXA logo up and the side with the bar code label and write-protect switch towards the cartridge access door.

- Slide the cartridge fully through the access door until it snaps into place in the cartridge cell.
- 9. Press the Select button. The cartridge access door closes. The autoloader checks for the presence of a cartridge in the specified cell and makes sure that the cartridge is seated correctly. The cell selection screen displays the next available cell number.
- ____10. Continue importing cartridges in the same manner until you have filled as many cells as you want.
- **Note:** If you plan to store a cleaning cartridge in the autoloader, you must store it in cell 10.
- ____ 11. After you have finished importing cartridges, the autoloader automatically scans the affected cartridge cells to update its cartridge inventory. Press the Up a Level button to return to the Choose a Command menu.

Exporting tape cartridges

To remove (export) tape cartridges from the autoloader, complete the following steps:

- 1. On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Choose a Command** menu is displayed.
- ____ **3**. Press the Down a Level button once.
- 4. Press the Next Choice button until the Export Cartridge screen is displayed.
- ____ 5. Press the Select button to display the cell selection screen.
- ____ 6. Press the Next Choice or Previous Choice button to scroll through the available cartridge cells. When the cell number from which you want to

remove the cartridge is displayed, press the Select button. The autoloader positions the selected cell, and the cartridge access door opens.

- ____ 7. Remove the tape cartridge.
- 8. Press the Select button. The cartridge access door closes. The autoloader checks for the presence of a cartridge in the specified cell. The cell selection screen displays the next available cell number.
- ____ 9. Continue exporting cartridges in the same manner until you have removed as many cartridges as you want.
- ____ 10. After you have finished exporting cartridges, the autoloader automatically scans the affected cartridge cells to update its cartridge inventory. Press the Up a Level button to return to the Choose a Command menu.

Loading and unloading cartridges in the tape drive

Use the following instructions to load and unload tape cartridges from the autoloader tape drive.

Note: To avoid problems with loading and unloading, use only one label in each label position on a cartridge. Multiple or poorly placed labels can obstruct the drive load mechanism.

Loading tape cartridges

To load cartridges, complete the following steps:

- 1. On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Choose a Command** menu is displayed.
- **3**. Press the Down a Level button once.
- ____4. Press the Next Choice button until the Load Drive screen is displayed.
- ____5. Press the Select button to display the cell selection screen.
- ____6. Press the Next Choice or Previous Choice button to scroll through the available cartridge cells. When the cell number from which you want to load the cartridge is displayed, press the Select button. The autoloader positions the selected cell and the cartridge is loaded into the drive. A series of status messages is displayed as the operation proceeds. The Choose a Command menu is displayed when the operation is complete.

Unloading tape cartridges

To remove tape cartridges from the autoloader tape drive, complete the following steps:

- ____1. On the Home screen, press the Down a Level button to access the main menus.
- 2. Press the Next Choice button to scroll through the menus until the **Choose a Command** menu is displayed.
- **____3**. Press the Down a Level button once.
- ____4. Press the Next Choice button until the Unload Cartridge screen is displayed.
- ____5. Press the Select button to display the cell selection screen.
- ____6. Press the Next Choice or Previous Choice button to scroll through the available cartridge cells. When the cell number into which you want to store the cartridge removed from the drive is displayed, press the Select button. The autoloader positions the selected cell and the drive will unload the

cartridge into the cell. A series of status messages is displayed as the operation proceeds. The **Choose a Command** menu is displayed when the operation is complete.

Cleaning the tape drive

Regular cleaning helps maintain optimal performance of the tape drive and maximizes the life of your VXA tape cartridges. The tape drive monitors its cleaning needs internally and notifies the autoloader when it requires cleaning (after approximately every 75 hours of tape motion). The tape drive can also notify your software application when it requires cleaning if your application supports this feature.

You can clean the tape drive in any of the following ways:

- Use the Autoclean function. Set up automatic tape drive cleaning when you configure the autoloader, and store a cleaning cartridge in the autoloader. When the tape drive notifies the autoloader that it requires cleaning, the autoloader loads the cleaning cartridge into the tape drive, waits until the cleaning is finished, unloads the cleaning cartridge, returns it to its cell, and resumes normal operation. Enable the autoclean function by using the Change Autoclean menu under the Change Configuration main menu.
- Use the Clean Drive option from the operator panel. Use the Clean Drive option and a cleaning cartridge that is stored in the autoloader to clean the tape drive when the autoloader or software notifies you to do so. When you select the Clean Drive option, the autoloader loads the cleaning cartridge into the tape drive, waits until the cleaning is finished, unloads the cleaning cartridge, returns it to its cell, and resumes normal operation. For instruction for using this method, see "Cleaning the drive by using the Clean Drive option."
- Insert a cleaning cartridge through the Cartridge Access Door. Use the Import Cartridge and Load Drive options to insert a cleaning cartridge and load it into the tape drive when the autoloader or software notifies you to do so. After the cleaning is finished, use the Unload Cartridge and Export Cartridge options to remove the cleaning cartridge. For instruction for using this method, see "Cleaning the drive by loading a cleaning cartridge" on page 37.
 - **Note:** If you are using all 10 cells in the autoloader for data cartridges, you will need to remove a data cartridge to make room for the cleaning cartridge.

Clean the tape drive whenever the autoloader displays the Clean Drive message on the Home screen or whenever your application software notifies you. (Not all software applications display cleaning requirements.)

Cleaning the drive by using the Clean Drive option

Make sure that the following tasks have been completed before you use the **Clean Drive** option:

- Install a cleaning cartridge in cell 10.
- Activate the cleaning cartridge cell, which designates cell 10 as the storage location for the cleaning cartridge.
- Disable the Autoclean function.

To clean the tape drive, complete the following steps:

1. On the Home screen, press the Down a Level button to access the main menus.

- ____2. Press the Next Choice button to scroll through the menus until the Choose a Command menu is displayed.
- **____3.** Press the Down a Level button once.
- ____4. Press the Next Choice button until the Clean Drive? screen is displayed.
- ____5. Press the Select button. The confirmation message Start Cleaning Drive Now? is displayed.
- **Note:** If cell 10 is empty, you are prompted to insert a cleaning cartridge. Follow the instructions to insert a cleaning cartridge. If you have not activated cell 10, an error message is displayed. Activate the cleaning cell and begin the cleaning process again.
- ____6. Press the Select button to begin the cleaning process. When the cleaning operation is completed, the drive ejects the cleaning cartridge, and it is stored in cell 10.
- ____7. Confirm that the cleaning was completed successfully by looking at the operator screen. If there is no message, the cleaning was successful. If the cleaning was not successful, a message that explains the failure is displayed. You might be prompted to insert a new cleaning cartridge.

Attention: Cleaning cartridges can be used for only 20 cleaning procedures. If you attempt to use a depleted cleaning cartridge, the drive detects the error and immediately ejects the cartridge. Do not attempt to rewind the cartridge and reuse it. This can cause debris to be deposited back onto the drive heads, causing damage and errors.

Cleaning the drive by loading a cleaning cartridge

Complete the following steps if you do not want to store a cleaning cartridge in the 87691VX Tape Autoloader.

- **Note:** Before you insert a cleaning cartridge though the cartridge access door, make sure that you have disabled the Autoclean function.
- ____1. If data cartridges are in all 10 cells, use the Export Cartridge option to remove a cartridge from the autoloader (see "Exporting tape cartridges" on page 34). Before you press a button to close the door, insert the cleaning cartridge. Then, press the Select button.
- **Note:** If you do not have to export a cartridge to make room for the cleaning cartridge, use the **Import Cartridge** option to insert the cleaning cartridge into the autoloader (see "Importing tape cartridges" on page 33.)
- **2.** On the Home screen, press the Down a Level button to access the main menus.
- ____3. Press the Next Choice button to scroll through the menus until the Choose a Command menu is displayed.
- _____4. Press the Down a Level button once.
- ____5. Press the Next Choice button until the Load Drive screen is displayed.
- ____6. Press the Select button to display the cell selection screen.
- ____7. Press the Next Choice or Previous Choice button to scroll through the available cartridge cells. When the cell number that contains the cleaning cartridge is displayed, press the Select button. The autoloader positions the selected cell and the cleaning cartridge is loaded into the drive. The tape drive automatically performs the cleaning and ejects the cartridge when the cleaning operation is completed. Confirm that the cleaning completed

successfully by looking at the operator screen. If there is no message, the cleaning operation was successful. If the cleaning was not successful, a message that explains the failure is displayed. You might be prompted to insert a new cleaning cartridge.

- ____8. Use the Unload Drive option to return the cleaning cartridge to its cell.
- ____9. Use the **Export Cartridge** option to remove the cleaning cartridge from the autoloader. Before you press a button to close the door, insert the data cartridge that you removed previously (if applicable). Then, press the Select button.

Chapter 6. Maintaining the 87691VX Tape Autoloader

This chapter describes autoloader maintenance tasks that you can perform on-site without the aid of a service technician. It also describes troubleshooting procedures to help you solve autoloader problems without service assistance.

Using the repair identification (RID) tag

An RID tag maintains the original serial number record of your 87691VX Tape Autoloader and is used by IBM to entitle the device to future warranty service. If the autoloader is replaced, you must retain the serial number of the original device to use the warranty.

To retain the serial number, complete the following steps:

- 1. Locate the RID tag that is included in the autoloader CRU package.
- 2. Read the instructions for the RID tag.
- **3**. Copy the serial number from the original 87691VX Tape Autoloader onto the RID tag.
- 4. Attach the RID tag to the replacement 87691VX Tape Autoloader in an appropriate location.

Handling static-sensitive devices

Attention: Static electricity can damage the tape drive and other electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of damage from electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- The use of a grounding system is recommended. For example, wear an electrostatic-discharge wrist strap, if one is available.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed circuitry.
- Do not leave the device where others can handle and damage it.
- Remove the device from its package and install it directly into the autoloader without setting down the device. If it is necessary to set down the device, put it back into its static-protective package. Do not place the device on the autoloader cover or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

Removing tape cartridges manually

If you have to remove cartridges from the autoloader when power is unavailable, either due to a general power failure or a failure of the autoloader power supply, you can operate the cartridge access door manually. The autoloader has a small hole in the front bezel that provides access to a gear shaft attached to the cartridge access door. Using a small Phillips screwdriver, you can turn the gear shaft to open the cartridge access door.

If a cartridge is loaded in the tape drive when power to the autoloader fails and must remove that cartridge, you must remove the tape drive from the autoloader.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

For security, you can block access to the gear shaft from the hole in the front of the faceplate. A screw that is accessible from the hole in the top of the faceplate (see Figure 19) can be lowered in front of the gear shaft. To lower this screw, use a small Phillips screwdriver to turn the screw clockwise until it blocks access to the gear shaft.

To remove cartridges from the autoloader without power, complete the following steps:

- ____1. Carefully insert a small Phillips screwdriver into the top access hole (see Figure 19) on the top front of the autoloader. Unscrew the security blocking screw.
- _ 2. Carefully insert a small Phillips screwdriver into the bottom access hole (see Figure 19) on the front of the autoloader. Make sure that the screwdriver engages the head of the gear shaft.

- ____3. Turn the gear shaft counterclockwise to open the cartridge access door.
- ____4. When the door is fully open, you can remove cartridges by hand from the autoloader. To move cartridge cells into position in front of the door, gently rotate the cartridge carousel with your fingers.

Reach inside the door and gently rotate the carousel toward the left or right to access tapes in the remaining cells. If the carousel binds or will not move freely, a cartridge might be incorrectly seated in one of the cells. An incorrectly seated cartridge can be resolved only by a service call or a replacement unit.

____5. When you are finished removing cartridges from the autoloader, close the cartridge access door by turning the gear shaft clockwise.

Resetting the autoloader

If the autoloader is not operating correctly, you might have to reset it. To reset the autoloader, complete the following steps

- 1. On the Home screen, press the Down a Level button to access the main menus.
- ____2. Press the Next Choice button to scroll through the menus until the Perform a Diagnostic menu is displayed.
- **____3.** Press the Down a Level button once.
- ____4. Press the Next Choice button until the **Reset library**? screen is displayed.
- ___5. Press the Select button. The confirmation message Reset the LIBRARY Now? is displayed.
- ____6. Press the Select button to begin the library reset process. The autoloader resets and performs a cartridge inventory. When the process is complete, the Home screen is displayed.

Updating firmware and creating diagnostic logs using FTP

You can use the optional autoloader Ethernet connection and the file transfer protocol (FTP) utility to upgrade the autoloader firmware. You must have the following hardware and software to use this utility:

- A Category 5 (100BaseT connection) data-grade cable
- Software that supports the FTP utility (RFC 959)
- A host system or network connection that uses a pin-through-hole RJ-45 shielded Ethernet connector

Updating firmware

To update the firmware using FTP, complete the following steps:

- 1. Ensure that the autoloader Ethernet cable is connected and that it is configured to use the Ethernet. See Chapter 3, "Installing and setting up the 87691VX Tape Autoloader," on page 15 for more information.
- Download the latest autoloader firmware or Ethernet firmware from http://www.ibm.com/pc/support/site.wss/document.do?lndocid=TAPE-FILES.
- 3. From the host system, start the FTP utility.
- 4. Log on to FTP. The default user name is anonymous and the default password is IBM. The user name and password are case-sensitive.
- 5. Ensure that the FTP file transfer type is set to binary.
- 6. Enter the following command: is. The following information is displayed:

Table 4. Autoloader file description

| Autoloader file | Description |
|--------------------------------------|-------------------------------|
| packetloader.bin or packetloader.img | Autoloader firmware files |
| enet_APP.s19 or enet.hex | Ethernet module firmware file |

- 7. Rename the firmware files that you downloaded in step 2 to match the names of the files you are replacing.
- 8. Enter the following command: put *xxxxxxxxxx*; where *xxxxxxxxxx* is the file you replacing.

Note: The put command is a common FTP command; however, your FTP utility might not use the put command. Use the command for your FTP utility that functions the same as the put command.

Creating diagnostic logs

To create a diagnostic log, complete the following steps:

- 1. Ensure that the autoloader Ethernet cable is connected and that it is configured to use the Ethernet. See Chapter 3, "Installing and setting up the 87691VX Tape Autoloader," on page 15 for more information.
- 2. From the host system, start the FTP utility.
- **3.** Log on to FTP. The default user name is anonymous and the default password is IBM. The user name and password are case-sensitive.
- 4. Ensure that the FTP file transfer type is set to binary.
- 5. Enter the following command: get libdump.bin

Solving problems

This section provides information for solving problems that might occur when you are installing and operating the autoloader. "Troubleshooting hints" provides a list of potential problems and solutions. "Maintenance analysis procedures" on page 44 provides detailed troubleshooting information.

Troubleshooting hints

This section provides a list of problems and suggested solutions. If the information in this section does not solve your problem, see "Maintenance analysis procedures" on page 44.

Installation problems

If the autoloader and application software are not communicating after installation, check the following possible causes:

Power

Make sure that the autoloader power cord is inserted correctly, and that the power switch is on. Make sure that the host computer system is turned on.

SCSI IDs (SCSI autoloader)

Make sure that the SCSI IDs that you selected for the autoloader and tape drive are not the same as the IDs that are used by any other devices on the SCSI bus, including the SCSI adapter.

SCSI connections (SCSI autoloader)

Make sure that you have securely connected the SCSI cables and terminator to the SCSI connectors on the back of the autoloader. Make sure that the SCSI connections to the host computer and other devices on the bus are also secure.

LVD SCSI devices (SCSI autoloader)

Because the autoloader is a low-voltage differential (LVD) device, all other devices on the SCSI bus should also be LVD. These devices include the controller cards, cables, terminators, and any other devices on the bus. Do not mix LVD and high voltage differential (HVD) devices on the same bus.

SCSI cable lengths (SCSI autoloader)

Make sure that the cabling for the SCSI bus that is attached to the autoloader does not exceed the maximum length restriction.

Termination (SCSI autoloader)

Make sure that the SCSI bus is correctly terminated. If another device previously terminated the SCSI bus and is no longer at the physical end of the bus, be sure to remove the terminator from that device.

Compatibility

Make sure that the autoloader and tape drive are compatible with the SCSI adapter and application software that you plan to use.

Host adapter installation

Make sure that your host adapter is correctly installed. See the documentation that came with your adapter for installation and troubleshooting instructions. Pay special attention to instructions for setting various jumpers and switches on the adapter. Make sure that the adapter is correctly seated.

Software installation

Make sure that the application software is installed correctly. (See your software documentation.) Pay special attention to instructions that describe how to configure the software for use with the autoloader and tape drive.

Control mode

Make sure that the control mode is set correctly. Use SCSI mode (the default) with an application that controls the autoloader. Use Sequential mode only if you do not plan to use autoloader software. In Sequential mode, the autoloader automatically processes cartridges in sequential order without direction from an application.

Autoloader operation problems

If the autoloader has been working correctly, but is now malfunctioning, check the following:

Control mode

If you are using application software to control the autoloader, make sure that the control mode is set to SCSI. Use Sequential mode only if you are not using autoloader software.

Hardware operation

Use the options in the **Diagnostics** menu to check specific autoloader functions.

Firmware level

Make sure that the autoloader and tape drive contain the latest versions of firmware.

Tape drive problems

If the application software and autoloader have been working correctly, but are now having problems reading and writing data, check the following possible causes:

Write-protect switch

If you are writing data, make sure that the cartridge is write-enabled.

Cartridge type

Use the correct cartridges for your tape drive. See Chapter 5, "Using the media," on page 29 for information about selecting cartridges.

Cartridge age

If the cartridge has been in use for a long time or if it has been used frequently, try using a new cartridge.

Cleaning

Clean the tape drive as described in "Cleaning the tape drive" on page 36.

Maintenance analysis procedures

This section provides step-by-step procedures for isolating problems with the 87691VX Tape Autoloader.

Purpose of the MAPs

Use the maintenance analysis procedures (MAPs) to check the following items:

| Power cable | SCSI address | Tape drive |
|--------------|-------------------------|------------|
| Power supply | SCSI bus (signal) cable | Fan |
| Terminator | Configuration | Drive head |

If a problem is detected, the procedure isolates the problem to the customer replaceable unit (CRU), either the taped drive or the autoloader. For instructions for removing and replacing a CRU, see "Removal and replacement procedures" on page 47.

Step 1: Power and fan

To determine whether the power and the fan are operating correctly, complete the following steps:

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

- 1. Make sure that the 87691VX Tape Autoloader power cable is connected to an electrical outlet.
- 2. Make sure that the LCD screen is on and there is air flow from the fan at the rear of the unit.

Is the LCD screen on and is there airflow from the fan?

- **NO** While watching for the LED screen to turn on, turn the power switch off and back on again. Repeat this procedure several times. If the status LED fails to come on or if there is no airflow from the fan, call IBM service.
- **YES** Go to Step 3: Cooling fan.

Step 2: Power cable

This step determines whether the power cable is functional.

Make sure that all of the conductors in the power cable have continuity and that there are no short circuits.

Does the power cable have continuity and are there no short circuits?

- **NO** Replace the power cable.
- **YES** Call IBM service.

Step 3: Cooling fan

If the fan is not operating correctly, the autoloader might be overheating. To check the cooling fan, complete the following steps:

- 1. Press the power switch to turn off the power.
- 2. Press the power switch to turn on the power.
- **3**. Observe the cooling fan, which is mounted to the back of the internal chassis. Make sure that the airflow is not impeded and that the fan operates correctly, providing good airflow.

Does the LCD screen turn on and stay on, and is there airflow from the fan?

- **NO** The cooling fan is faulty. Replace the autoloader unit.
- **YES** Go to Step 4: Tape drive.

Step 4: Tape drive

To determine whether the tape drive is the problem, complete the following steps:

- 1. Press the power switch to turn off the power.
- 2. Press the power switch to turn on the power.
- **3**. Listen to and observe the installed tape drive. Make sure that it is functioning and not emitting abnormal noises.

Does the drive power-on appear to operate normally?

- **NO** Turn off the 87691VX Tape Autoloader and then replace the drive. See "Replacing the autoloader tape drive" on page 47.
 - **Note:** If a cartridge is still in the drive that you are replacing, you can remove it manually. See "Removing tape cartridges manually" on page 40.
- **YES** Go to Step 5: SCSI address.

Step 5: SCSI address

Make sure that the SCSI address setting is correct.

Is the SCSI address set correctly?

- NO Set the SCSI address to the correct address and then go to Step 6: External SCSI cable connection. To set the SCSI address, see the instructions in "Step 4. Setting the SCSI address" on page 17.
 - **Note:** Turn the power to the 87691VX Tape Autoloader off and then back on again to ensure the SCSI address setting is recognized.
- **YES** Go to Step 6: External SCSI cable connection.

Step 6: External SCSI cable connection

Make sure that the SCSI bus cable is correctly connected to the system unit and to the 87691VX Tape Autoloader.

Is the SCSI bus cable correctly connected to the system unit and to the 87691VX Tape Autoloader?

- **NO** Connect the SCSI bus cable into the system unit and to the 87691VX Tape Autoloader, then go to Step 7: Terminator connection.
- **YES** Go to Step 7: Terminator connection.

Step 7: Terminator connection

Make sure that the terminator is correctly connected to the last device on the SCSI bus.

Is the terminator correctly connected to the last device on the SCSI bus?

- **NO** Connect the terminator to the last device on the SCSI bus, and then go to Step 8: Configuration.
- **YES** Go to Step 8: Configuration.

Step 8: Configuration

Verify that the 87691VX Tape Autoloader has been correctly configured to the host system. For more information, see Chapter 3, "Installing and setting up the 87691VX Tape Autoloader," on page 15.

Is the 87691VX Tape Autoloader correctly configured to the host system?

- **NO** Correct the configuration.
- **YES** Go to Step 9: Diagnostics.

Step 9: Diagnostics

This step runs the diagnostics to determine the problem. Run the diagnostics on the 87691VX Tape Autoloader from the command prompt by entering : diag at the host system command prompt. For additional information about running diagnostics, see your system documentation.

Do all of the diagnostics routines pass?

- **NO** Replace the CRU isolated by the diagnostics and identified by the service request number.
 - **Note:** If the tape drive is the CRU that was isolated by the diagnostics, check that the cable on the back of the tape drive is connected correctly. If the drive has recently been replaced because of a similar problem, contact IBM service.
- **YES** If no problem was identified, the problem may be intermittent, related to the tape quality, or relating to the environment. If a CRU was replaced or changed and no more errors occur, the problem is fixed.

Step 10: Operation retry

Clean the tape drive (see "Cleaning the tape drive" on page 36). Then, attempt the failing operation again.

Does the 87691VX Tape Autoloader perform the failing operation correctly?

NO Replace the 87691VX Tape Autoloader.

If you are instructed to return a device or component, follow all packaging instructions, and use any packaging materials for shipping that are supplied to you.

Replacing the autoloader tape drive

This section describes how to replace the autoloader tape drive.

Note: If your autoloader is installed in a rack, it is not necessary to remove the autoloader from the rack to replace the tape drive. It is also not necessary to disconnect the SCSI cable, terminator, or Ethernet cable from the back of the autoloader if they do not interfere with your access to the tape drive.

Removing a tape drive

To remove the tape drive, complete the following steps:

- ____1. Make sure that the environment is free of conditions that could cause electrostatic discharge (ESD). If possible, use an antistatic mat and a grounded static protection wristband during installation. If a mat and wristband are not available, touch a known grounded surface, such as a metal computer chassis.
- ____2. Turn off the autoloader and disconnect the power cord.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

- ____3. Locate the tape drive cover plate at the back of the autoloader.
- _____4. Using a #1 Phillips screwdriver, remove the two screws that secure the cover plate (see Figure 20 on page 48). Set the cover plate and screws aside.

____5. Disconnect the power cable, SCSI cable, and serial cable from the tape drive. Route the cables downward and away from the sides of the tape drive.

____6. Pull on the tabs on the tape drive brackets and slide the tape drive out of the autoloader.

____7. Using a #1 Phillips screwdriver, remove the two screws from each of the brackets that are attached to the tape drive (see Figure 23 on page 49). Save the brackets and screws. You will attach the brackets to the new tape drive.

Installing a tape drive

To install the tape drive, complete the following steps:

____1. If your new tape drive has a bezel attached, remove the bezel before you install the tape drive in the autoloader:

To remove the bezel:

- a. Using a small flat-blade screwdriver, push the bezel side catch tabs on each side of the tape drive inward until they clear the metal tabs attached to the tape drive chassis.
- b. With the bezel side catch tabs clear of the metal tabs that are on the tape drive chassis, rotate the bottom of the bezel out and up from the front of the drive.
- **c**. Disengage the upper tabs from the top of the tape drive chassis and lift the bezel up and away from the drive.
- ____2. Place the tape drive right side up (check the labels on the tape drive). Place the brackets you removed from the original tape drive on the new tape drive and attach them, using the two screws for each bracket.
- ____3. With the tape drive right side up, slide the tape drive into the autoloader until the bracket flanges rest against the flanges on the autoloader back panel.
- ____4. Connect the serial cable to the tape drive. The connector is keyed to ensure the correct orientation.
- **Note:** Before you connect the SCSI cable in the following step, make sure that none of the pins on the SCSI cable are bent.
- ____5. Connect the SCSI cable and power cable. The connectors are keyed to ensure the correct orientation.
- ____6. Route the cables into the notch in each bracket, and make sure that the cables do not hang below the tape drive. Make sure that the serial cable is not pinched between the SCSI cable and the side of the notch.

____7. Place the tape drive cover plate on the autoloader back panel. Make sure that the cables are not pinched by the cover plate. Insert and tighten the two screws.

Replacing the autoloader

This section describes how to replace the autoloader.

Removing the autoloader

To remove the tape drive, complete the following steps:

____1. Make sure that the environment is free of conditions that could cause electrostatic discharge (ESD). If possible, use an antistatic mat and a grounded static protection wristband during installation. If a mat and wristband are not available, touch a known grounded surface, such as a metal computer chassis.

Attention: Electrical current from power, telephone, and communication cables is hazardous. See "Safety" on page v for more information.

- ____2. Turn off the autoloader and disconnect the power cord.
- **____3.** Disconnect the SCSI cable, SCSI terminator, and Ethernet cable from the back of the autoloader.
- _____4. Remove the autoloader from the rack.
- ____5. Locate the tape drive cover plate at the back of the autoloader.
- ____6. Using a #1 Phillips screwdriver, remove the two screws securing the cover plate (see Figure 24). Set the cover plate and screws aside.

____7. Disconnect the power cable, SCSI cable, and serial cable from the tape drive. Route the cables downward and away from the sides of the tape drive.

8. Pull on the tabs on the tape drive brackets and slide the tape drive out of the autoloader.

Installing the autoloader

To install the autoloader, complete the following steps:

- ____1. With the tape drive right side up, slide the tape drive into the autoloader until the bracket flanges rest against the flanges on the autoloader back panel.
- ____2. Install the autoloader in the rack.
- **3**. Connect the serial cable to the tape drive. The connector is keyed to ensure the correct orientation.
- **Note:** Before you connect the SCSI cable in the following step, make sure that none of the pins on the SCSI cable are bent.
- _____4. Connect the SCSI cable and power cable to the tape drive. The connectors are keyed to ensure the correct orientation.
- ____5. Route the cables into the notch in each bracket, and make sure that the cables do not hang below the tape drive. Make sure that the serial cable is not pinched between the SCSI cable and the side of the notch.
- ____6. Place the tape drive cover plate on the autoloader back panel. Make sure that the cables are not pinched by the cover plate. Insert and tighten the two screws.
- ___7. Connect the SCSI cable, SCSI terminator, Ethernet cable, and power cable to the autoloader.

Manually Removing a Tape Cartridge

This section provides information about manually removing a tape cartridge.

Attention: This procedure might damage your tape cartridge, the 87691VX Tape Autoloader, or both. Use this procedure only after you have attempted the following tasks:

- Eject the cartridge by performing the cartridge unload procedure using the operator panel and display screen menus.
- Turn the power to the 87691VX Tape Autoloader off and on again to clear potential hang conditions.
- If available, issue the Unload SCSI command from your system command menu.
- Disconnect the 87691VX Tape Autoloader from the system, and turn the power to the 87691VX Tape Autoloader on and off again several times.
- 1. Remove the drive from the 87691VX Tape Autoloader (see "Replacing the autoloader tape drive" on page 47).

- 2. To remove the top cover of the drive mechanism, complete the following steps:
 - a. Use a small screwdriver to press the top tabs (see Figure 27) on each side of the drive.
 - b. Slide the cover approximately 5 mm to the rear, and then lift off the cover.
- **3**. Locate the large thumb wheel that is located below the right side of the data cartridge.
- 4. Gently rotate the thumb wheel (see Figure 28 on page 53) counterclockwise to remove slack from the tape by winding the media onto the take-up reel.
- 5. Insert a Phillips head screwdriver in the load motor access hole (see Figure 28 on page 53). Rotate the load motor clockwise to unwind the tape path. Unwind the mechanism until tape slack appears.

- 6. Gently rotate the thumb wheel again to remove the slack from the tape by winding the media onto the take-up reel.
- 7. Repeat steps 5 on page 52 and 6 until all of the tape media is wound onto the cartridge take-up wheel.
- 8. When the tape is completely rewound into the cartridge, turn the load motor clockwise until the tape cartridge is lifted out of the drive mechanism and ejected.
- 9. Remove the tape cartridge and attach the top cover.

To access the Remote Management Utility, complete the following steps:

- 1. Make sure that the autoloader is connected to an Ethernet network, and that it is correctly configured.
- 2. Make sure that the autoloader is turned on.
- **3**. Open a Web browser and enter the IP address of the autoloader in the following format:http://IPADDRESS. The Remote Management Utility home page is displayed.

The Remote Management Utility home page displays information in the following sections:

- Library information
- Library status (see Table 7)
- Tape drive status (see Table 8 on page 56)
- Inventory information (see Table 9 on page 56)

Running diagnostics

You can run diagnostics to determine the state of the autoloader. The diagnostics rotate the tape carousel to each tape cartridge position. If a tape is installed, the tape is placed in the tape drive and then removed. When the diagnostics are complete, the Diagnostics Results page is displayed.

To run the diagnostics, complete the following steps:

- 1. Click **Diagnostics**. The Library Diagnostics window opens.
- 2. Click Run Test.

Appendix A. Error messages

This section provides information about error messages on the LCD screen. The following information is provided for each message:

- · The error message
- A description of the problem that caused the error message
- The corrective action for the error message

Some corrective actions advise you to reset power or turn the autoloader off and then on. Read the following information to avoid problems:

- To avoid disrupting communication between the host system and other devices on the communication bus, make sure that there is no activity on the communication bus before you turn off the autoloader.
- Unload the tape from the tape drive before you turn off the autoloader. If you turn off the autoloader with a tape loaded in the tape drive, the tape drive might have to perform a format recovery process that can take 2 3 hours.

Table 14 provides an alphabetical list of the error messages. If the corrective action does not resolve the problem, contact IBM service.

Types of Warranty Service

If required, IBM provides repair or exchange service depending on the type of warranty service specified for your Machine in the above table and as described below. Warranty service may be provided by your reseller if approved by IBM to perform warranty service. Scheduling of service will depend upon the time of your call and is subject to parts availability. Service levels are response time objectives and are not guaranteed. The specified level of warranty service may not be available in all worldwide locations, additional charges may apply outside IBM's normal service area, contact your local IBM representative or your reseller for country and location specific information.

1. Customer Replaceable Unit ("CRU") Service

IBM provides replacement CRUs to you for you to install. CRU information and replacement instructions are shipped with your Machine and are available from IBM at any time on your request.
